	If you have a <b>Disclosable Pecuniary Interest*</b> in an item of business:  if it is not yet on the council's register, you <b>must</b> declare both the existence and details of it at the start of the meeting or when it becomes apparent;  you may <b>choose</b> to declare a Disclosable Pecuniary Interest that is already in the register in the interests of openness and transparency.  In both the above cases, you <b>must</b> leave the room without participating in discussion of the item.	
	If you have a <b>personal</b> interest in an item of business <b>and</b> you intend to speak or vote on the item you <b>must</b> declare both the existence and details of it at the start of the meeting or when it becomes apparent but you <b>may</b> participate in the discussion and vote on the item.	
	<ul> <li>*(a)Employment, etc - Any employment, office, trade, profession or vocation carried on for profit or gain.</li> <li>(b) Sponsorship - Any payment or other financial benefit in respect of your expenses in carrying out duties as a member, or of your election; including from a trade union.</li> <li>(c) Contracts - Any current contract for goods, services or works, between you or your partner (or a body in which one of you has a beneficial interest) and the council.</li> <li>(d) Land - Any beneficial interest in land which is within the council's area.</li> <li>(e) Licences- Any licence to occupy land in the council's area for a month or longer.</li> <li>(f) Corporate tenancies - Any tenancy between the council and a body in which you or your partner have a beneficial interest.</li> <li>(g) Securities - Any beneficial interest in securities of a body which has a place of business or land in the council's area, if the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body or of any one class of its issued share capital.</li> </ul>
