Subject: PREMISES LICENCE NEW APPLICATION
RE: Highbury Fine Food & Wine, 249 Upper Street, London, N1 1RU

1. Synopsis

- 1.1 This is an application for a new premise licence under the Licensing Act 2003.
- 1.2 The new application is to:
 - i) Allow the sale by retail of alcohol, off supplies only, 24 hours a day 7 days a week.

2. Recommendations

- 2.1 To determine the application for a new premises licence under Section 17 of the Licensing Act 2003.
- 2.2 To consider the representation from the Police in the light of the revised Secretary of State Guidance to Local Authorities issued on 25th April 2012 namely:

The Licensing Authority should accept all reasonable and proportionate representations made by the Police unless the Authority has evidence that to do so would not be appropriate for the promotion of the Licensing Objectives.

- 2.3 To consider that this address is in the Angel and Upper Street Saturation or “Cumulative Impact Policy” of Islington. This special policy creates a rebuttable presumption that applications for new premises licences, club premises certificates, or variation applications that are likely to add to the existing cumulative impact will normally be refused, unless the applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact or otherwise impact adversely on the promotion of the licensing objectives.
- 2.4 If the Committee grants the application it should be subject to:
- i. conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (See appendix 3);
 - ii. conditions recommended by responsible Authorities (see appendix 3);
 - iii. any conditions deemed necessary by the Committee to promote the four licensing objectives.

3. Background

- 3.1 The applicant currently holds a premises licence at this address allowing:
- i) the sale by retail of alcohol, off supplies only, Mondays to Sundays from 08:00 until 00:00.
- 3.2 Papers are attached as follows:-
- Appendix 1: application form;
- Appendix 2a: name & address details of those persons making representations;
- Appendix 2: representations;
- Appendix 3: suggested conditions and map of premise location.
- 3.3 Licensing history at the premises:
- 24th November 2005, premises issued to Mr Syed Hassan Raza by way of a conversion under the Licensing Act 2003;
 - 1st November 2007, premises licence variation granted authorising the sale by retail of alcohol, off supplies only, 24 hours a day seven days a week;
 - 13th June 2011, premises licence review application submitted by Islington Council’s Trading Standards team as a result of two seizures of illicit alcohol from the premises on 9th February 2011 and 22nd February 2011 respectively;
 - 4th August 2011, premises licence revoked at hearing before the Licensing Sub-Committee C;
 - 30th August 2011, appeal of Licensing Sub-Committee C’s decision placed before Highbury Corner Magistrates Court;
 - 6th October 2011, new application sought by Mr Azhar Naqvi seeking a premises licence to allow the sale by retail of alcohol, off supplies only, 24 hours a day seven days a week;
 - 22nd November 2011, designated premises supervisor (DPS) variation granted to name Mr Jaswinder Singh as new DPS;
 - 6th December 2011, agreement reached with Responsible Authorities, after negotiation and agreement to additional licence conditions, for a new premises licence to be granted authorising the sale by retail of alcohol, off supplies only, Mondays to Sundays from 08:00 until 00:00;
 - 7th December 2011, revoked licence appeal withdrawn as a result of grant of new licence;

- 30th March 2012, sale of alcohol to an underage volunteer during Trading Standards test purchase exercise. During post sale inspection a number of licence condition breaches were observed by Council officers;
- 4th April 2012, during a follow-up inspection continued premises licence condition breaches were witnessed by Officers;
- 6th April 2012, sale of alcohol to an Islington Council licensing officer after permitted hours. During follow-up to this unauthorised sale of alcohol, CCTV footage was requested but not supplied (breach of licence condition);
- 24th May 2012, premises licence review application submitted by Islington Council's Trading Standards team;
- 17th July 2012, premises licence suspended for 14 days and conditions added after the review hearing heard before Licensing Sub-Committee C. The DPS, Mr Jaswinder Singh, was also removed.

3.4 The Licensing Authority has received 10 letters of representation, none of which are from people who requested that they remain anonymous.

5.1 The Council is required to consider this application in the light of all relevant information, and if approval is given, it may attach such conditions necessary to promote the licensing objectives.

All new Mandatory Conditions

b) The prevention of crime and disorder

Retail 24 Ltd, Mr. Hassan Raza or anyone else involved in the running of the business under the former licence numbered 127798-944 will not carry on a business which involves the use of this premises licence.

A digital CCTV system will be installed and maintained on the premises.

The CCTV system will be recording at all times when the premises are open and the recordings shall be made available to the Police or other authorised officer on request within 31 days.

A panic alarm system linked to the central Police Station shall be installed.

All staff making sales of alcohol must be a Personal Licence holder or trained and authorised, in writing, by the Designated Premises Supervisor.

c) Public safety

A minimum of two members of staff will be present from 23:00 HRS and 06:00 hrs.

No alcoholic goods will ever be purchased from sellers calling to the shop.

The licensee will immediately report to Trading Standards any instance of a caller to the shop attempting to sell alcohol.

No spirits in re-sealed cases will be purchased.

Invoices (or copies) for all alcoholic goods on the premises will be kept at the shop and made available to officers from the council, police or HMRC upon request.

A stock control system will be introduced, so that the licensee can quickly identify where and when alcoholic goods have been purchased.

An ultra-violet light will be available at the premises for the purpose of checking the UK Duty Stamp on spirits as soon as practical after they have been purchased.

If any spirits bought by the company have UK Duty Stamps that do not fluoresce under ultra-violet light, or are otherwise suspicious, the licensee shall identify the supplier to Islington Trading Standards and HMRC as soon as possible.

d) The prevention of public nuisance

The licensee will display a 'We don't buy illegal alcohol' poster prominently in the shop window unless he has express permission not to, from Trading Standards;

The licensee shall ensure that staff are trained about age restricted products and ensure that they sign to confirm that they have understood the training. The training shall include the assessment of age: making a challenge: acceptable proof of age: and recording refusals. The licensee shall keep records of training and instruction given to staff and make them available for inspection upon request by the licensing team, police or trading standards. (replaced condition 16, Annex 2 of LN/13429-140812); and

Noise or vibration must not emanate from the premises so as to cause a nuisance to nearby properties.

No rubbish including bottles will be moved, removed or placed in outside areas on Sundays or Bank/Public Holidays and between the hours of 10pm and 7am other days of the week.

No deliveries on Sundays or Bank/Public Holidays and between the hours of 11pm and 7am other days of the week.

Prominent, clear and legible notices must be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and area quietly.

e) The protection of children from harm

The licensee shall adopt the Challenge 25, the Retail of Alcohol Standards Group's advice for off-licences.

The licensee shall require staff to note any refusals to sell to young people in a refusals log. The refusals log shall be checked and signed monthly by the Designated Premises Supervisor. The refusals log shall be made available for inspection by the licensing team, police or trading standards.

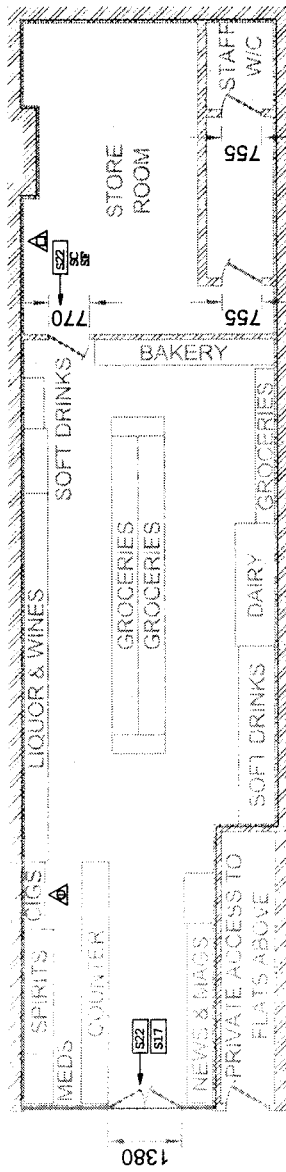

With reference to the above application, I am writing to inform you that the Metropolitan Police, as a Responsible Authority, will be objecting to this application as it is our belief that if granted the application would undermine the Licensing Objectives.

The venue is situated in the 'Angel, Upper Street Cumulative impact zone', a locality where this is traditionally high crime and disorder and there are concerns that this application will cause further policing problems in an already demanding area.

It is for these reasons that we are objecting to the application and propose that it is refused.

The premises is located in the Angel and Upper Street Cumulative Impact area which means that the council has determined that the area is already saturated with licenced premises and any licence applications need to be carefully examined to ensure that the proposed activities, opening hours, style of operation and management arrangements contained in the operating schedule will not add to the cumulative impact to such as extent that the licensing objectives are undermined.

As a result of more licenced premises operating in the area and existing premises extending their hours of operation the problems associated with alcohol consumption and the late night economy in the Angel have extended northwards along Upper St towards Highbury Corner

A new 24 hour off licence in this part of Upper St will:

- increase the supply of alcohol in the area
- make it easier for people to purchase alcohol, particularly at night
- encourage more people to remain longer in the area during the early hours of the morning

The proposal for a 24 hour off licence will have a detrimental impact on residents due to alcohol related crime, disorder and antisocial behaviour, noise and litter. Residents in the area have already experienced serious antisocial behaviour associated with drunk people regularly using a nearby alleyway as a place to congregate, drink, throw litter and use as a toilet area. The council has had to put in place significant resources to deal with these problems including stepping up their cleaning schedule issue. An additional premises selling alcohol in the area will undermine this work.

Recommendation and Reasons

The Licensing Authority has considered the style and hours of operation proposed by the applicant, the management arrangements described in the operating schedule, the special considerations described in paragraphs 2, 7 & 9 of the Licensing Policy.

The applicant has not presented any evidence to indicate there will be no adverse cumulative impact if this licence is granted.

It is recommended that this application is refused.

If the Licensing Committee is satisfied that the operation of the premises will not add to the existing cumulative impact the Licensing Authority recommends that the licenced be granted until 11pm Mondays to Sundays.

- (1) The mechanical extract ventilation fan in the toilet should extract direct to external air at a rate of not less than 6 litres/second and have a 15 minute overrun controlled by the light switch or occupant detecting sensor. Air inlet to the toilet should be provided, e.g. 10mm gap under the door.
- (2) One carbon dioxide fire extinguisher (rating 42B) and one water fire extinguisher (rating 13A) in conformity with BS EN 3 should be located behind or adjacent to the sales counter.

Fire fighting appliances should be on brackets or stands and located so as not to obstruct exit routes or cause a hazard to persons in and about the premises. Appropriate signs should be fixed adjacent to the fire fighting appliances indicating the type of fire fighting appliance and the class of fire covered.

- (3) Mains operated smoke alarms with a standby power supply such as a rechargeable or replaceable battery or capacitor in accordance with BS 5839 – 6 should be provided in the parts of the premises specified below:

- Store room
- Trading area of the shop

Smoke alarms should be sited so that no point is further than 7.5m from the nearest smoke alarm. Smoke alarms should not be mounted within 500mm of any walls or obstructions.

Smoke alarms should be interlinked so that detection of smoke by one unit operates the alarm signal in all of them. Smoke alarms should be wired in compliance with BS 7671 to a single independent circuit at the main distribution board. The circuit should be clearly labelled **Fire Alarm do not isolate**.

- (4) In addition to the lighting, emergency lighting in compliance with BS 5266 – 1 should be provided in the parts of the premises specified below:

- Trading area of the shop so all gangways are clearly illuminated.
- Store room

Note: Non-maintained emergency lighting should be wired to the local lighting circuit in such a manner as to operate not only in the event of failure of the mains supply but also on failure of the supply to the local lighting circuit.

- Electrical installation

Highbury Food and Wine, 249 Upper Street, London N1 1RU

I am submitting a representation against the application to vary the premises license to permit the sale of alcohol 24 hours a day from the above premises. This representation is on behalf of Islington Public Health Department, which as a health body is a responsible authority.

The impact of alcohol is particularly great in Islington with some of the greatest levels of alcohol-related problems in London, including:

- The highest rate of alcohol-specific deaths in men in London
- One of the highest rates of alcohol-related hospital admissions in London
- Significantly higher levels of alcohol-related violent crime and claimants of incapacity benefit where the main medical reason for being a claimant is alcoholism

The grounds for the representation are:

- Public safety
- Crime and disorder

The relevant policies in Islington's Licensing Policy

- Policies 1 and 2 relating to cumulative impact, in particular the Angel and Upper Street area
- Policy 4: Shops selling alcohol
- Policies 7 and 8: Licensing hours

Highbury Food and Wine is located in St Mary's ward. This is an area which already has relatively high density of premises licensed to sell alcohol. Currently within St Mary's ward there are:

- 192 premises licensed to sell alcohol, equivalent to one premises for every 49 residents aged 18 and over. This is the highest rate in Islington and is equivalent to one per 131 residents aged 18 and over.
- 49 premises are licensed for off-sales of alcohol only (i.e. excluding on-licences that also sell alcohol for consumption off the premises), one for every 191 residents aged 18 and over in the ward, and highest rate in Islington (the average is one per 374 in Islington)
- The nearest off-license licensed to sell alcohol for consumption 24 hours a day off the premises is less than 500m away. There are a further two 24-hour off-licences within 600m of Highbury Food and Wine.

I am concerned that if this application is granted it will increase the availability of alcohol for consumption off premises. This could lead to an increase in public nuisance, crime and disorder and impact adversely on health of both those buying and consuming the alcohol but also the health of others who come in contact with them.

The area already has sufficient premises to meet demand of local residents and additional outlets supplying alcohol after 11pm will be detrimental to the local residents in terms of noise and disturbance from this time throughout the early hours of the morning.

Alcohol and health

Alcohol misuse imposes a major preventable burden to health and the effect of this in Islington is felt across all health services. Recent analysis has estimated that in Islington the cost of hospital admissions where alcohol is an attributable factor was £7429.9k, (£39.4 per Islington resident during the financial year 2008/09¹).

There is a growing body of evidence that an increased number of alcohol outlets results in significant increases in both alcohol consumption and alcohol-related harm, including injury, violence and medical harm. Evidence from a number of countries indicates reducing alcohol outlet density can have an impact on reducing violence and problem drinking. There is also strong and reasonably consistent evidence that changes in hours or days of trading can have a significant impact on volume of alcohol consumed and rates of alcohol related problems^{2,3,4,5,6}.

Impact of alcohol on health in Islington

The impact of alcohol on health in Islington is particularly severe. Alcohol-specific hospital admissions are those which are wholly related to alcohol (e.g. alcoholic liver disease or alcohol overdose). Islington has the second highest rate in London for hospital admissions where alcohol is the specific cause of admission. For men the rate is also significantly worse than England, with the 24th highest rate across 326 English local authorities (2009/10).

Currently Islington has one of the highest rates of alcohol-related hospital admissions (all hospital admissions in which alcohol is likely to have played a part, for example injuries/falls or high blood pressure) in London. The rate for both men and women is significantly worse than the England average. Increases in alcohol related admissions have been much higher in Islington than in England as a whole. For instance, in Islington, the increase in alcohol-related admissions in men was 39% and 44% for women between 2003/4 and 2009/10, compared to increases of 25% for both men and women in England.

St Mary's Ward

Ambulance callouts

The data on alcohol-related ambulance callouts reflects where the ambulance attended, not where the individual lives, and therefore includes people who live outside the borough but who come into Islington to work, socialise, etc. In 2012/13, there were 185 alcohol-related ambulance callouts in St Mary's ward, compared to an average of 148 per ward. Local analysis indicates that there is a general trend of ambulance callouts increasing as the number of licensed premises increases. In St Marys' ward, 38% (71) of the 185 alcohol-related ambulance callouts in 2012/13 were between 11:00pm and 05:00am, compared to 30% across Islington.

At the smaller geographical Lower Super Output Area (equal to an area of around 1,500 residents), there were 66 alcohol-related ambulance call-outs in the LSOA in which the Highbury Food and Wine is located, compared to an average of 20 across all Islington LSOAs. 45% (30) were between 17:00hrs and 22:59hr, and 24% (15) between 23:00HRS and 04:59hrs. The largest proportion occurred on Saturdays (26; 39%), although overall the majority of alcohol-related ambulance callouts (56, 85%) occurred towards the end of the week (Thursday, Friday or Saturday)

Across Islington, 68% of alcohol-related callouts resulted in conveying a person to hospital, and 8% resulted in assistance being given at the scene or conveyed to an NHS walk-in centre – this results in a substantial use of health service resource.

Hospital admissions

St Mary's ward had the lowest rate of alcohol-specific hospital admissions among Islington wards in 2011/12, with a rate of 384 per 100,000 people – equivalent to 39 admissions to hospital. Alcohol-specific admissions record the number of residents admitted to hospital, in contrast to ambulance callouts which record the location of the incident, irrespective of the person's area of residence. This indicates the acute health impacts of alcohol on this area of the borough related to those who come to the area to socialise and drink alcohol as opposed to those who actually live in this area of Islington.

Conclusion

Islington experiences some of the highest levels of alcohol-related harm in London and the cumulative availability of alcohol is one area that is likely to be impacting on this. There is already good availability of alcohol in St Mary's ward, the highest density as measured by the number licences per residents aged 18 and over.

There is evidence that increased availability of alcohol, both in terms of the time period in which alcohol is available (hours of sale) and number of premises from which alcohol is available results in an increase in alcohol related harm. The LSOA in which Highbury Food and Wine is located has a much greater density of licensed premises than average for the borough and also has a much higher levels of alcohol-related ambulance callouts (more than three-times the average). The levels of ambulance related ambulance callouts reflects the increased pressure and costs to the NHS as a result of alcohol in Islington. These impacts are also felt across a range of groups including the council, policing and the community as a whole.

Recommendation

Islington Public Health Department recommends that:

1. The application for a 24 hour licence to supply alcohol is refused
2. The premises licence should allow for the sale of alcohol no later than 11.00pm

Suggested conditions of approval consistent with the operating schedule

1. Retail 24 Ltd, Mr Hassan Raza or anyone else involved in the running of the business under the former licence numbered 127798-944 will not carry on a business which involves the use of this premises licence.
2. A digital CCTV system will be installed and maintained on the premises.
3. The CCTV system will be recording at all times when the premises are open and the recordings shall be made available to the Police or other authorised officer on request within 31 days.
4. A panic alarm system linked to the central Police station will be installed.
5. All staff making sales of alcohol must be a Personal Licence holder or trained and authorised, in writing, by the Designated Premises Supervisor.
6. A minimum of two members of staff will be present between 23:00 and 00:00.
7. No alcoholic goods will ever be purchased from sellers calling to the shop.
8. The licensee will immediately report to Trading Standards any instance of a caller to the shop attempting to sell alcohol.
9. No spirits in re-sealed cases will be purchased.
10. Invoices (or copies) for all alcoholic goods on the premises will be kept at the shop and made available to officers from the council, police or HMRC upon request.
11. A stock control system will be introduced, so that the licensee can quickly identify where and when alcoholic goods have been purchased.
12. An ultra-violet light will be available at the premises for the purpose of checking the UK Duty Stamp on spirits as soon as practical after they have been purchased.
13. If any spirits bought by the company have UK Duty Stamps that do not fluoresce under ultra-violet light, or are otherwise suspicious, the licensee shall identify the supplier to Islington Trading Standards and HMRC as soon as possible.
14. The licensee will display a 'We don't buy illegal alcohol' poster prominently in the shop window unless he has express permission not to, from Trading Standards.
15. The licensee shall ensure that staff are trained about age restricted products and ensure that they sign to confirm that they have understood the training. The training shall include the assessment of age: making a challenge: acceptable proof of age: and recording refusals. The licensee shall keep records of training and instruction given to staff and make them available for inspection upon request by the licensing team, police or trading standards.
16. The licensee shall adopt the Challenge 25, the Retail of Alcohol Standards Group's advice for off-licences.
17. The licensee shall require staff to note any refusals to sell to young people in a refusals log. The refusals log shall be checked and signed monthly by the designated premises supervisor.
