**Subject: PREMISES LICENCE VARIATION APPLICATION
RE: TARMOND, 270 CALEDONIAN ROAD, LONDON N1 1BA**

1. Synopsis

- 1.1 This is an application for the variation of a premise licence under the Licensing Act 2003
- 1.2 The application is to allow:
 - i) Allow the sale of alcohol, for consumption on the premises, from 23:00 until 01:30 on Fridays and Saturdays.

2. Recommendations

- 2.1 To determine the application for a variation of the premises licence under Section 34 of the Licensing Act 2003.
- 2.2 If the Committee grants the application it should be subject to:
 - i. conditions of the current premises licence;
 - ii. conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (See appendix 3);
 - iii. conditions recommended by responsible Authorities (see appendix 3);
 - iv. any conditions deemed necessary by the Committee to promote the four licensing objectives.

3. Background

- 3.1 The premises is currently licensed for the sale of alcohol from 10:00 until 23:00 Monday to Saturday and from 12:00 until 22:30, recorded music from 00:00 until 24:00 Monday to Sunday and late night refreshment from 23:00 until 23:30 Monday to Saturday.
- 3.2 Papers are attached as follows:-

 - Appendix 2: representations;
 - Appendix 3: suggested conditions and map of premise location.
- 3.3 The Licensing Authority has received representations from Health & Safety, the Police and 4 letters of representation from 5 local residents,.

- 4.1 The Council is required to consider this application in the light of all relevant information, and if approval is given, it may attach such conditions necessary to promote the licensing objectives.

Annex 1 - Mandatory conditions

1. No supply of alcohol may be made under the premises licence-
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
3. If door supervisors are employed they shall be licensed by the Security Industry Authority.

Annex 2 - Conditions consistent with the Operating Schedule

1. Alcohol shall not be sold, supplied, consumed in or taken from the premises except during permitted hours. In this condition permitted hours means the authorised hours specified on this licence for the sale by retail of alcohol. This restriction does not prohibit:
 - a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
 - b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
 - c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
 - d) consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
 - e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
 - f) the sale of alcohol to a trader or club for the purposes of the trade or club;
 - g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
 - h) the taking of alcohol from the premises by a person residing there; or
 - i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
 - j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

2. No person under fourteen shall be in the bar of the licensed premises during the permitted hours for the sale by retail of alcohol unless one of the following applies:
 - a. He is the child of the holder of the premises licence.
 - b. He resides in the premises, but is not employed there.
 - c. He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.
 - d. The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary.

In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

3. Unless otherwise specified on this licence no regulated entertainment shall take place at the premises with the exception of pre-booked private events limited to the provision of music and dancing for pre-invited guests.
4. This licence is subject to such further conditions as are consistent with any restrictions imposed on the use of the premises for the existing licensable activities under the licence by virtue of the enactments hereinafter set out:
 - Children and Young Persons Act 1933
 - Cinematograph (Safety) Regulations 1955
 - Sporting Events (Control of Alcohol Etc) Act 1985

Objection to the variation to the license

The Tarmon, although a nice, local, old-fashioned pub is already a nuisance in the area in terms of noise at closing times. Often large groups of adults gather outside laughing and shouting in a drunken fashion. They do not disperse immediately. I am often woken or otherwise disturbed by this noise. Any extension to the licensed hours would cause further disturbance in the early hours which would be most unpleasant for close neighbours such as myself.

Additionally customers often exit the pub during its opening hours and after they have taken a fair amount of drink and they shout into mobile phones. These "conversations" can last up to 30 minutes, taking place just outside the pub (which is noisy inside). Swearing and cursing is usual and repeated at high volumes. At the end of the conversation the customer will re-enter the pub.

I am not aware of any crime and disorder caused by drunkenness although I do often hear cars starting up after the pub has closed and it may be that customers are drink driving.

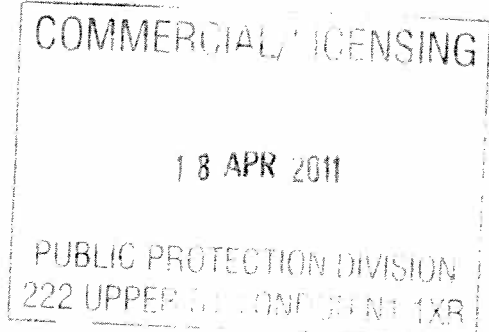

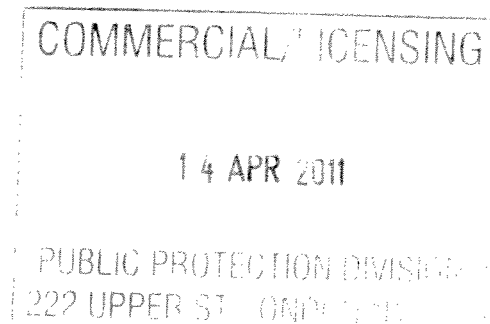

- (1) In addition to the lighting, emergency lighting in compliance with BS 5266 – 1 should be provided in public areas of the ground floor.

Note: Non-maintained emergency lighting should be wired to the local lighting circuit in such a manner as to operate not only in the event of failure of the mains supply but also on failure of the supply to the local lighting circuit.

- (2) Existing emergency lighting luminaires within the toilets and cellar and exit route from the cellar should be inspected and tested to ensure that each luminaire is wired to the local lighting circuit in such a manner as to operate not only in the event of failure of the mains supply but also on failure of the supply to the local lighting circuit.

- (3) The internally illuminated maintained exit signs over the two exit doors should be overhauled and put into full working order and the graphic symbols should comply with the Health and Safety (Safety Signs and Signals) Regulations.

Note: The colour of the graphic symbols on these exit signs is not in compliance with the Health and Safety (Safety Signs and Signals) Regulations. The signs should have a green background with white graphic symbols.
