

Subject: PREMISES LICENCE NEW APPLICATION

RE: BUDGEN'S OF ANGEL, 42 - 49 PACKINGTON STREET, LONDON, N1 7FZ

#### 1. Synopsis

- 1.1 This is an application for a new premise licence under the Licensing Act 2003.
- 1.2 The new application is to:
  - i) Permit the sale of alcohol, off supplies from 10:00 till 23:00 Monday to Saturday and 10:00 till 22:30 on Sunday.
  - ii) Recorded music to be played at background levels only from 10:00 till 23:00 seven days a week.
  - iii) Opening hours of 07:00 till 23:00 seven days a week.

#### 2. Recommendations

- 2.1 To determine the application for a new premises licence under Section 17 of the Licensing Act 2003.
- 2.2 If the Committee grants the application it should be subject to:
  - i. conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (See appendix 3);
  - ii. conditions recommended by responsible Authorities (see appendix 3);
  - iii. any conditions deemed necessary by the Committee to promote the four licensing objectives.

The Licensing Authority has received 13 letters of representation, none of which are from 3.2 people who requested that they remain anonymous. The Police representation has been withdrawn. Health and Safety representative has been withdrawn as works now completed.

#### Planning implications 4.

The Planning Service has reported that there are no planning enforcement issues in relation to 4.1 this site. The site has planning permission for A1 use, the supermarket would fall into this usage.

#### Conclusion and reasons for recommendations 5

The Council is required to consider this application in the light of all relevant information, and if 5.1 approval is given, it may attach such conditions necessary to promote the licensing objectives.

P Describe the steps you intend to take to promote the four licensing objectives:

#### a) General – all four licensing objectives (b,c,d,e) (please read guidance note 9)

- The Applicant has considered Islington Council's Statement of Licensing Policy 2013 2017.
- 2. The applicant has reviewed the designate areas of cumulative impact and saturation in Islington borough, especially Upper Street and Angel area which are in proximity to the premises, the issues and measures laid by the council in promoting the licensing objectives in the area.
- 3. Advice had been sought from Planning and Environmental Health as to likely noise levels in and around the premises and a Noise Risk Assessment carried out.
- 4. Advice has been sought from the London Fire Authority and a Fire and Emergency Planning assessment will be carried out.
- 5. Legal advice has been sought in relation to this application and the following legislation has been considered as part of this application: The Licensing Act 2003 and Regulations, Section 182 Guidance, Crime and Disorder Act 1998, Heath & Safety at Work Act 1974, Anti-Social Behaviour Act 2003, the Clean Neighbourhoods and Environment Act 2005, etc.
- 6. The Applicant has contacted the Responsible Authorities and awaiting advice on whether the licensing objectives would be satisfied on the basis of the Operating Conditions set out below.
- 7. The premises licence will be permanently displayed where it can be easily visible.

#### b) The prevention of crime and disorder

- 1. Staff shall receive regular training to ensure that the prevention of disorder is in sharp focus.
- 2. No alcoholic drinks will be sold or supplied to be consumed on the premises.
- 3. Staff shall implement the Challenge 21 proof of age policy.
- 4. Staff shall implement a dispersal policy outside the shop premises as within the Applicant's direct control.
- 5. Staff shall keep records of all sales and deliveries and, upon request, make these available for inspection by the Police, Licensing Authority or Trading Standards for six months from the date of delivery or refusal of alcohol.
- 6. Open containers of alcohol shall not be taken from the licensed premises.
- 7. CCTV shall be installed both inside and outside and staff shall be trained how to operate and maintain the equipment.
- 8. A conspicuous notice shall be displayed on or immediately outside the premises which gives details of the opening hours.

I am emailing you with regards to the licensing of the following : 47-49 Packington Street, London N1 7FZ

We have been sent a letter asking us if we have any objections for the Licence Application of the above premises to permit the sale of Alcohol, for consumption off the premises.

I would like to make it clear of my objection to this happening for the following reasons:

The location that has been picked is only meters away from COLAi secondary school to which my grand daughters attends. Having a supermarket that sells alcohol so close to the school could possibly encourage children to try and buy it. It was only this week that it was reported that children as young as 10 are drinking one alcoholic beverage a week. For the safety of our children, I would be very wary of a shop so close.

As well as this, we, the residents, although are being asked about this licence, were not asked about the actual supermarket, and whether we wanted the supermarket there in the first place.

This would dramatically increase the amount of people coming to the area, increasing the noise, not only to the surrounding area, but also the noise disruption to those living above the supermarket. And what about the delivery lorries arriving early in the morning, how much noise disruption will that bring? We have up to now been involved in many decisions concerning our new housing and surrounding neighbourhood, we should have been involved in this too.

### Suggested conditions of approval consistent with the operating schedule

- 1. No alcohol drinks sold or supplied shall be consumed on the premises.
- 2. All alcohol sales must be made by personal license holder or authorised person only.
- 3. Alcohol shall not be sold in an open container or be consumed in the licensed premises.
- 4. Strong beer and cider above 5.5% ABV will not be sold.
- 5. No single cans of beer or cider to be sold at any time.
- 6. Staff shall keep all records of all sales and deliveries and, upon request, make these available for inspection by the Police, Licensing Authority or Trading Standards for six months from the date of delivery. Or refusal of alcohol.
- 7. An incident book shall be used to record all instances of public disorder.
- 8. CCTV shall be installed, operated and maintained in agreement with the Police. The system will enable frontal identification of every person entering the premises. The system shall record in real time and operate whilst the premises are open for licensable activities. The recordings shall be kept available for a minimum of 31 days. Recordings shall be made available to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24 hours of any request.
- 9. Notices will be displayed at the entrance and in prominent positions throughout the premises, advising that CCTV is in operation.
- 10. Safety checks shall be carried out before the admission of the public. Details of safety checks shall be kept in a Log-book on the premises. The Log-book shall be made available for inspection by authorised officers.
- 11. All exit routes shall be kept unobstructed, with non-slippery and even surfaces, free of trip hazards and clearly identified.
- 12. Internal gangways between aisles shall be kept unobstructed.
- 13. Exit doors shall be regularly checked to ensure that they function satisfactorily and a record of the check shall be kept.
- 14. Noise or vibration must not emanate from the premises so as to cause a nuisance to nearby properties.
- 15. Signage shall be posted within the premises asking patrons to leave quietly.
- 16. Lobby doors at the premises shall be kept closed except for access and egress.
- 17. Internal and external lighting provided shall be positioned so as not to cause nuisance to neighbours and adjoining properties.
- 18. The licensee shall adopt the Challenge 25 and the BII National Standards Proof of Age Scheme
- 19. The licensee shall ensure that staff are trained about age restricted products and ensure that they sign to confirm that they have understood the training. The licensee shall keep records of training and instruction given to staff.
- 20. The licensee shall put arrangements in place to ensure that before serving alcohol to young persons, staff ask to see accredited proof of age cards e.g. Citizencard, a Passport, or UK Driving Licence bearing the photograph and date of birth of the bearer.
- 21. A notice or sticker acting as a permanent reminder to staff and customers about the sale of alcohol will be positioned next to the till.
- 22. The Epos tills should incorporate an Age Verification prompt that will remind the staff at the till to check a customer's age if anything requiring an age check is being sold, such as tobacco, alcohol and lottery.
- 23. The licensee and staff should note any refusals to sell to young people in a refusals log. The refusals log shall be checked and signed monthly by the designated premises supervisor. The refusals log shall be made available for inspection by the licensing team, police or trading standards
