Councillor Angelo Weekes welcomed everyone to the meeting and officers and members introduced themselves. The procedure for the conduct of the meeting was outlined.

58 MINUTES OF PREVIOUS MEETING (Item A6)

RESOLVED:

That the minutes of the meeting held on 22 August 2023 be confirmed as an accurate record of proceedings and the Chair be authorised to sign them.

59 <u>FIRST FLOOR, 1 NAVIGATOR SQUARE, N19 3TD - NEW PREMISES</u> LICENCE (Item B1)

The Licensing officer reported that a summary from the applicant had been circulated. An amended copy of the conditions, the dispersal policy, an operation manual and the security plan had also been circulated. It was noted that planning had confirmed that they were satisfied that as this was an application for a nightclub which had sui generis use; there was no requirement for an application for planning permission.

The Licensing Authority stated that the new documents circulated were quite comprehensive. They were satisfied that these operators had no links to the previous operators. They had held discussions about hours with the applicants and, although there had been an amendment to the hours requested, they would want to maintain their representation with the operating hours as framework, until 2am on Fridays and Saturdays

and at 1am during the week. They had concerns regarding the search and security check area and asked that the applicant clarify where this would be happening as part of their submission. The Police stated that they were satisfied that this was a distinct outfit with no connection to the previous operators. They had no concerns regarding the experience of the applicants, but this was a new nightclub in a challenging area with previous issues regarding patrons and parking problems. They had good dialogue with the applicants, and they had put together a series of comprehensive documents which were vital should a serious incident occur. They were content with the application up to framework hours. The risk of drugs and serious incidents in nightclubs were high. The noise team said that the applicant had agreed conditions to help prevent noise from amplified music and patrons' dispersal to a noise management plan. The applicants had engaged well but the noise team would prefer the granting of a licence at framework hours.

The applicants representative stated that they were aware of the history of the site. He thanked the Responsible Authorities for the work that had been carried out regarding the application. He submitted further amendments to hours to be Sunday to Thursday for the sale of alcohol to 1am with late night refreshment to 1.30am and on Friday and Saturdays, the hours for the sale of alcohol to 2.30 or 2.40am with a 3am closing time to allow for dispersal. However, it was accepted that this was a matter for the Sub-Committee. He stated that the applicants had more than 35 years' experience and they had no connection with the previous operator. They had included all conditions on the previous licence, a further 24 conditions agreed with the police and noise team and two additional conditions on critical incidents procedures and parking. Work experience history was detailed in the circulated summary and the applicants were already working in live events. They would be working with music promoters, the music venue trust, local councillors and the GLA and requested these hours be granted, particularly in terms of sustainability. With regard to the searching policy, they would have a robust random system at the door and if a more stringent search was required patrons would be led to the managers' office. They hoped to operate as a multi-purpose site and had an open-door policy with residents and the Council. It was unfortunate that the previous operator had given the premises a bad reputation.

In response to questions, it was noted that the applicant had previously run a venue in London which held about 2000 people. They wished to open this venue up as a communitybased venue with an eclectic mix of music. They would not be limited to one style of band and hoped to promote emerging talent and would also be looking at youth or fringe theatre groups. They considered that the venue was adaptable and there was a night tube available. They had meetings lined up over the next few weeks and had a calendar to the end of the year. They had a new security team which included street marshals with body cams to assist with parking. This would aid residents and also deter illegal parking. There would be six security guards and two street marshals. As an example; they would be offering dinner with a band first with DJs after. They were asking for a longer time for dispersal so were requesting longer closing hours. An application for Temporary Event Notices (TENs) would be problematic as events were in the calendar to the end of the year and they would need firm hours to work to rather than the need to apply for TENs. They would be looking to have live music five days a week. They had employed a well-known security team. They would persuade patrons not to use cars. They would not be having club nights only. They had contacted the Better Archway Forum and received no response but would follow this up.

In summary, the Licensing Authority and the Police stated that this had been an impressive presentation but would wish the Sub-Committee to remain with core hours. The licensing policy contained framework hours for good reason. The matter of closure was a matter for the Sub-Committee as their concern was around the sale of alcohol. It was accepted that there could be an argument that a longer closing down period could allow better dispersal.

The applicant's representative stated that hours had been pulled back to framework hours from Sunday to Thursday with sale of alcohol hours on Fridays and Saturdays to 2.30am with a 3am close for the reasons outlined at the meeting. Should the Sub-Committee not consider this to be appropriate, he requested that members further consider the sale of alcohol to 2am on Fridays and Saturdays with a 3am close.

RESOLVED

- 1) That the application for a new premises licence, in respect of First Floor, 1 Navigator Square, N19 3TD, be granted to allow:-
 - a) On supplies of alcohol from Sunday to Thursday 9am to 1am and Fridays and Saturdays 9am to 2am.
 - Regulated entertainment, films, live music, recorded music and the performance of dance, Sunday to Thursday from 9am to 1am and Fridays and Saturdays from 9am to 2am.
 - c) The provision of late-night refreshment, Sundays to Thursdays from 11pm to 1am, and on Fridays and Saturdays from 11pm to 2am,
 - d) Licensable activities to be extended from the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day,
 - e) The premises opening hours, Sundays to Thursdays from 9am to 1.30 am and Fridays to Saturdays from 9am to 2.30 am.
- 2) That conditions tabled at the meeting shall be applied to the licence with the following addition:-
 - Two street marshalls shall be employed on Fridays and Saturdays,
 - There should be demonstrable evidence of attempted engagement with residents, the Better Archway Forum and the Council.

REASONS FOR DECISION

The Sub-Committee listened to all the evidence and submissions and read all the material. The Sub-Committee reached the decision having given consideration to the Licensing Act 2003, as amended, and its regulations, the national guidance and the Council's Licensing Policy.

The Sub-Committee took into consideration Licensing Policies 2 & 3. The premises fall within the Junction cumulative impact area. Licensing policy 3 creates a rebuttable presumption that applications for the grant or variation of premises licences which are likely to add to the existing cumulative impact will normally be refused following the receipt of representations, unless the applicant can demonstrate in the operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives.

Representations had been made by the Police, the Licensing Authority and the Noise Team. Two local residents and the Better Archway Forum had also submitted representations.

At the hearing, representatives from the Licensing Authority, the Police and the Noise Team all expressed their support for the application with the agreed conditions attached, provided the hours for the sale of alcohol were within the framework hours for nightclubs set out in Licensing Policy 6.

The Sub Committee noted that unsuccessful attempts had been made by the applicant to engage with the Better Archway Forum.

The Sub Committee was satisfied with the Applicants plans for management of the premises and conditions that had been agreed with the Responsible Authorities. The Sub Committee took into considerations concerns regarding potential parking infringements by patrons.

The Sub-Committee was satisfied that the operating schedule demonstrated high standards of management and that the if the licence was granted with the appropriate hours and with the extensive conditions agreed, would not add to the cumulative impact.

The Sub-Committee concluded that the granting of the licence with the agreed conditions was proportionate and would promote the licensing objectives.

60 REINA DONER KEBAB, 5 JUNCTION ROAD, N19 5QT - PREMISES LICENCE VARIATION (Item B2)

The Sub-Committee noted that this item had been deferred to a future meeting by the applicant.

61 <u>FAIRBRIDGE MINI MARKET, 163A FAIRBRIDGE ROAD, N19 3HS - NEW PREMISES LICENCE (Item B3)</u>

The licensing officer reported that there was no additional documentation to the report.

The applicant's representative stated that the applicant had 23 years' experience. He had held a personal licence since 2003 and had owned shops previously. The shop was a convenience community store. The premises was not in a cumulative impact zone. Opening times would be the same as for the sale of alcohol so there would be no risk in selling alcohol without shutters. Conditions had been agreed with the police and the noise team. Conditions were proposed to discourage street drinking which included, drinks being sold with less that 5.5% abv and no small bottles of spirits. Invoices would be kept. There had been no representations from the responsible authorities and two objections from residents with one resident in support. There had been an issue raised about untidiness outside, but this was not outside this premises and was over the road. There was a condition to keep the area tidy. CCTV would prevent loitering and patrons would be asked to leave the area. It was not considered that the premises would cause problems with residents. It was a community-based shop and the applicant would not wish to upset the neighbours which would be bad for business. He considered that concerns raised by residents would be addressed with the proposed conditions.

In response to questions from members it was noted that a contact number would be placed in the shop window for residents. Any complaints would be noted in the incident book.

In summary, it was noted that the applicant was an experienced operator and had never had any problems with the police. This was a community shop and it was expected to achieve a regular customer base.

RESOLVED

- 3) That the application for a new premises licence, in respect of Fairbridge Mini Market, 163a Fairbridge Road, N19 3HS, be granted to allow:
 - f) The sale of alcohol, off supplies only from Mondays to Sundays from 8am to 11pm.
 - g) The premises opening hours to be Monday to Sundays from 8am to 11pm.

Conditions as detailed at pages 154 to 157 of the agenda shall be applied to the licence.

REASONS FOR DECISION

The Sub-Committee listened to all the evidence and submissions and read all the material. The Sub-Committee reached the decision having given consideration to the Licensing Act 2003, as amended, and its regulations, the national guidance and the Council's Licensing Policy.

The Sub-Committee took into consideration Licensing Policy 4. The Council has adopted a special policy relating to cumulative impact in relation to shops and other premises selling alcohol for consumption off the premises. Licensing policy 4 creates a rebuttable presumption that applications for the grant or variation of premises licences which are likely to add to the existing cumulative impact will normally be refused or subject to certain limitations, following the receipt of representations, unless the applicant can demonstrate in the operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives.

The Licensing Authority received two letters of representation in opposition to this application from local residents and one letter of support. Conditions had been agreed with the Metropolitan Police and the Council's Noise Service. No representations were made by any other Responsible Authority.

The Sub-Committee noted that the hours sought were within the hours specified core hours in licensing policy 6. The sale of alcohol was not the main business of the undertaking. The premises are outside a designated Cumulative impact area and are not near schools or other vulnerable institutions.

The Sub-Committee was accordingly satisfied that the exemptions to the cumulative impact were applicable and that the presumption brought into consideration by Licensing Policy 4 were rebutted.

The Sub-Committee concluded that the granting of the licence with the agreed conditions would promote the licensing objectives.

Councillor Angelo Weekes welcomed everyone to the meeting and officers and members introduced themselves. The procedure for the conduct of the meeting was outlined.

63 APOLOGIES FOR ABSENCE (Item A2)

Apologies for absence were received from Councillors Shaikh and Croft.

64 <u>DECLARATIONS OF SUBSTITUTE MEMBERS (Item A3)</u>

Councillor Phil Graham substituted for Councillor Asima Shaikh and Councillor Heather Staff substituted for Councillor Joseph Croft.

65 <u>DECLARATIONS OF INTEREST (Item A4)</u>

There were no declarations of interest.

66 ORDER OF BUSINESS (Item A5)

The order of business would be as the agenda.

67 <u>BASEMENT, 144 HOLLOWAY ROAD, N7 8DD - TEMPORARY EVENT NOTICE</u> (<u>Item C1</u>)

The licensing officer clarified that the TENs were for the 29 December, the 1 January and the 2 January 2024.

The noise team reported that a S80 notice had been served on the venue on the 27 August 2023. A further complaint had been made on the 29 October 2023 although the noise was not deemed to be a statutory nuisance. The Section 80 notice had been appealed and this had yet to be resolved.

The applicant stated that the notice had been received and since that time the decibels had been reduced. There had been events up until 4.30/5am with no complaints until one in October 2023. This had not been classed as a statutory nuisance and it was considered that this had been caused by customers blowing whistles at a carnival event on that evening. Whistles and horns were no longer allowed and since October there had been no more complaints.

In response to questions, the applicant advised that they would consider a reduction in hours for the first event on the 29 December. There were no themes for the birthday party on the 29 December. The noise limit had been reduced since the notice being served and

TENs had been used with no disturbance. Security measures were in place. The premises had a maximum capacity of 100 persons with a minimum of three SIA registered door supervisors. The applicant considered that half an hour to wind down at the end of an evening was sufficient. The supervisors actively monitored the area until customers had left. They asked cars to move on if loitering outside. Customers were also asked to stand inside the premises if waiting for taxis.

The licensing officer advised that, if the Sub-Committee was minded to grant the temporary event notices, all licence conditions could be applied.

RESOLVED

- That the application for temporary event notices in respect of Basement, 144 Holloway Road, N7 6DU be granted to allow:-
 - a) the sale of alcohol, the provision of regulated entertainment and the provision of late night refreshment from midnight to 2am with a close time of 2.30am on 29 December 2023;
 - the sale of alcohol, the provision of regulated entertainment and the provision of late night refreshment from midnight to 3.30am with a 4am close time on 1 January 2024 and
 - c) the sale of alcohol, the provision of regulated entertainment and the provision of late night refreshment from midnight to 12.30am with a close time of 1am on 2 January 2024.
- 2) That conditions of the existing premise licence be applied to all the temporary event notices.

REASONS FOR DECISION

The Sub-Committee listened to all the evidence and submissions and read all the material. The Sub-Committee reached the decision having given consideration to the Licensing Act 2003, as amended, and its regulations, the national guidance and the Council's Licensing Policy.

The Sub-Committee heard representation from the environmental health officer that the application was objected to on the ground of nuisance following a statutory notice issued on 27 August 2023. There had been a further complaint of noise received on 29 October 2023 that had been dealt with informally. It was accepted that there had been no complaints received since that date.

The Sub-Committee heard evidence from the applicant that they had complied with the notice since served and it was under appeal. The applicant had also reduced the decibel levels of music and security measures were in place generally as well as to cover the temporary events. The applicant stated that the incident referred on 29 October was due to whistles being used as part of the carnival theme for an event that day and whistles had since been banned and were not to be used at the events applied for under the temporary event notices. The applicant stated that she had run various events since the banning of the whistles which had not caused any nuisance. The applicant also confirmed that she was willing to reduce the opening hours to promote the licensing objectives and clarified that the date sought under the first temporary event notice was 29 December.

The Sub-Committee considered that the hours needed to be reduced to promote the licensing objectives. The Sub-Committee noted that the 29 December and 2 January were

both working days, however, the latter was outside of the festive period and therefore required further limitation.

The Sub-Committee was satisfied that granting the temporary event notices with the conditions agreed in the existing licence and with reduced opening times, particularly on working days and outside of the festive period, was proportionate and appropriate to the promotion of the licensing objectives.

68 <u>DRIP, 27 CLERKENWELL ROAD, EC1M 4RN - TEMPORARY EVENT NOTICE</u> (Item C2)

The licensing officer reported that the representation dated 28 November and made by the Noise Team was not in the agenda but had been circulated separately. This had been reported verbally to the Sub-Committee.

At this point of proceedings, the Sub-Committee agreed that the applicant's representative make submissions regarding the Noise representation. He stated that an agenda had been published which included a representation dated the 21 November, which preceded the date of the application. He had been informed that there was a further objection which he had seen and, he considered that, as it had not been made within three days and had contained no grounds for objection based on the licensing objectives, it was not a valid representation.

The noise officer stated that he had been minded to object to the temporary event notices but had agreed with the General Manager of the premises to hold his objection pending events held on the 9/10 December. He stated that he was still objecting to the remaining temporary event notices.

In summary, the applicant's representative stated that there had been no physical objection made within the statutory three days. The email dated the 28 November was therefore not a valid representation.

The Sub-Committee deliberated to consider this point before hearing the remaining submissions.

RESOLVED

That it was determined that, in respect of Drip, 27 Clerkenwell Road, EC1M 4RN, no valid representation had been made and the temporary event notices be automatically granted.

These premises are located in the Bunhill Cumulative Impact Area therefore the Licensing Sub-Committee will need to consider Licensing Policy 3, which states that there is a presumption of refusal unless the Sub-Committee is satisfied that there will be no adverse cumulative impact on the licensing objectives.
- 1.7. If the Licensing Sub-Committee grants the application it should be subject to:
 - i. Conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (see appendix 4); and
 - ii. Any conditions deemed appropriate by the Licensing Sub-Committee to promote the four licensing objectives.

2. Background

- 2.1. The current premises licence was originally granted on 18th August 2015 and has always been held by the St. Luke's Community Centre.
- 2.2. This premises licence variation application was received by the licensing service on 5th November 2023.
- 2.3. The Met Police did submit a representation in response to the proposed variation however, this was withdrawn given the condition of approval agreed with the applicant. This condition can be found at appendix 4 of this report.
- 2.4. There were three local resident representations outstanding at the end of the representation period.
 - Copies of these representations can be found at appendix 3.

3. Implications

3.1. Financial Implications

3.1.1. The Head of Finance reports that the applicant has paid the application fee of £450.00. Should the application be refused, the fee is not refundable.

3.2. Legal Implications

Annex 1 - Mandatory conditions

- 1. No supply of alcohol may be made under the premises licence:
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. All door supervisors shall be licensed by the Security Industry Authority.
- 4. The admission of children to the exhibition of a film shall be restricted in accordance with the recommendation of a film classification body as defined in the Video Recordings Act 1984 or Islington Council acting as the licensing authority where it has given notice in section 20(3) of the Licensing Act 2003.

There are further 'Mandatory conditions' applicable to licences authorising the supply of alcohol. A full list of the current mandatory conditions is available from the licensing pages on Islington's web site, www.islington.gov.uk. This list is subject to change by order of the Secretary of State and licensees and other responsible persons are advised to ensure they are aware of the latest conditions.

Annex 2 - Conditions consistent with the Operating Schedule

- There will always be the provision of food available when ever alcohol is being served.
- 2. CCTV shall be installed, operated and maintained in agreement with the Police. Maintained means that the system will be regularly serviced (at least once a year) and checked every two weeks to ensure that it is storing images correctly and a log kept and signed by a Supervisor to this effect. The system will provide an identifiable full head and shoulder image of everyone entering the premises and will operate in any light conditions within the premises. The system will cover the full exterior of the premises and shall record in real time, date and time stamped and will operate whilst the premises is open for licensable activities. The recordings will be kept for a minimum of 31 days and copies will be made available to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24hrs of any request free of charge. There will always be a member of staff on duty who can operate the system, to allow Officers to view recordings and if required by a Police Officer, provide a copy of images immediately free of charge to assist in the immediate investigation of offences. If the system malfunctions and will not be operating for longer than one day of business then Police must be informed.
- 3. A clear and legible notice outside the premises indicating the normal hours under the terms of the premises licence during which licensable activities are permitted.
- 4. Custom will not be sought by means of personal solicitation outside or in the vicinity of the premises.
- 5. Stall will be trained in asking customers to use premises in an orderly and respectful manner, including making sure people leave the premises quietly.
- 6. St Luke's shall not be promoted as a drinking venue.
- 7. The premises manager shall vet all booking to ensure they comply with the Licensing Act 2003. This includes ensuring no booking are taken for person aged 15 25 years old, if the event takes place in the late afternoon or evening.
- 8. Internal and external lighting shall be maintained at the premises.
- 9. Staff will be trained in first aid, fire safety, health and safety, prevention of underage sales and the prevention of public nuisance.

- 10. A log book (incident records) shall be kept on the premises, in which entries shall be made of all inspections made by those required to made by statue, and information complied to comply with any public safety conditions attached to the premises licence that requires to be recorded. The log book shall be made available for inspection by an authorised officer.
- 11. All parts of the premises and all the fittings and apparatus therein, including door fastenings and notices, lighting, heating, electrical, air conditioning, sanitary accommodation and other installations, will be maintained at all times in good order and a safe condition.
- 12. Daily, weekly, and monthly Health and Safety checks shall be place.
- 13. A yearly fire risk assessment shall be implemented by an external consultant.
- 14. Noise reduction measures shall be in place to prevent noise pollution.
- 15. Prominent notices shall be displayed requesting that the public respect the needs of nearby residents and leave the area quietly.
- 16. Deliveries shall be carried out at suitable times to minimise disruption and prevent disturbance to local residents.
- Customers will be asked not to stand outside and talk loudly in the street. 17.
- 18. All lighting on or outside the premises will be positioned and screened in such a way so as to not cause a disturbance to nearby residents.
- 19. Adequate waste receptacles for use by customers will be provided in the local vicinity.
- 20. A challenge 25 policy shall be in operation at the premises, whereby anyone who is under 18 but looks under 25 will be required to carry acceptable Id, such as a card bearing a PASS hologram, a photographic driving licence or a passport if they wish to purchase alcohol.
- 21. A child protection policy shall be in place to ensure the protection the vulnerable people in place. All staff shall be made aware of this policy and its procedure and relevant staff shall be trained in this area.
- 22. All doors and windows to be kept closed, so far as practicable, at all times when noise generating regulated entertainment is taking place i.e. the playing of recorded music, live music, plays, films and performance of dance.
- 23. Notices will be prominently displayed at exits and in the garden requesting the public to respect the needs of local residents when using the garden and to leave the area quietly.
- 24. No refuse including bottles will be moved, removed or placed in outside areas of the premises on Sunday or Bank/Public Holiday and between the hours of 9pm and 8am other days of the week.
- 25. No deliveries on Sunday or Bank/Public Holidays and between the hours of 9pm and 8am other days of the week
- 26. The licensee shall appoint a noise consultant registered with the Institute of Acoustics or Association of Noise Consultants to prepare a scheme of sound insulation and noise control measures to prevent persons in the neighbourhood from being unreasonably disturbed by regulated entertainment from the premises. The scheme shall be submitted for approval by the Council, and the approved scheme fully implemented to the satisfaction of the Council and the licensee notified in writing accordingly, prior to the premises being used for regulated entertainment.
- 27. Where entertainment noise control devices or automatic volume control systems are proposed they shall be calibrated and set up, to meet suitable noise control targets. The installation of such devices shall take place under the supervision of an acoustic consultant registered with the Institute of Acoustics who will provide a certificate of the completion and verification of the calibration and set up, including details of the sound system. An annual check of the effectiveness, with re-

calibration where necessary, of the devices shall be undertaken by an acoustic consultant registered with the institute of acoustics, who shall provide a certificate of verification of the calibration and set up. Copies of the certificates of completion and verification of the calibration and set up, both initially and annually, to be provided to the Council's Licensing Team within 21 days of the check of effectiveness

- 28. If a noise limiting device is installed the entertainment noise control system shall be monitored, checked and calibrated as necessary so that the approved levels set by the Council are not exceeded
- 29. Conditions 27, 28 and 29 will only come into effect if a nuisance is witnessed by a Council Officer.

Annex 3 - Conditions attached after a hearing by the licensing authority

1. The premises garden on the ground floor will be closed and be cleared of patrons by 20:00hrs. The café terrace on the first floor (facing the road) will be closed and cleared of smokers by 21.00. The garden on the ground floor can be used as a smoking area for patrons up to 23:00 hours (22.30 on Sundays) and monitored by the Centre's staff for noise nuisance caused by patrons. Patrons should be asked to leave these areas if they are persistently noisy.

I live at	(diagonally across from 60 King Henry's V	Walk)

I am writing to express my deep concerns regarding the licensing application for a bar at 60 KING HENRY'S WALK, LONDON, N1 ANJ.

While your notification does not make it clear if this is a bar or restaurant or shop (you say shop) the information on the reverse side, which describes alcohol consumption "on and off" the premises, and late hours of operation, certainly makes it seem to be a bar.

If it is to be a late night bar, I am concerned that the Council is considering this application for a quiet residential corner.

This is a quiet family area, with St Jude Street and Queen Margarets Grove being even quieter residential streets which literally meet at 60 King Henry's Walk.

We have already had problems with The Railway Tavern pub causing noise disturbances (I am other residences have reached out to you many times), and even had the participation of Cllr Angelo Weekes involved with the issue of their "temporary" patio on parking bays, which caused a lot of noise disturbances for all of us at the west end of St Jude Street.

So to learn that you are considering an application for a bar, which will sell alcohol, have "recorded music" (loud we assume) until near or past midnight, is of great concern to me and my family.

In terms of your criteria:

The prevention of crime and disorder

• Judging from the information about alcohol being served on the back of your letter, this premises will be injecting more people onto the streets at late hours who have been drinking, which often leads to loudness, bad judgement, and potential aggression.

The prevention of public nuisance

- alcohol consumption and loud music until midnight or later will most definitely constitute a public disturbance, to myself, my family, and all our neighbours near this corner. Loud music will be audible through the glass frontage of this location, and will echo off buildings all around when the front door is opened and closed.
- when people who have been drinking leave this bar/restaurant/shop at night, they will be loud.... we know this from living next to The Railway Tavern. When patrons leave at midnight or later, they will linger outside, talking loudly and laughing as people do when they have been drinking. I am very

concerned about noise from the bar/restaurant/shop when in operation, but also noise from patrons leaving late at night. If this were a high-street location, fine. But this is a quiet residential spot. This type of bar business is not compatible.

Public Safety

- as above, injecting more drunk people onto the street, when there is already a pub on the opposite corner, is just too many drunk people in one (quiet) location - drunk people can be aggressive and belligerent, leading to public safety concerns - this "bar" would be injected twice the amount of people who have been drinking onto the street in the very same location. Literally 5 meters apart.

The protection of children from harm

- there are 2 primary schools very close to this location, one literally across the street. Broken glass on the ground outside a "bar" is not something I consider very safe for children passing every morning and every afternoon. We know there will be broken glass having lived next to The Railway Tavern, that routinely has broken glass on the pavement and road outside that children pass in the mornings. I have seen this time and time again.
- and according to the listed hours of operation, this bar will open at 7:00am, presumably selling coffee? I am not concerned with that, but I do have grave concerns about alcohol and recorded music until near or after midnight every night of the week (except Monday)!

In light of these concerns, I implore the Licensing Team to carefully evaluate the compatibility of this bar business with the tranquil residential nature of the surrounding area. I earnestly request that you reconsider and ultimately reject the licensing application for the well-being and safety of the residents in this community.

Hello Licensing Board,

I trust this message finds you well. I am writing to express my deep concerns regarding the recent licensing application for the establishment near our community. While I understand the importance of fostering local businesses, I believe it is crucial to consider the potential implications on the safety, peace, and well-being of our residents.

I am the owner of and live at St Jude St, London N16 8JT. I have lived at this address for the last 16 years. I know and understand the neighbourhood and street well.

Here are my objections against the criteria you requested:

Crime and Disorder Prevention: The prospect of alcohol being served until late hours raises significant concerns about increased foot traffic on our streets, often resulting in disruptive behavior, impaired judgment, and potential aggression. This could compromise the safety

and security of our neighborhood. We ALREADY have this issue thanks to the RAILWAY TAVERN. Another bar in the area (which is residential) will surely increase the behaviour.

In the past, we have had broken glass outside our door, beers left on on our front window sills and patrons sitting on our front stoop.

Prevention of Public Nuisance: The proposed alcohol consumption and loud music until midnight pose a real threat to the peace of our community. The disturbance caused by these activities, echoing off nearby buildings and audible through glass frontages, will undoubtedly impact the quality of life for myself, my family, and our neighbours.



I understand you have reservations about our application, which you have voiced with the Licensing Committee of the Islington Council. I thought it would be wise to introduce myself, and do whatever I can to ease your concerns over our plans.

During the day we intend to trade primarily as a neighborhood wine shop, providing an interesting, elevated retail experience. We will offer a sensible range of everyday table wine, but will also some fun, by appointment consultations, sourcing fine and rare natural wines to help people curate their cellars. It's niche, I know, but people love these wines and we think it will be a nice experience for our guests.

We aim to open with a very relaxed daytime hospitality offering. We will provide a very limited menu, ie one signature sandwich, one weekly changing special dish and a freshly baked cake/tart gracing the counter. We want this to be an accessibly priced, ideal neighborhood drop-in. We will serve specialty coffee and tea and function much like a café, you'll just be surrounded by lovely bottles and stories available to take home. The venue will open at 11am.

Michelin Star quality food, fine, rare and organic wine – this is what you can expect to find in the evenings at Baudelaire. Whilst we would love for our guests to come by and enjoy a full meal delivered from a lovely little kitchen, we are also very welcoming of having people use the place to pop in for an early aperitif, or a plate of cheese and glass of wine after dinner. We aren't really a restaurant, but it's not really a bar, either. No pints, no shots. Just top quality fare from small, independent producers, and warm, welcoming vibes from experienced staff.

Music is also not something you need worry about. The audience for this space will be mature, and will behave accordingly. We are anticipated a culturally engaged crowd, bringing with them a very different energy than the pub set.

We intend to close by 11pm every evening. We have sought a midnight extension on Fridays and Saturdays simply to afford us a little grace to provide a friendly window to shuffle people off home, should it occasionally be required. We have over six decades of industry experience between us, working in and operating venues of the highest caliber in Australia, The UK, Europe and Asia. - 10. Notices shall be prominently displayed at all exits requesting customers to respect the needs of local residents and leave the area quietly, and to dispose of their waste responsibly. Staff will also encourage customers to do the same.
- 11.A "Challenge 25" age verification policy shall be operated at the Premises during the permitted

- 18. Noise, vibration and odour must not emanate from the premises so as to cause a nuisance to nearby properties.



Annex 1 - Mandatory conditions

- 1. No supply of alcohol may be made under the premises licence:
 - at a time when there is no designated premises supervisor in respect of the a) premises licence, or
 - at a time when the designated premises supervisor does not hold a personal b) licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- All door supervisors shall be licensed by the Security Industry Authority. 3.
- The admission of children to the exhibition of a film shall be restricted in 4. accordance with the recommendation of a film classification body as defined in the Video Recordings Act 1984 or Islington Council acting as the licensing authority where it has given notice in section 20(3) of the Licensing Act 2003.

There are further 'Mandatory conditions' applicable to licences authorising the supply of alcohol. A full list of the current mandatory conditions is available from the licensing pages on Islington's web site, www.islington.gov.uk. This list is subject to change by order of the Secretary of State and licensees and other responsible persons are advised to ensure they are aware of the latest conditions.

Annex 2 - Conditions consistent with the Operating Schedule

- Noise or vibration must not emanate from the premises so as to cause a nuisance to 1. nearby properties.
- In the event of a noise/nuisance complaint substantiated by an authorised officer, the 2. licensee shall take appropriate measures in order to prevent any recurrence.
- Prominent, clear and legible notices must be displayed at all exits requesting the public 3. to respect the needs of local residents and to leave the premises quietly.
- No refuse will be placed on the street more than 30 minutes before collection. 4.
- The delivery of licensable goods shall be restricted to the hours between 07:00 and 5. 23:00 Monday-Saturday. No deliveries shall be made on a Sunday or Bank Holiday.#
- The outside frontage shall be swept and cleared of any rubbish and smoking litter 6. associated with the business at the end of trade each evening.
- Any music shall be restricted to ambient background levels of sound. 7.
- The shutters to the front of the premises shall be maintained so as not to cause a 8. noise nuisance when in operation to residential properties in close vicinity.
- In the event that crime or serious disorder is, or appears to have been, committed on 9. the premises, the management will immediately ensure that:
 - (a) The police and, where appropriate, the London Ambulance Service, are called immediately:
 - (b) As far as is safe and reasonable practicable, all measures will be taken to apprehend any identified suspects pending the arrival of the police;
 - (c) As far as is safe and reasonable practicable, all measures will be taken to preserve any identified crime scene pending the arrival of the police;
 - (d) Any and all appropriate measures are taken to fully protect the safety of all persons present on the premises at all times during operating hours. Page 111

- 10. An incident log shall be kept at the premises, and made available on request to the police or an authorised officer, which will record:
 - (a) Any and all allegations of crime or disorder reported at the venue
 - (b) Any and all complaints received by any party
 - (c) Any faults in the CCTV system
 - (d) Any visit by a relevant authority or emergency service
 - (e) Any and all ejections of patrons
 - (f) Any refusal of the sale of alcohol.
- 11. The refusals log part of the incident book shall be checked and signed monthly by the designated premises supervisor.
- 12. CCTV shall be installed, operated, and maintained, to function all times that the premises are open for licensable activities. This CCTV shall comply with the following criteria:
 - (a) The licensee will ensure that the system is checked every two weeks to ensure that the system is working properly and that the date and time are correct.
 - (b) A record of these checks, showing the date and name of the person checking, will be kept and made available to the police or other authorised officer on request;
 - (c) The Police will be informed if the system will not be operating for longer than one day of business for any reason;
 - (d) One camera will show a close-up of the entrance to the premises, to capture a clear, full length image of anyone entering;
 - (e) The system will provide full coverage of the interior of the premises and any exterior part of the premises accessible to the public;
 - (f) The system will record in real time and recordings will be date and time stamped;
 - (g) At all times during operating hours, there will be at least 1 member of staff on the premises who can operate the system sufficiently to allow Police or authorised Council officers to view footage on request.
 - (h) Recordings will be kept for a minimum of 31 days and downloaded footage will be provided free of charge to the police or other authorised officers on request (subject to the Data Protection Act 1998) within 24 hours of any request.
- 13. The licensee shall ensure that all staff are trained on relevant matters, including the conditions of the premises licence, age restricted products and [if they are ever left in charge of the shop] the operation of the CCTV system and how to deal with visits from authorised officers. The licensee shall keep written records of training and instructions given to each member of staff, detailing the areas covered to include the Licensing Objectives, identifying persons under 25, making a challenge, acceptable proof of age & checking it, making & recording a refusal, avoiding conflict and responsible alcohol retailing. Staff shall sign to confirm that they have received and understood the training .All staff who work at the till will be trained for their role on induction and be given refresher training every six months. The written training records kept for each staff member will be produced to police & authorised council officers on request.
- 14. The premises will operate the 'Challenge 25' proof of age scheme.
 - (a) All staff will be fully trained in its operation;
 - (b) Only suitable forms of photographic identification, such as passport or UK driving licence, or a holographically marked PASS scheme cards, will be accepted.

- 15. The licence holder will at all times maintain adequate levels of staff and security. Such staff and security levels will be disclosed, on request, to the Licensing Authority and the Police.
- 16. The premises licence holder shall endeavour to eliminate or minimise any nuisance arising out of its licensable activities. In doing so the premises licence holder will work with enforcement authorities where any issues are identified. A complaints procedure will be maintained in order that local residents have a means of contact if necessary.
- 17. Ismail Kurt will take no part in the ownership or the day to day running of the premises or be employed there under this licence if granted.
- 18. All staff who work at the till will be trained for their role on induction and be given refresher training every six months. The written training records kept for each staff member will be produced to police & authorised council officers on request. The licence holder and staff will attend any offered Trading Standards training in the sale and supply of alcohol.
- 19. In the event that crime or serious disorder is, or appears to have been, committed on the premises, the management will immediately ensure that:
 - (a) The police and, where appropriate, the London Ambulance Service, are called immediately;
 - (b) As far as is safe and reasonable practicable, all measures will be taken to apprehend any identified suspects pending the arrival of the police;
 - (c) As far as is safe and reasonable practicable, all measures will be taken to preserve any identified crime scene pending the arrival of the police;
 - (d) Any and all appropriate measures are taken to fully protect the safety of all persons present on the premises at all times during operating hours.
- 20. Notices will be prominently displayed by the entry/ exit.
 - A) That CCTV is in use & a Challenge 25 proof of age policy is in operation;
 - B) Advising customers of the provisions of the licensing act regarding underage & proxy sales;
 - C) Of the permitted hours for licensable activities & the opening times of the premises;
 - D) Not to drink in the street;
- 21. A phone number for the premises shall be made available if required upon request to the police, any other responsible authority or any local resident to express any concerns caused by the operation of the premises. Any complaints and the outcome will be recorded in the incident book.
- 22. No alcoholic goods or tobacco products will ever be purchased or taken from sellers calling to the shop.
- 23. No spirits shall be purchased in a resealed box.
- 24. The licensee will immediately report to trading Standards any instance of a caller to the shop attempting to sell alcohol or tobacco products.
- 25. All off sales will be sold in sealed containers.
- 26. Customers will be reminded by way of a notice at the entrance/ exit door to please leave the premises quietly and have consideration for the neighbouring properties.

- 27. Sufficient litter bins will be provided to allow the customers to deposit their waste/rubbish.
- 28. Challenge 25 shall be operated as the proof of age policy and only a valid passport, photo driving licence, HM forces photographic iID card or proof of age card with the PASS logo or hologram on it may be accepted as proof of age.
- 29. Prominent, clear and legible signage (in not less than 32 font bold) shall also be displayed at all entrances to the premises as well as at, at least one location behind any counter advertising the scheme.
- 30. A notice will be displayed at the till either electronically or physically to remind staff to ask for identification.
- 31. The Premises Licence Holder shall ensure that all staff members engaged or to be engaged, in selling alcohol at the premises shall receive the following induction training. This training will take place prior to the selling of such products: Refusing the sale of alcohol to a person who is drunk.
- 32. Further verbal reinforcement/refresher training covering the above will be carried out thereafter at intervals not to exceed six months, with the date and time of the verbal reinforcement/refresher training documented. All such training undertaken by staff members shall be fully documented and recorded. All training records will be kept at the premises and made available to officers of any responsible authority upon request.
- 33. The premises shall at all times maintain and operate refusals recording system (either in book or electronic form) which shall be reviewed by the Designated Premises Supervisor at intervals of no less than 4 weeks and feedback given to staff as relevant. This refusals book will be kept at the premises and made available to officers of any responsible authority upon request.

With reference to the above variation application, I am writing to inform you that the Metropolitan Police, as a Responsible Authority, will be objecting to the variation as it is our considered belief that if granted at present this variation would undermine the Licensing Objectives in regard to prevention of crime and disorder.

The date of the original grant of the licence is 24/11/2020. The premises is applying again after having a similar application declined in 2021 to remove some of the conditions on the existing licence after 'over 2 years of trouble free trading'. The applicant also wishes to reduce the trading hours for the permitted sale of alcohol from 07:00 to 08:00 in the morning, with sales set to conclude as before at 23:00 hours. The conditions that the applicant wishes to remove from the licence are as given on grant by the Licensing Committee:

Annex 3.1 No beers lagers or ciders of above 6% shall be sold at the premises.

*This condition to be modified to include save for a pre authorised range of premium beers lagers or ciders.

Annex 3.2 No spirit miniatures or other bottles at or below 33cl shall be sold from the premises at any time.

Direct removal .No alternative offer or conditioning

Annex 3.3 Single can of beer shall not be sold.

Direct removal. No alternative offer or conditioning

The rationale given is that the hours reduction would comply with the council core hours for off licences and thereby remove the need for these conditions to be imposed, as they were only added to the original licence because the applicant was to trade outside of the council core hours they believe.

Police have no objection to the reduction in early morning hours.

Police have checked with the Council Licensing Officer for the premises when the application was received to see if the agent or premises had contacted them to discuss and they said no. No pre-application consultation appears to have been conducted with the Police either to see if any additional safeguarding could be offered that would meet relevant authority concern re this step or proposal and the application contains no offer of additional or alternative safeguarding when submitted in regard to this increase of availability of alcohol in the area.

As the premises is applying to remove and amend safeguarding and off licence best practice conditions generally in use to help minimize crime and disorder attached after the premises application hearing re strength, miniature sales and single cans because they believe these were only there because of the current hours [which the Police reading of the Council Licensing policy would not support] it would seem appropriate for the premises to present their case to the Committee where the application was determined and the conditions given and to answer any questions or concerns in person as the only entries in the Licensing Objectives promotion boxes only give 'current conditions to remain, save for those requested to be removed'.
