This EIA relates to the approval of accepting Revenue funding of £637,090 from the Greater London Authority for continuance of the Independent Housing Intensive Support Team (IHIS) support team for 2024 - 2025. This internal LBI team supports 60 individuals with a history of rough sleeping who are living independently in their own homes (council accommodation). This scheme has been in existence since 2021 and so far, has supported 81 individuals. The original Revenue funding was from 2021 – 2024, however the Greater London Authority have additional Revenue funding to extend this service until 31^{st} March 2025. Due to the amount – this is a key decision and as such this EIA is being carried out, further to the initial one which was carried out prior to the scheme inception in 2021.

The IHIS team work intensively with individuals to offer personalised support to link in with services as needed, to support tenancy sustainment, in order that people can move on positively after 2 years.

The social benefits of this contract are immense. This service provides a lifeline for individuals who find themselves street homeless and offers a positive move on opportunity for people ready to move on from supported/temporary accommodation, by offering intensive ongoing support for 2 years.

It also offers considerable value to local residents, business and communities by providing another route of accommodation away from the streets, thus reducing rough sleeping in the borough. It also supports the creation of a fairer borough, by offering a safe home and support to some of the most dis-advantaged residents of the borough, who face greater social inequalities on account of additional support needs.



The benefits expected to be realized from this contract are: a continued reduction in the number of people sleeping rough, continued support for 60 individuals living in the IHIS scheme to sustain their tenancies and move on positively, continued move on from supported/temporary accommodation, freeing up much needed spaces for people new to the streets.

The continuation of this funding will offer savings by way of less demand for temporary accommodation for people rough sleeping, by creating through put from supported/temporary accommodation. This also promotes the health and well-being of individuals, likely to result in less demand for acute admissions to A&E, ambulance call outs and reduces the cost to NHS partners.

The service users of the IHIS scheme will feel the greatest impact, as current support will continue to be provided for 12 months until end of March 2025.
