1. Synopsis

- 1.1 This is an application for the variation of a premise licence under the Licensing Act 2003.
- 1.2 The premises currently holds a licence allowing:
 - The provision off sales of alcohol Monday to Sunday from 08:00 until 23:00;
 - Opening hours Monday to Sunday from 08:00 until 23:00.
- 1.3 The variation application is to:
 - To increase the terminal hour for the off sales of alcohol until 00:00 Sunday to Wednesday and until 01:00 Thursday to Saturday;
 - To increase the opening hours for the premises until 00:00 Sunday to Wednesday and until 01:00 Thursday to Saturday.

3.2 The shop is located in the Kings Cross Cumulative Impact Policy area.

4. Planning Implications

- 4.1 The Planning Department have confirmed that there is no planning history in connection with the ground floor commercial unit, but it appears to have been operating as retail within A1 use for many years and thereby the change of hours cannot be controlled by the planning department. The sale of alcohol off the premises is a retail activity and therefore there are no objections to this.
- 4.2 The Planning Department further confirm there are currently no outstanding planning enforcement investigations in relation to this site.

a) General - all four licensing objectives (b, c, d and e) (please read guidance note 9)

We will work closely with relevant authorities including Police and Licensing team to ensure the Council's Licensing policy objectives are adhered to at all times. We will invest resources and time to prevent crime, ensure public safety, prevent public nuisance and harm to children at all times. We will also listen to feedback or concerns made by members of the public and if there are any issues raised we will make every effort to address those concerns. We value the community in which we trade and we will take appropriate responsibility for the wellbeing of our customers and local area.

b) The prevention of crime and disorder

We have at least 3 members of staff during late hours to monitor and supervise customers and we will continue this practice if we are granted the proposed license variation. A staff member will be at the door ensuring there is no obstruction of the pavement and to monitor possible gathering of crowds and all binge drinkers. Furthermore customers will be monitored at all times via CCTV to prevent crime and disorder. We will refrain from selling alcohol to those who are evidently drunk or those who are known alcoholics and during all trading hours we will ensure that anyone that appears under 25 will be asked for ID when purchasing alcohol products.

c) Public safety

We already have positive working relationship with our neighbors and will continue to collaborate to create a safe and pleasant high street. As mentioned previously we will work with customers and local community to maintain a safe high street for local community at all times.

d) The prevention of public nuisance

The premise will have clear signs reminding customers to be considerate of neighbours and residents when leaving the premises at all times. We will also ask customers not to create crowds outside of the premise.

Annex 1 - Mandatory conditions

- No supply of alcohol may be made under the premises licence:
 - at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

There are further 'Mandatory conditions' applicable to licences authorising the supply of alcohol. A full list of the current mandatory conditions is available from the licensing pages on Islington's web site, www.islington.gov.uk. This list is subject to change by order of the Secretary of State and licensees and other responsible persons are advised to ensure they are aware of the latest conditions.

Annex 2 - Conditions consistent with the Operating Schedule

- 1. The restrictions on hours during which the sale of alcohol is authorised does not prohibit:
 - during the first 20 minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
 - b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of alcohol so ordered;
 - c) the sale of alcohol to a trader or club for the purposes of the trade or club;
 - d) the sale of supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval military.
- Alcohol shall not be sold in an open container or be consumed in the licensed premises
- No alcoholic goods will ever be purchased or taken from persons calling to the shop.
- 4. No spirits shall be purchased in a resealed box.
- 5. The licensee will immediately report to Trading Standards any instance of a caller to the shop attempting to sell alcohol.
- 6. Invoices (or copies) for all alcoholic goods on the premises will be kept at the shop and made available to officers from the council, police or HMRC upon request.
- 7. A stock control system will be introduced, so that the licensee can quickly identify where and when alcoholic goods have been purchased.
- 8. An ultra-violet light will be available at the premises for the purpose of checking the UK Duty Stamp on spirits as soon as practical after they have been purchased.
- If any spirits bought by the business have UK Duty Stamps that do not fluoresce under ultra-violet light, or are otherwise suspicious, the licensee shall identify the supplier to Islington Trading Standards and HMRC as soon as possible.
- The licensee shall adopt 'Challenge 25', the Retail of Alcohol Standards Group's advice for off-licences.

- 11. The licensee shall ensure that staff are trained about age restricted products and ensure that they sign to confirm that they have understood the training, which should be regularly reinforced. The training shall include the assessment of age; making a challenge; acceptable proof of age; and recording refusals. The licensee shall keep records of training and instructions given to staff and make them available for inspection upon request by the licensing team, police or trading standards.
- 12. The licensee shall put arrangements in place to ensure that before serving alcohol to young persons, staff ask to see accredited proof of age: that is proof of age cards carrying the 'PASS' logo (and no others), a Passport, or UK Driving Licence bearing the photograph and date of birth of the bearer.
- 13. The licensee shall require staff to note any refusals to sell to young people in a refusals log. The refusals log shall be checked and signed monthly by the designated premises supervisor. The refusals log shall be made available for inspection upon request by the licensing team, police or trading standards.
- 14. CCTV shall be installed, operated and maintained in agreement with the Police. The system will enable frontal identification of every person entering the premises. The system shall record in real time and operate whilst the premises are open for licensable activities. The recordings shall be kept available for a minimum of 31 days. Recordings shall be made available to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24 hours of any request.
- 15. All instances of crime and disorder shall be reported to the police.
- 16. The holder of the premises licence shall subscribe to and participate fully in the local pub/club/shop watch scheme.
- 17. All exit routes shall be kept unobstructed, with non-slippery and even surfaces, free of trip hazards and clearly identified.
- 18. All exits doors shall be maintained easily operable without the use of a key, card, code or similar means.
- 19. Noise or vibration must not emanate from the premises so as to cause a nuisance to nearby properties.
- 20. Prominent, clear and legible notices must be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and the area quietly.



Re: Premises License Variation Application: Caledonian Supermarket 288 Caledonian Rd N1 1BA With reference to the above application, I am writing to inform you that the Metropolitan Police, as a Responsible Authority, will be objecting to this Premises License minor variation as it is our belief that if granted this application would undermine the Licensing Objective: The prevention of Crime & Disorder and the prevention of Public Nuisance

The venue falls within the Kings Cross Cumulative Impact Area where there are a large number of licensed premises. There are 23 License premises within a 250m radius of the venue, 11 of these are On Licenses premises, 5 are Late Night Refreshment venues and 7 are Off-Licenses. Of these 7 Off-Licenses 5 sell alcohol between 8am-11pm Mon-Sat, 10am-midnight Sunday. 1 sells alcohol between 9.30am-9pm Mon-Sat & 10am-6pm Sunday and 1 sells alcohol between 8am - 2am Mon-Sat and 8am-Midnight Sunday.



The above chart shows the total number of crimes in Islington categorised by the Home Office as alcohol crime from September 2013 to August 2015.

The total for September 2013 to August 2013 was 1,780. The total for September 2014 to August 2015 was 1,581. Therefore, there was an overall reduction in alcohol crime of 11% during September 2014 to August 2015 compared to the same period twelve months ago.

These figures show that alcohol related crime is on the decrease and we feel that the reason for this is the current licensing Policy in place and the partnership work the Responsible Authorities. The current licensing Policy and the Cumulative Impact Areas are all assisting in reducing this type of crime.

Hotspot mapping indicates that the main priority areas for these Alcohol related offences were: The night-time economy area covering

- Angel, Upper Street, Chapel Market and Essex Road
- Holloway Road/ Seven Sisters Junction and Seven Sisters Road
- Highbury Corner
- Caledonian Road

We do not believe that there is a need for this venue to sell alcohol until the times requested in the application, it not only falls within the Kings Cross Cumulative Impact Area but is also one of the identified hot spot areas for alcohol related crime within Islington.

It is for these reasons that we propose that this application is refused.

I am submitting a representation on behalf of the Licensing Authority with respect to the variation application for the above premises.

The grounds for the representation are:

- Public nuisance
- Crime and disorder

Issues of Concern

- The premises are located within the Kings Cross Cumulative Impact policy area and
 whist the applicant has proposed several new measures to mitigate against the
 impact of extended licensing hours. The Licensing Authority does not believe that
 these are sufficient to rebut the presumption of refusal as required by the policy
- The premises is currently licenced to sell alcohol until 11pm, the variation
 applications seeks to extend the licencing hours beyond the framework hours in
 Licensing Policy 8.
- 3. The council continues to receive complaints from local residents about the impact of licensed businesses in the area, in particular antisocial behaviour associated with the consumption of alcohol.
- 4. Over the last 3 years, the Licensing Authority has worked with Responsible Authorities and the licenced trade to reduce alcohol related crime, disorder and antisocial behaviour through robust application of the licensing policy, targeted enforcement, late night levy funded street patrols and partnership working. Granting this application to increase the availability of late night alcohol will undermine these efforts.
- 5. It is my opinion that the proposed application will add to the cumulative impact.

Recommendation

This application is not consistent with the Licensing Policy and it is likely to add to the cumulative impact. It is recommended that the application is refused unless the applicant is able to demonstrate to the Licensing Committee why the extension of licensing hours will not add to the cumulative impact or otherwise impact adversely on the promotion of the licensing objectives

Representation from Islington Public Health department on behalf of health bodies providing services in Islington concerning 288 Caledonian Road, London N1 1BA

I am submitting a representation against the application for a licence to permit the sale of alcohol outside framework hours from the above premises. This representation is on behalf of Islington's Public Health Department, which as a responsible authority.

The impact of alcohol is particularly great in Islington with some of the greatest levels of alcohol-related problems in London, including:

- The highest rate of alcohol-specific mortality of any London borough in 2012-14
- The highest rate of alcohol-related hospital admissions in London in 2012-14
- The second highest rate of alcohol-specific hospital admissions in London in 2012-14
- The third highest rate of claimants of incapacity benefit where the main medical reason for being a claimant is alcoholism compared in London in 2012-14

The premises are located on Caledonian Road, which is located in Caledonian ward. The location is within the Kings Cross Cumulative Impact Area described in Islington's Licensing Policy 2013-2017. The area already experiences significant alcohol-related harm, as described below.

The grounds for the representation are:

- Public safety
- · Crime and disorder

The relevant policies in Islington's Licensing Policy

- Policy 2: Cumulative impact and saturation
- Policy 4: Shops selling alcohol
- Policy 8: Framework hours

I am concerned that if this application for extension of hours is granted, it will increase the availability of alcohol for consumption off premises. This could lead to an increase in public nuisance, crime and disorder and impact adversely on health of both those buying and consuming the alcohol but also the health of others who come in contact with them.

Extending the hours of trade for the licence of 288 Caledonian Road would add to the impact in an area which already has high density of licensed premises. At the time of writing this representation, there were 6 on-licenses and 8 off-licenses in the LSOA. This density of off-licenses accounts for 4.6 off-licenses per 1,000 residents – higher than the Islington average. The area already has sufficient premises to meet demand and extending the current supply of alcohol will be detrimental to the local residents in terms of noise and disturbance, anti-social behaviour and crime.

Alcohol and health

Alcohol misuse imposes a major preventable burden to health and the effect of this in Islington is felt across all health services. There is a growing body of evidence that an increased number of alcohol outlets results in significant increases in both alcohol consumption and alcohol-related harm, including injury, violence and medical harm. Evidence from a number of countries indicates reducing alcohol outlet density can have an impact on reducing violence and problem drinking. There is also evidence that changes in hours or days of trading can have a significant impact on volume of alcohol consumed and rates of alcohol related problems.^{3,4,5,6,7}.

Impact of alcohol on health in Islington

The impact of alcohol on health in Islington is particularly severe. Alcohol-specific hospital admissions are those which are wholly related to alcohol (e.g. alcoholic liver disease or alcohol overdose). Islington has the <u>second highest rate in London</u> for hospital admissions where alcohol is the specific cause of admission⁸. The rate is also significantly worse than England.

Harm from alcohol in the vicinity of 288 Caledonian Road, London N1 1BA Ambulance callouts

The data on alcohol-related ambulance callouts reflect where the ambulance attended, not where the individual lives, and therefore includes people who live outside the borough but who come into Islington to work, socialise, etc. Alcohol related ambulance call-outs highlight the immediate harms of alcohol on health and thus the risk to physical safety that alcohol causes. The London Ambulance Service records the callout at Lower Super Output Area (LSOA) level, a geographical area in which an average 1,500 residents live. The LSOA in which 288 Caledonian Road is located experienced 20 alcohol-related ambulance callouts in 2014/15, 36% of these occurred between 2300hrs and 0500hrs.

The proportion of all ambulance callouts that are alcohol related in this LSOA is <u>significantly higher</u> compared to the borough average. The Caledonian ward is ranked 34th highest in this respect out of 118 LSOAs within the borough of Islington.

An alcohol-related ambulance call-out is an indicator that public safety has been compromised by alcohol and many are related to crime and disorder. Local analysis shows a general trend that ambulance callouts increase as the number of licensed premises increases.

Hospital admissions

Alcohol-specific admissions refer to the number of residents admitted to a hospital because of a condition that was wholly attributable to alcohol. Alcohol-specific admissions do not include those seen in Accident and Emergency but then sent home (i.e. those who are seen but not admitted). Data are available at ward level. Caledonian ward, in which the premises are located, had 76 alcohol-specific admissions to hospital in 2014/2015.

Conclusion

Islington experiences some of the highest levels of alcohol-related harm in London and the cumulative availability of alcohol is one area that is likely to be impacting on this.

There is already good availability of alcohol in the area around 288 Caledonian Road, London N1 1BA. At the time of writing this representation there were 6 on-licenced and 8 off-licensed premises within the LSOA.

There is evidence that increased availability of alcohol, both in terms of the time period in which alcohol is available (hours of sale) and number of premises from which alcohol is available, results in an increase in alcohol-related harm. One effect of this is increased pressure and costs to the NHS. The impacts are also felt across a range of groups including the council, policing and the community as a whole.

Recommendation

Islington's Public Health Department recommends that the application for an extension to the hours of the licence to supply alcohol at 288 Caledonian Road, London N1 1BA is to be refused on the grounds that there is already sufficient supply in an area which already experiences high levels of alcohol-related harm.

Suggested conditions of approval consistent with the operating schedule

- 1. The premises licence holder shall work closely woth the relevant authorities, including the Police and Licensing Team to ensure that the Council's Licensing Policy objectives are adhered to at all times.
- 2. The premises licence holder shall make every effort to address the concerns of Members of the public.
- 3. The premises shall employ at least three members of staff from 23:00 until the premises close.
- 4. Staff at the premises shall monitor the outside area to deter people loitering to drink in the vicinity of the premises.
- 5. Staff at the premises shall not sell alcohol to people who are intoxicated with alcohol or drugs.
- 6. Staff at the premises shall not sell alcohol to people who are known alcoholic.
- 7. Signs shall be displayed advising customers that there is a Challenge 25 policy in place and that identification will be sought of those looking younger than 25 years old.
