

- 1. Synopsis
  - 1.1 This is an application for a new premise licence under the Licensing Act 2003.
  - 1.2 The new application is to:
    - I. Supply alcohol for consumption on the premises from 12:00 until 22:30 Monday to Saturday;
    - II. Opening hours of the premises from 12:00 until 23:00 Monday to Saturday.

- 3.2 The application originally had a terminal hour of 23:00 for the sale of alcohol. This was reduced by the applicant to 22:30 following consultation with the Pollutions Team.
- 3.3 The premises is currently unlicensed.

### 4. Planning Implications

4.1 No adverse observations have been received from Planning regarding this new application.

### 5 Recommendations

- 5.1 To determine the application for a new premises licence under Section 17 of the Licensing Act 2003.
- 5.2 To consider that this address is in the Bunhill Saturation or "Cumulative Impact Policy" of Islington. This special policy creates a rebuttable presumption that applications for new premises licences, club premises certificates, or variation applications that are likely to add to the existing cumulative impact will normally be refused, unless the applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact or otherwise impact adversely on the promotion of the licensing objectives.
- 5.3 If the Committee grants the application it should be subject to:
  - i. conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (see appendix 4)
  - ii. any conditions deemed appropriate by the Committee to promote the four licensing objectives. (see appendix 4)

### Conclusion and reasons for recommendations

6.1 The Council is required to consider this application in the light of all relevant information, and if approval is given, it may attach such conditions as appropriate to promote the licensing objectives.

- The supply of alcohol shall be by waiter or waitress service only.
- Notwithstanding the condition above (waiter/waitress service only), alcohol may be supplied and consumed prior to their meal in the bar area (*designated on the plan*), by up to a maximum at any one time, of 12 (Twelve) persons dining at the premises.

### b) The prevention of crime and disorder

- The holder of the premises licence shall subscribe to and participate fully in the local pub/club/shop watch scheme.
- Alcoholic drinks may only be consumed within the premises. The premises licence holder must ensure
  that no alcohol is consumed outside the premises at any time.

#### c) Public safety

Compliance with existing Health and Safety/Fire Safety requirements.

### d) The prevention of public nuisance

- Noise or vibration must not emanate from the premises so as to cause a nuisance to nearby properties.
- Prominent, clear and legible notices must be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and the area quietly.
- Bottling out from the premises is prohibited between 22:00 hours and 10:00 hours.
- Patrons permitted to temporarily leave and then re-enter the premises,
   e.g. to smoke, shall be limited to 10(Ten) persons at any one time.



Many thanks for your letter re New Premises Licence Application Restaurant - 72 St John Street.

We act as Managing Agents for the adjacent residential building.

We would like to object on the following grounds:

- Noise late at night adjacent to a residential block (66 St John Street)
- Hazardous littering from people throwing their glasses around the pavement, to the entrance of our building and throwing up.
- There are more than sufficient licensed premises in St John Street already.

There also needs to be a proper extract system for the restaurant as we have had problems in the past with smells at St John Street.
