

PREMISES LICENCE NEW APPLICATION

69-73 St John Street, London EC1M

1. Synopsis

- 1.1 This is an application for a new premise licence under the Licensing Act 2003.
- 1.2 The new application is to:
 - i) permit the premises to sell alcohol, on supplies only, Sundays to Thursdays from 11:00 until 23:00 and Fridays and Saturdays from 11:00 until 00:00;
 - ii) supply Late Night Refreshment (hot food and drink) on Fridays and Saturdays only to 00:00.

2. Recommendations

2.1 To determine the application for a new premises licence under Section 17 of the Licensing Act 2003.

- 2.2 If the Committee grants the application it should be subject to:
 - i. conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (See appendix 3);
 - ii. conditions recommended by responsible Authorities (see appendix 3); and
 - iii. any conditions deemed necessary by the Committee to promote the four licensing objectives.

- 3.2 A premises licence held in respect of these premises, when it operated as North Road, lapsed in December 2012 when the company holding the licence entered liquidation. This licence allowed:
 - The premises to sell alcohol for consumption on and off the premises, Mondays to Saturdays from 10:00 to 23:00, and 12:00 to 22:30 on Sundays.
 - The playing of recorded music, 24 hours, 7 days a week.
 - The provision of Late Night Refreshment, Mondays to Saturdays until 23:30.
- 3.3 The premises is located within the Bunhill and Clerkenwell Cumulative Impact Policy area, adopted by the Council on 24 January 2013.
- 3.4 The Licensing Authority initially received 11 letters of representation, however 4 of these were subsequently withdrawn. Of the remaining 7 representations, the author of one has requested that they remain anonymous.
- 3.5 In response to the representations the applicant requested that an amended application be considered, with reduced hours in line with those set out in 1.2 above. The applicant also requested that permission to allow recorded music be removed from the application.

4. Planning Implications

4.1 Islington's Planning Service have confirmed that the site was granted planning permission to use the premises as a restaurant and wine bar in 1987, between the hours of 09:00 and 00:00 on any day.

5. Conclusion and reasons for recommendations

5.1 The Council is required to consider this application in the light of all relevant information, and if approval is given, it may attach such conditions necessary to promote the licensing objectives.

M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)

We intend to provide high-end / Michelin-star type food. We hope this will help anchor Clerkenwell on the high-end gastronomy map, attracting well heeled / older customers to the neighbourhood whose primary goal is to enjoy an excellent dinner.

In order to ensure this has a positive effect on the community, we will:

- Ensure drinks are not served without food
- Provide staff will adequate training to deal with situations of disorderly conduct
- Provide staff with an appropriate evacuation plan
- Participate in the local Pubwatch scheme

b) The prevention of crime and disorder

We will:

- Ensure training is provided to staff to ensure compliance with licensing laws
- No alcohol will be served to customers appearing to be drunk, aggressive and on drugs. This will be underlined by signage.
- Not serve drinks without food
- Work with local authorities where required to ensure that we or our patrons do not contribute to any crime or disorder
- Sign up to the Clerkenwell licensing charter

c) Public safety

We will:

- Carry out full risk assessment for the premises, for staff and public, prior to the opening of the premises, and on a regular basis thereafter
- Carry out regular electrical and gas safety checks
- Ensure staff are trained on a regular basis on emergency procedures
- Keep first aid equipment on premises

d) The prevention of public nuisance

We will:

- Keep doors will be kept shut to prevent noise onto the street
- Prevent bottles or glasses from being taken off the premises, particularly when patrons go smoking. We will place signage up in the restaurant as well as remind patrons in person that drinks must stay inside.
- Place notices to ask patrons to keep noise to a minimum outside our premises, respect our neighbours and not obstruct the pavement
- Control sources of noise (refrigeration and ventilation units)

e) The protection of children from harm

We will:


- Only accept children to the dining room with their parents / guardians until 9pm
- Train staff to ensure compliance with the law in relation to consumption of alcohol of under 18s, including prevention of adults buying alcohol for children. This would include operating a Challenge 25 policy.
- Staff will be asked to sign a declaration that they will verify IDs of guests looking 25 years of age and under.
- Signage will be displayed informing patrons of our Challenge 25 policy.

We are the landlords for 62-68 St John Street and our building is located directly opposite the premise licence application at the above address. We object not only on our behalf but on behalf of the residents to:

- Recorded music from 08:00-23:00 Sundays to Thursdays and 08:00-00:00 Fridays and Saturdays
- Sale of alcohol from 11:00-23:00 Sundays to Thursdays and 11:00-00:00 Fridays and Saturdays
- Late night refreshments on Fridays and Saturdays from 23:00-00:00

We are already inundated with bars, restaurants and nightclubs and on exiting are door we are continuously faced with broken glass, rubbish, urinating on the buildings grate and general public disorder and nuisance outside our building. Food and cooking odour is also an issue which currently affects the residents from existing outlets, such as Burger and Lobster.

Furthermore the majority of the residential apartments have bedrooms facing directly onto St John Street . The late licence and noise will greatly affect the residents and there are a number of young children living in the building who will have sleep disturbed. The residents already have to contend with public nuisance, for example people hanging around the building after bars, being noisy and ringing the entry buzzers.

Taking the above objection into consideration we do hope that the Licence is not approved.

I am concerned about this licensing application for a premises which is very close to my flat.

I am concerned that the restaurant intends to sell alcohol, play recorded music late at night and serve hot food and drink during the night.

This is an objection to the proposed license application for 69-73 St John Street to have extended open hours beyond 0:00 and to have a licence to provide late night refreshment between 00:00 and 5:00.

The premises are located within the Clerkenwell Cumulative Impact Area as set out in the Licensing Policy 2013-2017.

Area is now saturated with providers of late night refreshment.

Problems from late night eating and drinking on the streets are documented in the councils pages 10 and 11.

Policy 1 states that in determining licensing applications the Council will take into account the location of premises within a Cumulative Impact Area.

Clerkenwell is a 'Cumulative Impact Area,' under policy 2. There is therefore a rebuttable presumption that applications will be refused.

There is no sound basis for displacing that presumption here.

The use of the premises, in particular the proposed hours of operation, fall outside the exceptional circumstances anticipated in the policy (see para. 6).

When describing the Cumulative Impact Area, the policy states that:

- a. "concerns continue to be raised by residents about public nuisance"
- b. "recent independent research commissioned by the council concerning the impact of licensed premises on Clerkenwell has indicated that 'the impact of licensed premises is a major issue affecting the daily lives of the residents we spoke to' (para. 16).
- c. "whilst improvements have been made the council continues to receive complaints from local residents about the negative impacts of the night time economy in Clerkenwell" (para. 17);
- d. "Having considered all the evidence the Licensing Authority is of the opinion that

Clerkenwell is now saturated with licensed premises and an extension of the cumulative impact area to cover the entire ward of Clerkenwell has been agreed as being appropriate for promoting the licensing objectives" (para. 19).

The premises (and 66 St John Street) both lay within the original Cumulative Impact Area nd are now at the heart of the "saturated" extended area. The issues identified in the policy document and the public nuisance it describes, plainly apply to this application.

Para. 59 (under policy 7) recognises "disturbance to local residents living near licenced premises, fast food outlets, bus stops, train and underground stations that continues through the early hours of the morning. Later opening hours also impact on the response times for the Police, Fire and Ambulance Service as peak demand for their services now extends across a longer period of the night / early hours of the morning, correlating with the increase in late opening. The number of late night premises is now at a level where to allow more would adversely impact on this balance"

[emphasis added]. Again this applies to the current application.

Policy 1 also treats as relevant the location of the premises and the character of the area. In this instance the premises are located in proximity to the apartments at 66 St John Street which are already located within the Cumulative Impact Area where the licensing policy document records the problems that are experienced by residents. There is no good reason to add to these issues. Similarly, the existence of other late-night premises elsewhere in the area is not a sound basis for allowing this application (see para. 1), not least because such premises have prompted the need for the Cumulative Impact Area policy in the first place.

Further, there is no evidence (under policy 1) of past compliance history of the management or of any enforceable commitment to a high standard of management.

Allowing this application would therefore run contrary to the purpose and objectives of the Cumulative Impact Areas policy and it is respectfully requested that it be refused.

This is an objection to the proposed license application for 69-73 St John Street to have extended open hours beyond 0:00 and to have a license to provide late night refreshment between 00:00 and 5:00.

Area is now saturated with providers of late night refreshment.

Problems from late night eating and drinking on the streets are documented in the councils Licensing Policy 2013-2017 pages 10 and 11.

The area has been a 'Cumulative Impact Area' since 2011.

Clause 19 on page 11 shows clear council policy on limiting new licenses:

19. Having considered all the evidence the Licensing Authority is of the opinion that Clerkenwell is now saturated with licensed premises and an extension of the cumulative impact area to cover the entire ward of Clerkenwell has been agreed as being appropriate for promoting the licensing objectives.

69-73 St John Street lies within the Clerkenwell Cumulative Impact Area and we would request that the council refuse to grant the application.

Suggested conditions of approval consistent with the operating schedule

- 1. The licensee shall participate in the local Pubwatch scheme.
- 2. The licensee shall ensure training is provided to staff to ensure compliance with licensing laws.
- 3. No alcohol will be served to customers appearing to be drunk, aggressive or on drugs. This will be underlined by signage.
- 4. Drinks shall not be served without food.
- 5. The licensee shall work with responsible authorities where required to ensure that patrons do not contribute to any crime or disorder.
- 6. The licensee shall sign up to the Clerkenwell licensees' charter.
- 7. The licensee shall carry out full risk assessment for the premises, for staff and public, prior to the opening of the premises, and on a regular basis thereafter.
- 8. Regular electrical and gas safety checks shall be carried out.
- 9. The licensee shall ensure staff are trained on a regular basis on emergency procedures.
- 10. First aid equipment shall be kept on the premises.
- 11. Doors will be kept shut to prevent noise onto the street
- 12. Measures shall be in place to prevent bottles or glasses from being taken off the premises, particularly when patrons go smoking. Signage shall be put up in the restaurant and patrons reminded in person that drinks must stay inside.
- 13. Prominent, clear and legible notices must be displayed at all public exits requesting customers to respect the needs of local residents and to leave the premises and area quietly.
- 14. Prominent notices (a minimum of 2) shall be displayed asking patrons smoking to keep noise to a minimum outside the premises, respect the neighbours and not obstruct the pavement.
- 15. The licensee shall control sources of noise (refrigeration and ventilation units).
- 16. Children shall only be accepted to the dining room with their parents / guardians until 9pm.
- 17. Staff shall be trained to ensure compliance with the law in relation to consumption of alcohol of under 18s, including prevention of adults buying alcohol for children. This would include operating a Challenge 25 policy.
- 18. Staff shall be asked to sign a declaration that they will verify IDs of guests looking 25 years of age and under
- 19. Signage shall be displayed informing patrons of our Challenge 25 policy.
