Road Traffic Regulation Act 1984

The A503 GLA Road (Tollington Road and Parkhurst Road, London Borough of Islington) (Temporary Suspension of Bus Lane and Parking Baye) Order 2007

1. Transport for London hereby gives notice that it intends to make bove named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

The purpose of the Order is to enable works to take place on the A503 Tollington Road to upgrade a junction and the A503 Parkhurst Road to construct a new pedestrian crossi

The effect of the Order will be to:

(a) suspend the bus lane on the A503 Parkhurst Road between Chambers Road and the A1 Holloway Road; and to prevent stopping on the south-east side of the A503 Parkhurst Road between a point 3 metres north-east of the extended common boundary of No's 57 and 59 Parkhurst Road and a point 4 metres north-east of the extended common boundary of Nos 61 and 63 Parkhurst Road;

(b) and to prevent stopping on the A503 Tollington Road bets its junction with Homsey Road and the common boundary of Nos 70 and 72 Tollington Road.

The Order will be effective from 00:01 hours on 15th October 2007 to 23:59 hours on 14th December 2007 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

The prohibitions will not apply in respect of:

(1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes

(2) anything done with the permission or at the direction of a police constable in uniform or a parking attendant.
