

PREMISES LICENCE REVIEW APPLICATION

RE: UNIQUE NEWSAGENT, 336 HOLLOWAY ROAD, LONDON, N7 6NJ

1. Synopsis

- 1.1 This is an application by Trading Standards for a Review of the Premises Licence under Section 51 of the Licensing Act 2003. A copy of the review application is attached as Appendix 1.
- 1.2 The grounds for review are related to the licensing objectives:
 - i) Protection of Children from Harm

2. Recommendations

- 2.1 To determine the application to review the premises licence under Section 52 of the Licensing Act.
- 2.2 The Committee must have regard to the application and any relevant representations. The Committee must take such steps as necessary for the promotion of the four licensing objectives.
- 2.3 The steps stated in Sections 52(4) of the Act are as follows:
 - a) to modify the conditions of the licence; and for this purpose the conditions of the licence are modified if any of them are altered, omitted or any new condition is added;
 - b) to exclude a licensable activity from the scope of the licence;

- c) to remove the designated premises supervisor;
- d) to suspend the licence for a period not exceeding three months;
- e) to revoke the licence;
- f) the Committee also have the option to leave the licence in its existing state;
- g) the Committee also has the power in relation to steps a) and b) to provide that the modification and exclusion only has effect for a limited period not exceeding three months.

3. Background

- 3.1 The premises are currently licensed for the sale of alcohol for consumption off the premises Monday to Saturday from 08:00 to 23:00 and on Sunday from 10:00 to 22:30.

3.3 The Licensing Authority has received a representation from Metropolitan Police, a business and three local residents. The business and local resident's representations are supporting the premises against the review.

Recommendations

There have been two sales of alcohol to underage people made within a year by Mr Haria, the owner, licensee and designated premises supervisor of the business, although it is worth noting that the business is not known to have been a problem to Trading Standards in the previous 22 years of Mr Haria's ownership.

Before and in between the offences, Mr Haria received advice in person and in writing showing him how he could avoid selling to underage buyers. A significant part of this advice was the need to use the 'Challenge 25' rule and this was stressed at the Officer Panel Mr Haria attended and in the follow-up letter. However, on the occasion of both sales, Mr Haria indicated that he thought the volunteers were over 18, but less than 25.

I recommend that the proposed conditions below are added to the licence and the Committee may wish to consider a short suspension as a deterrent against falling from a high standard of management in future.

Proposed conditions:

- The licensee shall adopt 'Challenge 25', the Retail of Alcohol Standards Group's advice for off-licences, and promote it through the display of posters.
- The licensee shall ensure that staff are trained about age restricted products and ensure
 that they sign to confirm that they have understood the training. The training shall include
 the assessment of age; making a challenge; acceptable proof of age; and recording
 refusals. The licensee shall keep records of training and instruction given to staff, detailing
 the areas covered, and make them available for inspection upon request by the licensing
 team, police or trading standards.
- The licensee shall put arrangements in place to ensure that before serving alcohol to
 persons they believe to be less than 25, staff ask to see accredited proof of age: that is,
 proof of age cards carrying the 'PASS' logo (and no others), a Passport, or UK Driving
 Licence bearing the photograph and date of birth of the bearer.
- The licensee shall require staff to note any refusals to sell to young people in a refusals log. The refusals log shall be checked and signed monthly by the designated premises supervisor. The refusals log shall be made available for inspection upon request by the licensing team, police or trading standards.

WARNING LETTER

Thank you for attending the Licensing Officer Panel on Friday 30 March 2012 when you met David Fordham, Head of Trading Standards, Don Stewart of the Islington Police.

You were asked to attend the meeting following a test purchase exercise at your premises on 17 February 2012 when alcohol was sold to a young person. On that date you personally sold a can of Fosters Lager to two volunteers, aged 15 years and 17 years. It was noted that the last entry into your refusals book was 25 March 2010.

At the meeting you told us that the sale took place while you were busy dealing with an oyster card and lottery purchase and you accept you made a mistake. You said you were aware of "Challenge 25" and were now displaying posters in your shop to advise customers. You now have the refusals book next to the till to make it easier to use.

You told us that you and your wife were the main people running your shop with some help from another person at weekends.

Both Don Stewart and David Fordham warned you that any further sales to young people would result in a review of your alcohol licence which could be revoked.

Here is a summary of actions that were discussed and which will help you prevent any further sales to young people

- Challenge 25 challenge any customers who look under 25 and ask to see photo identification to confirm they are over 18. Place a poster near the point of sale.
- Use the refusals book make a note of refusals in you refusals book. This shows us you are operating a good system. You should also check that the book is being completed by all staff as gaps may suggest a lack of confidence in refusing.
- Staff training Read through the trader advice pack that was given to you and ensure your wife and son are up to date. Make a record of this training in your training book as this shows you are taking this issue seriously.

If you suspect an adult may be buying alcohol for under aged people you have a right to refuse that sale.

Annex 1 - Mandatory conditions

- 1. No supply of alcohol may be made under the premises licence
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the Operating Schedule

- 1) The restrictions on hours during which the sale of alcohol is authorised does not prohibit:
 - a) during the first 20 minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel:
 - b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of alcohol so ordered;
 - c) the sale of alcohol to a trader or club for the purposes of the trade or club:
 - d) the sale of supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval military.
- 2) Alcohol shall not be sold in an open container or be consumed in the licensed premises



My daughter, now nineteen has grown up experiencing a friendly responsible atmosphere.


There has never been a hint of bad practice, all people are treated with respect and courtesy irrespective of of their age or gender.

When he originally decided to apply for the Off Licence Permit he even asked me and other customers what we thought in case we were against it.

I hope the committee will not be too harsh on him as his shop is good for the community because unlike the big faceless supermarkets he knows his regular customers and looks out for them if he hasn't seen them about especially the more elderly ones.
