DRAFT PROPOSAL - NHS Support for Social Care: 2013/14

The Government has provided non-recurrent funding of £4.6m (for 2013-14) to the NHS Commissioning Board to be used to support adult social care within the Islington area, which also has a health benefit. Local health partners have been tasked with working together with the Council to agree how the funding is best used within social care. Decisions on spend are expected (by Government) to take into account the Joint Strategic Needs Assessment for the borough and existing commissioning plans for both health and social care.

The NHS funding will enable Islington Council to maintain service provision at the current level for residents with moderate needs, which will benefit both social care and health care as it will prevent more costly interventions in the future.

The 2013/14 allocation is detailed below.

It should be noted due to this funding being non-recurrent the council may face future cost pressures, for example from on going costs of placements, that will need to be resolved as part of the 2015/16 budget setting process.
