- (a) That, subject to the deletion of "B2B Create" from the Appendix to the report, the current grant awards from the Voluntary and Community Sector Grants Fund and the Advice Fund, as detailed in the Appendix of the report of the Executive Member for Community Development, be approved for twelve months to 31 March 2016.
- (b) That consideration of a grant award extension to the organisation B2B Create be considered at the next meeting of the Committee.

Reasons for decision

Extending grant awards from the Voluntary and Community Sector Grants Fund and the Advice Fund for twelve months will enable the Council to develop a resiliency strategy with the voluntary sector and consider how best to provide support for local organisations after 2016.

SUBJECT: LOCAL INITIATIVES FUND

1. Synopsis

1.1 The voluntary and community sector lies at the heart of the council's ambition for a fairer Islington. In 2011 an Islington Community Fund was established to support local organisations working with the borough's diverse communities and to help them respond to the needs of vulnerable residents. An important element of the Islington Community Fund is the Local Initiatives Fund which has a funding allocation of £320,000 per year. Each ward has £20,000 per year to spend on local schemes. Ward councillors consider project ideas for their ward and make recommendations to the Voluntary and Community Sector Committee. This report outlines the process for administering the Local Initiatives Fund and sets out the latest proposals submitted by ward councillors.

2. Recommendations

- 2.1 To consider the new proposals submitted by ward councillors as set out in Appendix A and to agree these proposals in principle subject to the Assistant Chief Executive (Strategy and Community Partnerships) being satisfied that the necessary checks have been made and any other issues resolved.
- 2.2 To note the amendments to the ward budgets resulting from project funding being returned. The amendments are included in the budget summary on Appendix A.

3. Background

- 3.1 On 17 March 2011 the Executive agreed to strengthen the role of ward councillors by building on existing 'neighbourhood arrangements' for some wards and establishing a mechanism for a more focussed ward based approach throughout the borough. From 2011-12 onwards, the new Ward Partnership arrangements replaced the previous Area Committees which were abolished at Council on 31 March 2011.
- 3.2 A report relating to the Islington Community Fund was agreed by Executive on 17 March 2011. This proposed the creation of the Local Initiatives Fund to replace the existing £320,000 of Area Committee Budgets from 2011-12 onwards, with each ward having an allocation of £20,000 per year. Council subsequently agreed at its meeting on 31 March 2011 to reallocate the £320,000 comprising the Area Page 15
 Page 1 of 3

Committee budget to the Local Initiatives Fund.

- 3.3 As Ward Partnerships are not formally constituted committees of the Council, it is not legally possible for ward councillors to allocate funding so an alternative mechanism was required to allocate the budgets previously managed by Area Committees.
- 3.4 At Executive in March 2011 it was agreed that a Voluntary and Community Sector (VCS) Committee of the Executive be set up to oversee matters relating to Council engagement with the voluntary and community sector, including decisions around allocation of the Islington Community Fund. This committee enables Executive Members to steer funding towards those organisations and types of services they feel are of most value in tackling priorities around employment, crime, housing and in enhancing the role of ward members in their local areas.
- 3.5 The Terms of Reference for the VCS Committee include 'To be responsible for the allocation of the Islington Community Fund including...allocating the Local Initiatives Fund having regard to the recommendations of the relevant ward members/relevant ward partnership or neighbourhood group and on the basis that the funding will be allocated equally among the 16 wards making up the Council's area'.
- 3.6 The Local Initiatives Fund enables councillors to respond directly to priorities in their ward that lie outside of the current mainstream funding programmes and might not otherwise receive funding. They enable councillors to suggest improvements to local services or facilities, which would benefit from financial assistance.
- 3.7 In April 2011, the VCS Committee agreed that each ward councillor be given a notional allocation of the Local Initiatives Fund budget (i.e. divided equally between the councillors elected for each ward). Councillors can then make recommendations as to how that money should be spent although the final decision (which used to sit with the Area Committees) is now taken by the VCS Committee. From 2011-12 onwards, £20,000 is available to each ward therefore the notional allocation for each councillor is £6,666. In September 2014 the VCS Committee agreed to introduce a minimum award of £250 per project.
- 3.8 The Third Sector Partnerships team in Strategy and Community Partnerships manages the Local Initiatives Fund budget in liaison with ward councillors and the VCS Committee. The team has a lead role in managing the Community Fund and incorporates this into other similar work. Increasingly the team is making links with other small grant programmes in Islington to ensure that funding is fairly spread across the borough and provides good value for money.

4. Implications

4.1 Financial implications:

The proposals referred to in this report will be met from budget allocations for the Local Initiatives Fund.

4.2 Legal Implications:

The general power of competence pursuant to Section1 of the Localism Act 2011 which came into force on 6 April 2012 provides the Council with very broad powers 'to do anything that individuals generally may do'. This covers the power to give grants to voluntary and community sector organisations as proposed in this report and includes anything which it considers is likely to achieve the promotion or improvement of the economic, social or environmental well-being of the whole or part of its area or all or any of the persons resident or present in that area. The provision of grants for the voluntary and community sector is likely to promote the social and economic well being of Islington's residents. In exercising the general power of competence regard must be had to the Council's Sustainable Community Strategy which has "improving access for all" as one of its objectives.

The Council is under a fiduciary duty to ensure that its resources are used appropriately. Where the money is allocated to outside bodies, the requirements of the procurement rules may apply. In any Page 2 of 3

event it will be important to maintain current practice of ensuring that the money will be used for the purposes for which it is allocated and that individual members are made aware of the responsibility they bear in making recommendations in relation to specific groups.

4.3 Environmental Implications:

When considering proposals the Executive will take relevant environmental implications into account.

4.4 Resident Impact Assessment:

The Council must, in the exercise of its functions, have due regard to the need to eliminate discrimination, harassment and victimisation, and to advance equality of opportunity, and foster good relations, between those who share a relevant protected characteristic and those who do not share it (section 149 Equality Act 2010). The Council has a duty to have due regard to the need to remove or minimise disadvantages, take steps to meet needs, in particular steps to take account of disabled persons' disabilities, and encourage people to participate in public life. The Council must have due regard to the need to tackle prejudice and promote understanding.

When considering proposals the Executive will take relevant equalities implications into account. The recommendations in this report directly respond to concerns highlighted in the impact assessments of (a) the loss of Islington Strategic Partnership funding; and (b) the proposals for achieving savings across the Council. A further Equality Impact Assessment (EIA) was completed to assess the impact of the new Islington Community Fund on different groups of residents. The impact was found to be mainly positive. Where actual or potential impacts were identified, further actions were proposed to mitigate these. A copy of the EIA was published as an appendix to the Islington Community Fund report to Executive Committee on 17 March 2011. The proposed Local Initiatives Fund allocations will not make any material difference to the findings of these earlier impact assessments.

5. Conclusion and reasons for recommendations

5.1 The recommendations in this report will help to develop and sustain a healthy voluntary and community sector in Islington. The Local Initiatives Fund provides an opportunity for the Council to fund small projects for which funding through other channels is unavailable. It is important that processes are clear and that they enable efficient and effective allocation of the available budget.

LONDON BOROUGHS GRANTS COMMITTEE - LEVY 2015-16

1. Background

- 1.1. This report seeks approval for the London Boroughs Grants Committee (LBGC) 2015-16 provisional budget, and the payment by the Council of its annual subscription. The Council, together with other London boroughs, is a member of the LBGC. Accordingly the Council is required to approve the annual committee budget (£10.5m in 2015-16) and the Council's levy (£231k in 2015-16).
- 1.2. The Council's annual subscription currently contributes towards the funding of many London-wide organisations providing a wide range of services. These services are accessible by Islington residents and contribute towards the Council's priorities including tackling crime and providing decent and affordable housing. Islington residents and Islington-based organisations currently receive considerable benefit from the annual subscription. The net-benefit to Islington residents is estimated to be about £0.4m per annum.

2. Recommendations

- 2.1. To note the LBGC proposed 2015-16 annual budget of £10.5m (paragraph 3.3).
- 2.2. To agree, Islington's estimated contribution of £231k in 2015-16, an increase of 0.9% or £2k on the 2014-15 contribution (paragraph 3.4).

3. London Boroughs Grants Committee Levy - Analysis

- 3.1. The London Councils Grants Committee has agreed the following priorities; these reflect some of the Council's priorities and historically the funding has been of benefit to both Islington residents and Islington based voluntary organizations:
 - Homelessness
 - Sexual and Domestic Violence
 - Tackling Poverty (through advice and training for employment)
 - Support for London's voluntary and community organisations
- 3.2. Islington currently benefits in two ways from being a member of the Committee.

- 3.2.1. Firstly, it is currently estimated that about 18% (£1.572m) of the current year funding approved by the LBGC is allocated to commissioning organisations based in the borough, although most commissioning organisations provide services across London and in many cases benefit Islington residents.
- 3.2.2. Secondly, it is estimated that up to £0.4m (4%) of the current funding benefits Islington residents. This has included funding to organisations subcontracted to provide services by commissioning organisations, including Alone in London Service and Hillside Clubhouse.
- 3.3. The total budget for the scheme will be £10.5m in 2015-16. Total borough contributions will be unchanged at £9m in 2015-16. Borough contributions towards administrative costs will be £0.4m in 2015-16, unchanged again from 2014-15. The remaining c£1m will be financed by European Social Fund grants.
- 3.4. The Islington contribution to the scheme is expected to increase from just under £229k in 2014-15 to just under £231k in 2015-16.

4. Implications

4.1. Financial Implications

- 4.1.1. The 2015-16 levy is in line with budget expectation.
- 4.1.2. The budget is subject to the agreement of London Councils Leaders Committee on 9th December 2014 and the agreement of two-thirds of London boroughs by the end of January 2015.

4.2. Legal implications

4.2.1. Under the constitution of the LBGC, the Council is required to confirm the Committee's budget and its own contribution. The Council is required to inform the Committee of its approval or otherwise by 1st February 2015.

4.3. Equalities Impact Assessment

4.3.1. A significant proportion of the grants made by the Committee are to organisations meeting the needs and priorities of a wide range of Islington's community, and in particular aimed at improving equality within the borough.

4.4. Environmental Implications

4.4.1. There are no direct environmental implications arising from this report.

SUBJECT: Support to Local Voluntary Organisations: Discretionary Rate Relief Awards and Procurement Strategy for Islington Community Chest

1. Synopsis

1.1 This report sets out the background to a review of support to local voluntary organisations in the context of the savings challenge facing the council. To help sustain a healthy voluntary sector in Islington it asks the VCS Committee to agree discretionary rate relief awards for five years to 172 local organisations and a process for considering applications from other organisations that become eligible in the future. It also recommends a procurement strategy for Islington Community Chest which would enable successful partnership arrangements to continue for three more years, and the extension of a grant award from the VCS Grants Fund to one organisation.

2. Recommendations

- 2.1 To agree discretionary rate relief awards to the organisations listed at Appendix A for five years from 1 April 2015 to 31 March 2020.
- 2.2 To agree that applications from organisations that become eligible for discretionary rate relief after these awards have been made will be considered by the VCS Committee twice a year in January and July.
- 2.3 To note that the current arrangements for Islington Community Chest are working well and on this basis to invite the Cripplegate Foundation to submit a proposal to the VCS Committee for future support and development of the programme. The proposal will be considered by the VCS Committee in March 2015 for a three year council contribution of £200,000 per year from 1 April 2015 to 31 March 2018, subject to council's final budget approval in February 2015.
- To agree to extend the current grant award from the VCS Grants Fund to the organisation B2B Create for twelve months to 31 March 2016, as set out in paragraph 3.24 of this report. The award is worth £5,000 per year.

3. Background

- 3.1 The voluntary sector lies at the heart of the council's ambition for a fairer Islington. Each day, hundreds of staff and volunteers in community organisations across the borough provide valuable services to our most vulnerable residents. In 2013/14 the council spent almost £40m on services delivered by the voluntary sector.
- 3.2 Unprecedented cuts in government spending present enormous challenges to maintaining essential services and responding to new demands. Since 2010/11 the council has had to cut its spending by £112 million and we expect to have to find another £95 million savings over the next four years. By 2018 we expect our overall budget to have more than halved since 2010.
- 3.3 Reduced resources mean that we will have to find new ways of meeting our priorities, which residents say are jobs, housing and coping with the rising cost of living, and we are open to voluntary sector solutions to improving local services. We want to work with innovative organisations that are well run, provide value for money and deliver positive outcomes for residents.
- 3.4 The council acknowledges the importance of its financial support to local voluntary groups and to the infrastructure that sustains and enables the wider sector to flourish. We will continue to provide funding, and although we won't be in a position to do so to the same extent in future years, we believe we can build a resilient voluntary sector in Islington if we work together creatively and imaginatively.
- 3.5 The council is looking at ways of supporting local voluntary organisations to develop greater resilience and independence themselves and within the communities they serve. Suggestions for areas we would like to explore with the voluntary sector, and with other partners, include diversifying income by securing more external funding, reducing costs on things like premises, and strengthening the key skills needed to run successful organisations.
- 3.6 Discussions around developing a resiliency strategy began at the annual Islington Voluntary Sector Conference in November 2014 and there will be further consultation with local organisations in 2015.

Discretionary Rate Relief

- 3.7 There are two types of rate relief:
 - (a) Mandatory Rate Relief which by law is given automatically to any registered charity in the borough and covers 80% of their rates. The cost of mandatory rate relief is met by central government.
 - (b) Discretionary Rate Relief (DRR) can be given by the council to cover the remaining 20% of a charity's rates. It can also pay all or part of the rates of not for profit voluntary organisations that aren't registered charities and so not getting mandatory rate relief.

DRR is an effective way for the council to support the voluntary sector as we only have to pay 30% of the cost of giving it. The rest is funded by central government and the Greater London Authority.

- 3.8 All current DRR awards end on 31 March 2015 and recipients were invited to re-apply to continue receiving DRR from 1 April. Organisations not currently receiving DRR were also able to apply for the first time.
- 3.9 We received 177 applications (Appendix A) which we assessed against the DRR criteria agreed by VCS Committee in 2011 (Appendix B). This focusses our support on local organisations delivering local activity and serving residents from Islington's deprived neighbourhoods and communities. We therefore exclude national and international organisations that happen to be based in the borough but provide little if any local benefit.
- 3.10 Other considerations include how organisations make good use of their premises and we balance the

cost of an individual DRR award against the amount of local benefit. We may cap large awards (over £6,000) and not offer a full 100% of relief from rates. Out of the organisations recommended for approval we propose to only cap Sadler's Wells' award at £15,000 (£4,500 cost to council) to reflect the extent of its local benefit and community engagement programme.

3.11 DRR is **recommended** to 172 organisations (97% of applicants) shown at Appendix A.

Approvals are broken down into the following categories:

- 3.12 Only five applications failed to meet the criteria and are **not recommended**. These are also shown at Appendix A.
- 3.13 In September 2014 VCS Committee agreed that the length of DRR awards from 1 April 2015 should be for three years, with an option to extend for a further two years. The mechanics of the DRR system, with a legally required full financial year's notice of any intention to withdraw or reduce an award, makes this problematic however.
- 3.14 It would require VCS Committee to decide on whether or not to extend DRR awards for a further two years before the end of the 2017/18 financial year. Consequently all organisations would need to be sent the required 12 months' notice of a possible change/withdrawal by no later than 31 March 2017 which runs counter to VCS Committee's intention of giving organisations longer term assurances of the council's support.
- 3.15 It is therefore recommended to award DRR for five years (1 April 2015 to 31 March 2020).
- 3.16 We expect other organisations to apply for DRR over the next few years. This may be because they have just started up; have recently moved into the borough or may have only just found out that they are liable for business rates.
- 3.17 We therefore propose to recommend other applications that we receive to VCS Committee twice a year in January and July. This will ensure that they do not have to wait an unreasonably long time before knowing whether or not they will be given DRR. In practice this should involve no more than half a dozen new awards per year which will be for the period up to 31 March 2020 to align them with the end date for existing awards for other organisations.

Islington Community Chest

- 3.18 Over the last four years Islington Community Chest has proved to be an effective way of supporting grassroots activity across the borough. It provides small grants to local organisations with a turnover of no more than £100,000 a year in most cases less than £50,000 per year and offers additional capacity building, networking and development support. Organisations can apply for one grant per year.
- 3.19 The priority under current arrangements is to support applications from the most deprived areas of the borough with a focus on:
 - Advising and supporting people
 - > Educating people and improving their skills and employability
 - > Reducing isolation and increasing people's involvement in the community
 - > Improving people's mental and/or physical health
 - > Improving the local environment and making communities safer.

- 3.20 Community chest programmes in Islington have been successfully managed by the Cripplegate Foundation for many years. In the existing scheme, established in 2011, the Council contributes £200,000 per year and the Cripplegate Foundation adds £50,000 per year (from which £36,000 per year is deducted to cover the costs of managing the programme).
- 3.21 A panel made up of representatives from Islington Council, Cripplegate Foundation and the local voluntary sector (nominated by Islington Community Network) meets three times a year to consider applications and to make recommendations to the VCS Committee and to Cripplegate Foundation Governors. The final round of awards will be made in March 2015.
- 3.22 Islington Community Chest is one of our most popular grant programmes and feedback from local organisations suggests that it is running well. The partnership model is a good one and on this basis we intend to invite Cripplegate Foundation to submit a proposal to the VCS Committee for future support and development of Islington Community Chest.
- 3.23 The proposal will be considered by the VCS Committee in March 2015 for a three year council contribution of £200,000 per year from 1 April 2015 to 31 March 2018, subject to council's final budget approval in February 2015. As part of their proposal we would like the Cripplegate Foundation to review current priorities, develop new opportunities to promote Community Chest achievements and assess the potential for increasing the size of the Community Chest with contributions from other funders.

VCS Grants Fund Award to B2B Create

3.24 At the VCS Committee held on 12 December 2014 it was agreed to extend current grant awards from the VCS Grants Fund and the Advice Fund for twelve months to 31 March 2016. Due to the interests of committee members present, it was not possible to take a decision in respect of one organisation B2B Create. It was therefore agreed that consideration of a grant award extension to B2B Create should be considered at the next meeting of the VCS Committee. The value of this award is £5,000 per year.

4. Implications

4.1 Financial implications:

Under the business rates retention system, the council bears 30% of the cost of discretionary rate relief (with 50% and 20% borne by central government and the Greater London Authority respectively). Any increase in the overall cost of discretionary rate relief would represent a budget pressure for the council and would need to be offset by additional compensatory savings elsewhere. The grant awards in this report will be met from existing budgets.

4.2 Legal Implications:

Section 47 of the Local Government Finance Act 1988 confers discretion on local billing authorities to grant discretionary rate relief from all or part of the amount of non-domestic rates payable to registered charities and certain non-profit making organisations. Authorities have discretion to award up to 100% relief to non-profit making bodies and can grant up to 20% relief by way of top-up to charitable bodies in receipt of the 80% mandatory relief.

The council may grant rate relief for a fixed period of time. The Non-Domestic Rating (Discretionary Relief) Regulations 1989 require the council to give notice to the ratepayer stating the start date and end date of the period in respect of which relief is given. This provision enables the council to adopt a quinquennial re-application and assessment process for granting discretionary rate relief.

Applications for rate relief should be considered on their merits but taking into account the council's criteria for awarding discretionary rate relief as set out in Appendix B.

The council has power to provide grants to voluntary and community sector organisations under the

general power of competence set out in section 1 of the Localism Act 2011. The council must also ensure that it complies with its duty to secure best value (section 3 of the Local Government Act 1999).

European Union competition rules generally prohibit government subsidies to businesses. Relief from taxes, including non-domestic rates, as well as the provision of grants, can constitute state aid. The council must bear this in mind when granting discretionary rate relief and/or providing grants. However aid provided to organisations that are not in competition with other businesses is not captured by the rules on state aid. Therefore the rules on state aid are unlikely to apply to the organisations in relation to which this report proposes the provision of discretionary rate relief and/or grants.

4.3 Environmental Implications

4.4 Resident Impact Assessment:

The council must, in the exercise of its functions, have due regard to the need to eliminate discrimination, harassment and victimisation, and to advance equality of opportunity, and foster good relations, between those who share a relevant protected characteristic and those who do not share it (section 149 Equality Act 2010). The council has a duty to have due regard to the need to remove or minimise disadvantages, take steps to meet needs, in particular steps to take account of disabled persons' disabilities, and encourage people to participate in public life. The council must have due regard to the need to tackle prejudice and promote understanding.

Organisations recommended for DRR are particularly focussed on serving poor and vulnerable residents and those with protected characteristics. Many groups are based on council housing estates or located in deprived neighbourhoods. The criteria for DRR were drawn up specifically to support organisations serving the most disadvantaged sections of our community and only five applications have failed to meet it.

Islington Community Chest provides resources for small community organisations, many of which are volunteer-led and wouldn't meet the criteria for funding under our other programmes. It enables some of Islington's poorest residents to access community-based services and activities. Analysis of grants awarded since 2011 shows that Islington Community Chest is effective at reaching those with protected characteristics, for example people from black and minority ethnic and refugee backgrounds, women and people with disabilities.

5. Conclusion and reasons for recommendations

5.1 The council has a strong partnership with the voluntary sector and values highly the role that local organisations play in meeting the needs of some of Islington's most disadvantaged communities. Awarding discretionary rate relief to charitable and non-profit making bodies providing community benefit, and initiating a process which would enable successful Islington Community Chest arrangements to continue, are cost effective ways of supporting local organisations and will help to sustain a healthy voluntary sector capable of achieving the best outcomes for residents.

DISCRETIONARY RATE RELIEF CRITERIA

Each case will be considered on its own merits with priority given to efficient and well managed organisations that:

- primarily benefit Islington residents
- demonstrate a link with council priorities and promote a fairer Islington
- relieve the council of providing certain facilities or services
- serve the needs of poorer and excluded sections of the local community
- provide services for and in the borough's most deprived neighbourhoods
- maximise the use of their premises for community benefit
- serve equalities groups protected under the Equality Act 2010

Priority will also be given to:

- local organisations that are funded by the council through grant-aid or service contract
- local organisations that have a governing body whose membership mainly consists of people who live and/or work in Islington or have a strong connection with the borough
- organisations reliant on volunteers to carry out their activities
- self-help groups with few sources of funding to carry out their activities

Other Considerations

- the financial cost to the council incurred in awarding relief
- the organisation's ability to pay its rates
- the amount of central government funding levered in by a discretionary rate relief award to deliver statutory or other council services

Not Eligible for Discretionary Rate Relief

Islington Council will not normally award discretionary rate relief to:

- Profit making organisations
- Empty properties
- Charity shops
- Private schools, colleges, nurseries or schools that are not within the Islington family of schools
- National charity headquarters
- Housing Associations (other than for community centres)
- Car parking spaces
- Buildings exclusively used for worship

Award Limits

The following limits to awards will apply (cost to the council of discretionary rate relief):

Up to £6,000 Organisations will normally be awarded 100% discretionary rate relief

Over £6,000 Awards will be proportionate to the level of local benefit which may be less than 100% discretionary rate relief

SUBJECT: Community Festivals Fund: proposals for review

1. Synopsis

- 1.1 The Community Festivals Fund (CFF) aims to support organisations based in Islington to deliver high quality, innovative, community focused festivals that promote access, cultural benefit, stronger communities and partnership working. These events range from large borough-wide festivals to small scale neighbourhood parties.
- 1.2 The annual CFF budget is £16,000. Currently, the smallest grant provided through the fund has been £250; the maximum grant provided is £1,000. The fund is oversubscribed and applicants to CFF often apply to other council funding streams such as the Local Initiatives Fund (LIF) and Islington Community Chest. This duplication of funding submissions creates additional work for both applicants and council staff. The volume of applications also requires significant officer time to administer what is a modest CFF budget.
- 1.3 To streamline the CFF funding process and to support a more strategic programme of festivals and events that deliver against the council's equalities, place-shaping and community development agendas, this paper recommends revising the eligibility and selection criteria for the Community Festivals Fund.
- 1.4 The revised eligibility and selection criteria would see increased investment in a smaller number of key strategic festivals. Organisations would be able to apply for a minimum grant of £1,500 up to a maximum of £4,000 to deliver festivals and events that provide borough-wide benefit and meet the council's priorities.
- 1.5 In order to ensure continued support for local events of primary benefit to specific neighbourhoods, smaller organisations would be directed to LIF. Applicants seeking funding from CFF would not be eligible to apply to the Local Initiatives Fund for the same event.

2. Recommendations

- 2.1 To agree the revised funding criteria for the Community Festivals Fund to be used from 2015/2016 (attached at Appendix One).
- 2.2 To approve raising the minimum level of funding provided by the Community Festivals Fund to an individual festival to £1,500, and the maximum to £4,000, for those festivals that meet the fund's new strategic ambitions and provide borough-wide benefit.
- 2.3 To agree to the eligibility criteria that applicants seeking Community Festivals Fund support are not eligible to apply to the Local Initiatives Fund to support the same event and that smaller community events primarily of benefit to local neighbourhoods or specific ward areas will no longer be eligible to apply to the Community Festivals Fund but will be directed to apply to the Local Initiatives Fund.

3. Background

- 3.1 The Community Festivals Fund budget is currently £16,000. Funding is used to support a range of community festivals, from small events that engage audiences of around 100 500 people and provide benefit to families and groups within a local neighbourhood or specific ward to larger events that attract audiences of up to 8,000-10,000 from across Islington and the surrounding boroughs.
- 3.2 The CFF scheme is oversubscribed, receiving an average of 25 applications per year since 2010/2011 with the majority of these applications receiving part or full funding (of up to £1000). Total annual grant requests have averaged around £24,230 per annum.

- 3.3 The majority of larger festivals in Islington apply to CFF and other small grant funds offered by the council including the Local Initiatives Fund and Islington Community Chest (administered by Cripplegate) as the current maximum CFF grant is not sufficient to deliver activities or provide adequate match funding for external funding bids.
- 3.4 To streamline the administration of council funding and reduce the impact on applicants who are currently applying to a range of council funds, revised CFF eligibility and selection criteria are recommended for 2015/2016. Key proposed changes to the fund include:
 - Increasing the minimum CFF grant to £1,500 and maximum to £4,000 for individual events
 - Events must provide borough-wide benefit and meet the council's wider priorities around equalities, community cohesion and place-shaping
 - CFF applicants will not be eligible to seek additional funding support through the council's Local Initiatives Funds. Groups must choose to apply to one fund or the other but will not be eligible for funding from both schemes.
 - Smaller community events that primarily provide benefit to local neighbourhoods or specific ward areas would not be eligible for CFF but encouraged to apply to the Local Initiatives Fund.
- 3.5 In addition to meeting these eligibility criteria, applicants for Community Festivals Fund grants will need to illustrate how their proposed event meets the following selection criteria:
 - Cultural Benefit: events deliver high quality, innovative, community focused activities that contribute to Islington's cultural offer
 - **Equality:** festivals recognise and value Islington's diverse communities, promote good relationships between people of different backgrounds and lifestyles and contribute to the council's commitment to making Islington a fairer place
 - Value for Money

- Inclusive and accessible: activities should be open to all the community and accessible and inclusive for Islington's most disadvantaged communities.
- Match Funding: applicants have secured funding to match any council contribution to deliver their event
- Partnership Working: applicants work with other agencies and organisations that may be able to share costs, facilities, expertise, and access to participants or beneficiaries.
- Licensing and Public Protection: applicants comply with all public protection requirements including securing venue permissions, relevant licenses and ensuring public health and safety.

4. **Implications**

Financial implications 4.1

4.1.1 The overall funding available to support festivals outlined in this report will be £16,000 during 2015/16 subject to final budget approval in February 2015. Revised eligibility and selection criteria to provide greater funding to a smaller number of key strategic festivals in Islington will reduce the amount of grant administration time required to manage the Community Festivals Fund, stop multiple applications to CFF and Local Initiatives Fund for single events and ensure that grant funding contributes to the Council's wider equalities, community cohesion and place-shaping objectives.

4.2 Legal Implications

4.2.1 There are no legal implications arising from this proposal. Under Section 2 of the Local Government Act 2000, the Council has the power to give support to organisations in the voluntary and community sector to provide services that are likely to achieve the promotion or improvement of the economic, social or environmental well-being of residents within the local authority's area.

4.3 Environmental Implications

4.3.1 There are no environmental implications arising from this proposal.

4.4 Equality Impact Assessment

4.4.1 The addition of new Equality funding criteria will help strengthen the selection of organisations who will deliver festivals that meet the needs of local residents and communities across the wider borough.

5. Conclusion and reasons for recommendations

Recommendations included in this paper have been made to streamline the Council's funding 5.1 processes, prioritise key strategic festivals that provide borough-wide benefit and ensure funding support given also contributes to the Council's wider priorities around equalities, community cohesion and place-shaping.

Appendix One – Community Festivals Fund 2015/16 – Criteria and Guidance

Community Festivals Fund grants will be awarded in amounts from £1,500 to a maximum of £4,000.

Eligibility Criteria

- Funding is restricted to voluntary, community and faith organisations based in Islington
- Organisations can only apply for funding for one festival in the annual grant round
- Festival applications must demonstrate how they will provide <u>borough-wide benefit for Islington</u> residents
- Each festival will be eligible for one award. Where a number of organisations are contributing different elements of a festival, they should work together to submit one application
- The following are not eligible for funding: events of a political nature; events promoting a religious doctrine; fundraising events; events viewed as offensive or defamatory; profit-making organisations; individuals.
- Community Festivals Fund applicants cannot seek additional funding support through the council's Local Initiatives Fund. Groups must choose to apply to one fund or the other but will not be eligible for funding from both schemes.

Selection Criteria

Applicants for Community Festival Fund grants will need to show that the proposed event meets all of the following funding criteria:

1. Cultural Benefit

Festivals are a key part of Islington's cultural offer. In line with the council's cultural strategy, "Cultural Matters", events will need to deliver high quality, innovative, community focused activities that:

- maximise access to and participation in arts activities
- celebrate Islington's diversity
- improve, animate and interpret the physical environment
- celebrate and interpret the distinctive characters of local areas.

2. Equality

Festivals should promote community involvement and should encourage people from a range of different backgrounds to participate. Festivals will recognise and value Islington's diverse communities, promote good relationships between people of different backgrounds and lifestyles and contribute to the council's commitment to making Islington a fairer place for people to live where discrimination and inequality are addressed.

These values will be visible in event programming by:

- ensuring that participating artists or components of the festival reflect and are attractive to the diversity of local people, cultures and lifestyles in Islington
- involving local people to define festival aims and objectives
- promoting understanding, tolerance and cohesion.

We are particularly keen that festivals will attract people from the following groups (who can often feel excluded from these events) as well as people from across the Islington community.

- Disabled people
- Black and minority ethnic communities
- Refugees and asylum seekers
- Lesbian, gay, bisexual and transgender groups
- Older people
- Young people

Please show in your application which of these groups will attend your event and how you will encourage them to attend. All festivals must be open and accessible to the general public and provide benefit across Islington not just to the organisation's own members.

3. Value for Money

Islington Council is committed to providing value for money in all its services. Event costs should be realistic and clearly itemised with income matching expenditure. If you have organised festivals in previous years you should provide evidence of their success (e.g. press cuttings, photographs and any evaluation reports).

4. Inclusive and accessible

Activities should be open to all the community and accessible and inclusive for Islington's most disadvantaged communities. Applications from organisations that are based in areas of high deprivation will be particularly welcomed. Proposals should demonstrate a commitment to using environmentally friendly policies and practices.

5. Match Funding

Applicants are advised to seek funding from more than one source. This may include contributions from your own organisation, charities, trusts, business sponsorship, other local grant schemes, Arts Council England or the Heritage Lottery Fund. Applicants applying to the Community Festivals Fund cannot seek additional funding support through the council's Local Initiatives Fund.

6. Partnership Working

Applicants are encouraged to work with other agencies and organisations that may be able to share costs, facilities, expertise, and access to or encourage the involvement of participants or beneficiaries.

7. Licensing and Public Protection

Applicants will need to comply with the following public protection requirements. We recognise that some organisations will need guidance to obtain some of these requirements and will be happy to help you with this.

- Venue Permissions: You will need to obtain written permission from the owner of the space you are using, whether you choose a school, a community centre, an estate or other open space, and attach a copy to your application.
- Public Liability Insurance: Funding will be conditional on obtaining sufficient public liability insurance.
 You may be able to arrange cover through your existing insurer. Include the cost of premiums in your budget.
- Entertainment Licensing: If you are putting on any form of entertainment, such as live or recorded music, film or video, disco, bands, or live performance, you will need to apply for an entertainment licence. Applications for a licence need to be received at least 28 days in advance of the event. For all enquiries about this, contact the Council's Licensing Team on licensing@islington.gov.uk or telephone 0207 527 3031.
- **First Aid:** You will need to arrange First Aid cover for your event. If you do not already have a trained first aider, a representative from your organisation must complete training or you will need to hire first aid support for the festival.
- Islington logo: Organisations must include an acknowledgement of the support from the London Borough of Islington by displaying the Islington logo on all festival publicity. This will be sent to you separately, together with guidance on its use, once the grant is awarded.
