### 164 <u>INTRODUCTIONS AND PROCEDURE (Item A1)</u>

Councillor Nick Wayne welcomed everyone to the meeting and officers and members introduced themselves. The procedure for the conduct of the meeting was outlined.

Apologies for absence were received from Councillor Gary Poole.

#### 169 MINUTES OF PREVIOUS MEETING (Item A6)

#### **RESOLVED**

That the minutes of the meeting held on the 3 April 2017 be confirmed as a correct record and the Chair be authorised to sign them.

### 170 TITANIA, 113 HOLLOWAY ROAD, N7 8LT - NEW PREMISES LICENCE (Item B1)

The Sub-Committee noted that confirmation had been received from the applicant agreeing to an adjournment to the 19 June 2017. The interested parties had also been in agreement to this.

#### **RESOLVED**

That the application for a new premises licence, in respect of Titania, 113 Holloway Road, N7 8LT be adjourned until the 19 June 2017.

## 171 <u>HUMBLE GRAPE, 11-13 THEBERTON STREET, N1 0QY - NEW PREMISES LICENCE</u> (Item B2)

The Sub-Committee noted the additional papers tabled; a letter submitted by the interested parties and a proposed list of conditions submitted by the licensing officer reflecting the comments of the interested parties. These papers would be interleaved with the agenda papers. The Sub-Committee noted that the applicant agreed to delete conditions 1, 6 and 7d but stated that they would prefer conditions 3 and 8 to remain.

The licensing officer informed that due to an administrative error, Councillor Gary Poole had been unable to submit a representation.

The licensing authority reported that the latest documents had been considered and in response to a question from the Chair of the Sub-Committee clarified that the representation still remained but should the Sub-Committee grant the application they would suggest imposing the tabled conditions.

The Sub-Committee noted that condition 5 regarding CCTV was a condition that was regularly applied to licences.

The noise team reported that the applicant had agreed the noise conditions.

The interested parties reported that they had met with the applicant. A resident raised concerns that the premises had been food led for the past twenty years and would now be drinks led if this application was granted. The cumulative impact would be significant. There were many residents living in close proximity and they would want the impact to be mitigated. The resident would prefer a condition to restrict the sale of alcohol with the provision of food and they would also require a limit on the number of events held. Residents remained opposed to the off-licence. The resident stated that the area was saturated with off licences. Residents were opposed to the outdoor tables and stated that there was a narrow pavement outside the premises and the noise from customers would be a nuisance to neighbours. There would need to be an off sales licence if serving alcohol to the tables outside. Deliveries were already a nuisance, particularly at those premises adjoining Humble Grape and residents would not want a 10pm delivery service which they considered would change the nature of the establishment.

In response to questions, the Sub-Committee noted that the pavement outside was narrow for tables and chairs outside which made it difficult to pass by unencumbered. The road opposite acted as a funnel for noise from the tables and chairs and the resident stated that there would be a loss of amenity. It was noted that Humble Grape at Fleet Street had a different location type and this application would be judged on its merits in this location. The Sub-Committee noted that this premises had its own curtilage and did not require a tables and chairs licence. However an off licence would be required to serve alcohol to the outside tables and chairs.

The applicant informed the Sub-Committee that the business was a new concept where wines were imported from tiny vineyards and served with ethically sourced food. It would be a seated wine bar which served food. They applicant lived next door to a Humble Grape premises in Battersea and considered that the business would be good for the neighbourhood. The premises would be local neighbourhood reliant and the applicant would distribute telephone numbers and email addresses in case of problems, although it was considered that there would not be any. The member of staff at the reception would show customers to the bar or a table. Wine to be taken away could be selected and taken back to the manager for wrapping. Retail spirits and beers were available at other sites but would not be available at these premises. It was intended that there would be four tables

outside, each with two chairs. A 1.8m gap would be maintained. There would be a manager at the entrance who would supervise the outside area to ensure there was no disturbance. There were no immediate neighbours and the business would not sell alcohol to outside tables after 10pm. It was considered important to undertake deliveries between 6 and 9 pm although the applicant would consider a cut off time between 9pm and 10pm if 10pm was considered too late.

In response to questions the applicant reported that need was not a relevant licensing issue. The nature of the wines to be sold was unique and obtained from different wine regions and would not be able to be obtained elsewhere. The take out percentage was 15% of revenue in the Battersea premises with 20% delivery as percentage of retail sales. There was a reasonable use of the delivery service between 6pm and 8pm and Deliveroo used 60/70% of cycle use and 30% of moped use. After six months of using Deliveroo they may be able to specify use to cycles only. It was likely that there would be 65% alcohol sales and 35% food sales. 80/90% of customers would end up eating some food. The applicant encourages customers to eat and showed them the small plate menu. Providing snacks would often encourage customers to eat more. Walk in custom usually took place between 6-9 pm. Walk in demand after 9pm was low. The applicant stated that he would accept an off sales time restriction of 10pm. The applicant stated that he lived next door to the bar in Battersea and had never been contacted by residents. They had a good dispersal policy. It was noted that the minimum requirement distances for tables and chairs was 1.8m and the applicant stated they would conform to this.

In summary, the resident stated that this was in a saturation zone which had posters on display with the words 'are you thirsty' indicating that this was a drinks led premises. The abv strength of wine was higher than beer. A condition that alcohol could not be served without food would alleviate many concerns. Regarding the pavement area there were concerns that customers outside would be abusive and the pavement crowded. The resident was unsure how a space of 1.8m for tables and chairs would work in the small space and asked that, should the licence be granted, an early finish time of 9pm be conditioned. The scooters would be noisy and a condition to curtail the lateness of delivery orders would be welcome.

The applicant stated that 10% of customers who would not be eating were crucial to the business and having to dine with food would discourage some people attending. The applicant was happy to agree a 1.8m gap for the tables and chairs and invited the Sub-Committee to have a 10pm cut off delivery time. He stated that there would not be pre-booked events.

#### **RESOLVED**

- 1) That the application for a new premises licence, in respect of Humble Grape, 11-13 Theberton Street, N1 0QY be granted to allow:
  - a) To allow the sale of alcohol, on and off sales, Sundays from 12:00 noon until 10pm, Mondays to Thursdays from 11am until 11pm and Fridays and Saturdays from 11am until midnight.
  - b) The provision of late night refreshment, Fridays and Saturdays from 11pm until midnight.
  - c) The premises to be open to the public, Sundays from 12 noon until 10.30pm, Mondays to Thursdays from 10am until 11.30pm and Fridays and Saturdays from 10am until half past midnight.

Conditions detailed on pages 162 and 163 be agreed with the following amendments:-

- Deletion of condition 1.
- Condition 4 Deletion of 'or to persons attending a pre-booked wine tasting event or a pre-booked function'.
- Condition 6 to be deleted.
- Condition 7 d to be deleted.
- Condition 8 to read. Alcohol sold for consumption off the premises will only be as follows:-
- a. Up to 21:00, to persons seated at tables lawfully placed on the private forecourt on Theberton Street, for consumption by those persons seated at such tables.
- b. Up to 23:00 hours, wines only (not spirits, beers or lagers) in sealed containers to persons to take away from the premises.
- c. For delivery by the licence holder or their agent to an address in Great Britain. Delivery agents should not visit the premises after 21:30.

Additional condition. All tables and chairs be removed by 22:00 hours.

#### **REASONS FOR DECISION**

The Sub-Committee listened to all the evidence and submissions and read all the material. The Sub-Committee reached the decision having given consideration to the Licensing Act 2003, as amended, and its regulations, the current national guidance and the Council's Licensing Policy.

The Sub-Committee took into consideration Licensing Policy 2. The premises fall within the Angel and Upper Street cumulative impact area. Licensing policy 2 creates a rebuttable presumption that applications for new premises licences that are likely to add to the existing cumulative impact will normally be refused, unless an applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact or otherwise impact adversely on the promotion of the licensing objectives.

The Sub-Committee noted that the hours sought were now within the hours specified in licensing policy 8 having been amended following consultation with the police.

The Sub-Committee noted that the residents had met with the applicant and had proposed changes to some of the conditions detailed in the report. The Sub-Committee heard evidence from a resident who represented the Theberton Street and Moon and Studd Street Residents' Associations. They raised concerns that the new business would be drinks led rather than a food led premises, which it had been previously, and they were opposed to off-sales in an area of cumulative impact. They were also opposed to tables and chairs outside the premises citing issues including loss of amenity and noise nuisance. They also raised concerns about the noise created from deliveries.

The Sub-Committee heard evidence from the applicant that the business was a unique concept where wines were imported from tiny vineyards from all over the world and food served at the premises would be ethically sourced. It would be a seated wine bar which would have waiter/waitress service. It was not a destination venue and the applicant was keen to secure the patronage of local residents and fit in with the neighbourhood. Customers would be encouraged to order food with drinks. He stated that there would be a manager or trained staff member at the front door who would be responsible for seating customers inside and would also manage the outside area to prevent nuisance from the use of the tables and chairs. The applicant stated that the delivery service was a significant part of the business turnover and it was provided for by bicycles 60/70% of the time.

The Sub-Committee noted the applicants' commitment to engage with residents and also noted that the applicant had a successful similar operation in south London in a residential neighbourhood in Battersea.

The Sub-Committee concluded that granting the application, within the core hours and with the proposed conditions, would not adversely impact on the cumulative area or otherwise impact adversely on the promotion of the licensing objectives.

When making their decision the Sub-Committee also considered licensing policy 8 regarding licensing hours, licensing policy 20 regarding outside areas, licensing policy 9 and 10 regarding standards of management and licensing policy 18 in relation to noise.

The Sub-Committee noted the applicants' commitment to engage with residents and also noted that the applicant had a successful similar operation in south London in a residential neighbourhood in Battersea.

The Sub-Committee concluded that granting the application, within the core hours and with the proposed conditions, would not adversely impact on the cumulative area or otherwise impact adversely on the promotion of the licensing objectives.

When making their decision the Sub-Committee also considered licensing policy 8 regarding licensing hours, licensing policy 20 regarding outside areas, licensing policy 9 and 10 regarding standards of management and licensing policy 18 in relation to noise.

## 172 <u>SOURCED MARKET, 7-12 GOSWELL ROAD, EC1M 7AH - NEW PREMISES LICENCE</u> (Item B3)

It was noted that this item had been adjourned from the meeting on the 22 May in order that planning issues be further considered. One interested party had discussed the application with the applicant and had withdrawn their representation. The Sub-Committee noted that the opening hours would be from 7am to 10pm. In respect of the planning consent, planning officers considered that the proposed use would be ancillary to the hotel use. If the situation changed there would need to be a planning application.

The applicant stated that this was a small premises which was a specialist delicatessen/bakery/café that was seeking to sell alcohol. In other branches, alcohol accounted for 10% of sales and 80% was consumed on the premises. There were likely to be a maximum of 45 customers on the premises.

#### **RESOLVED**

- That the application for a new premises licence, in respect of Sourced Market, Ground Floor, 7-12 Goswell Road, EC1M 7AH, be granted to allow:
  - a) To allow the supply of alcohol on the premises from 11am until 10pm from Monday to Sunday.
  - b) Opening hours to be 7am until 10pm Monday to Sunday.
- 2) That conditions detailed on page 196 of the agenda be applied to the licence.

#### **REASONS FOR DECISION**

The Sub-Committee listened to all the evidence and submissions and read all the material. The Sub-Committee reached the decision having given consideration to the Licensing Act 2003, as amended, and its regulations, the current national guidance and the Council's Licensing Policy.

The Sub-Committee took into consideration Licensing Policy 2. The premises fall within the Bunhill cumulative impact area. Licensing policy 2 creates a rebuttable presumption that applications for new premises licences that are likely to add to the existing cumulative impact will normally be refused, unless an applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact or otherwise impact adversely on the promotion of the licensing objectives.

Four local resident objections had been received. There had been no representations made by the responsible authorities.

The Sub-Committee considered licensing policy 8 and noted that the hours sought had been reduced following discussions with interested parties including a resident who was present at the previous meeting, who had now withdrawn their representation on this basis.

The Sub-Committee heard evidence from the applicant regarding the nature of the operation and noted that it was not alcohol led. The Sub-Committee also noted the limited number of covers provided.

The Sub-Committee concluded that granting the application, within the core hours and with the proposed conditions, would not adversely impact on the cumulative area or otherwise impact adversely on the promotion of the licensing objectives.

When making their decision the Sub-Committee also considered licensing policy 9 and 10 regarding standards of management.

## 173 TRANSPORT, 70-74 CITY ROAD, EC1V 2BJ - PREMISES LICENCE VARIATION (Item B4)

The Sub-Committee noted that this was a variation application to reduce the hours and to amend the plan. Conditions were tabled which had been agreed by the applicant and would be interleaved with the agenda papers. There was to be a seated restaurant on the ground floor.

The noise officer reported that the premises would be an improvement and she'd had good communication with the acoustic consultant who had taken on board all advice given.

The interested party reported that he lived 100m away from the premises. He had met with the applicant who had accepted all but 1 of his proposed conditions. He raised concerns about the 'counter area' indicated on the proposed plan which he considered could be an issue in the future.

It was noted that a variation could allow for a change in curtilage, although there was no provision for off sales and this would require a new variation application. The applicant's representative agreed that the counter area could be excluded from the plan and undertook to submit a revised plan within seven days.

The applicant's representative reported that a reduction in hours to 2am would reduce the cumulative impact and the business plan would turn an alcohol led premises into a food led business. The footprint of the licensed area would be reduced to 280sqm and there would be a reduction in capacity to 350 persons. Disabled access would be improved. Two lobbies had been installed to prevent noise escape. Noise levels had been calibrated to ensure there was no noise at the nearest residential premises. There was a new dispersal policy with a good operator. The responsible authorities had not objected and comments made by residents had been taken on board and turned into conditions.

In response to questions it was noted that music had been tested in the nearest residential premises on a Wednesday evening. Different tracks had been played and noise levels adjusted as necessary. Once the business was open this would be repeated. A phone number would be made available to residents. The noise officer advised that a limiter would be installed and certificates issued. It was advisable to check noise levels on a regular basis. The noise team would respond if there were issues.

In summary the applicant's representative stated that he considered that all issues had been resolved with residents.

#### **RESOLVED**

- 1) That the application for a new premises licence, in respect of Transport, 70-74 City Road, EC1V 2BJ, be granted to allow:
  - a) To change the plan attached to the premises licence
  - b) To reduce the hours for the provision of regulated entertainment including live music, recorded music and performance of dance: 10 to midnight, Sunday to Wednesday, 10 to 1am Thursday and 10 to 2am Friday and Saturday.
  - c) To reduce the hours for the sale of alcohol for consumption on the premises 10:00 to midnight, Sunday to Wednesday, 10:00 am to 1am Thursday and 10 am to 2am Friday to Saturday.
  - d) To reduce the hours for the provision of late night refreshment 11pm to midnight Sunday to Wednesday, 11pm to 1am Thursday and 11pm to 2am Friday and Saturday.
  - e) To reduce the opening hours of the premises from 10am to half past midnight Sunday to Wednesday, 10am to 1.30am on Thursday and 10am to 2:30 am Friday and Saturday.
  - f) Annex 2 Condition 13 to be amended (details at Annex 4 of the report).
- 2) That the conditions detailed below shall be applied to the licence.

#### **Amendments/Deletions to existing conditions**

- 1. Amended ground floor plan to exclude noise lobbies from licensed area within redline (see attached). (Basement Plan to remain as proposed in original variation application).
- 2. Delete condition 8 of Annex 2 (Notices) duplication of condition 17
- 3. Delete condition 10 of Annex 2 (under 18's to be accompanied by adults at all times) conflicts with concept of food-led community venue and is unnecessary
- 4. Delete condition 12 of Annex 2 (Technical Standards for Places of Entertainment) reflects old licensing regime.
- 5. Amend condition 13 of Annex 2 to read: "The maximum number of persons accommodated at any one time in the premises shall not exceed 350 customers with a maximum capacity for each floor as follows: Ground Floor 200. Basement 200". (i.e. as originally proposed in application)

#### Additional conditions proposed by resident and accepted by applicant

- 6. Any music or other sound played within the licensed premises should not be audible at any residential receptors in City Road, Mallow St or Featherstone Street.
- 7. The premises shall operate in accordance with a written dispersal policy which includes the following measures:
  - a. The ground floor area will be closed and patrons will be asked to leave approximately 30 minutes prior to the basement area.
  - b. Music noise levels will be reduced gradually over the final 30 minute period for each area.
  - c. All patrons leaving the venue will be encouraged to do so in a quiet manner.
  - d. At closure time the premises will be managed to ensure a gradual dispersal of customers.
- 8. From 6pm on Thursday, Friday and Saturday a senior member of management will stand outside the premises until 02.30hrs with a doorman on both exits and an extra member of security.
- 9. One staff member will be positioned at the corner of Featherstone Street and City Road and the other at the City Road entrance. Security will patrol the area around Featherstone Street and Mallow Street to ensure that customers walking near to residential premises do not create a disturbance.

#### The following additional condition:-

 That a revised plan be submitted within seven days to exclude the 'to go counter' area.

#### **REASONS FOR DECISION**

The Sub-Committee listened to all the evidence and submissions and read all the material. The Sub-Committee reached the decision having given consideration to the Licensing Act 2003, as amended, and its regulations, the current national guidance and the Council's Licensing Policy.

Four local resident objections had been received. There had been no representations made by the responsible authorities.

The Sub-Committee heard evidence that the variation application was to reduce the existing hours as the nature of the business had changed and would now be food led rather than alcohol led. Additional conditions were proposed by the resident which had been accepted by the applicant.

The Sub-Committee heard evidence from the resident who raised an issue regarding the plan and specifically an area marked 'to go counter' which he considered could be used in the future. The applicant noted the concerns raised by the resident and agreed to re-serve the plan with this area removed, within seven days.

The Sub-Committee concluded that granting the application with the additional conditions, would not adversely impact on the cumulative area or otherwise impact adversely on the promotion of the licensing objectives.

When making their decision the Sub-Committee also considered licensing policy 9 and 10 regarding standards of management, licensing policy 18 in relation to noise and licensing policy 21 in relation to dispersal.

- 3.2 This application has received seven representations from local residents and one representation from the Police Licensing Team. The Police representations has now been withdrawn subject to additional conditions being agreed.

#### 4. Planning Implications

4.1 The application is for a premises licence to serve alcohol at a crepe restaurant. Planning permission was granted for such as use on 31 January 2017, under ref. P2016.4812.FUL, and the hours stated on the application form conform to those under the relevant planning condition. As such, the planning department has no objections.



LICENSING - CREPEAFFAIRE, ISLINGTON

Further to our recent correspondence we can confirm that Daniel Spinath (Founder and Managing Director) will be appearing on behalf of Crepeaffaire at the hearing currently listed for 1 August 2017 at 18:30.

We are in receipt of the representations which have been received from Interested Parties to the application and our client notes the concerns raised of the local residents.

During the consultation period we were able to reach an agreement with Islington Police Licensing Officer (PC Steven Harrington). As the Interested Parties will not be aware of the agreed conditions, we should be grateful if this letter together with the enclosed conditions could be circulated to the Licensing Committee and Interested Parties ahead of the hearing.

We hope that the conditions agreed with the Police will allay the majority of the concerns raised and in particular we would highlight the following:

# 1. Off Licence

Save for sales to customers seating in the small external seating area at the premises sales of alcohol can only be supplied as off sales if **ancillary to a take-away meal and must be in sealed containers.** There is a very small external seating area and save for utilisation of this area the requirement for off-sales is purely to allow operational flexibility in the event that a customer may wish to purchase alcohol with their take-away meal. We stress that off-sales do not form part of the cafe offering.

### 2. Vertical Drinking

This will not be allowed at the premises save for a maximum of 8 persons waiting to be seated for a meal. We would also highlight the fact as is shown on the plan submitted in support of the application the majority of the premises are fully laid out with tables and chairs.

# 3. CIZ

Turning to the issue of the CIZ the terminal hour applied for is 8 pm, therefore these premises will not be operating late at night. We note from the Council's policy that there is concern over the proliferation of late night venues and retailers and the cumulative impact this is having on the promotion of the licensing objectives. The applicant is confident that the conditions included within the application, together with those agreed with the Police and the reduced terminal hour will ensure that there is no addition to the cumulative impact of late night premises operating in the area.

### 4. Table Meals

All sales of alcohol are restricted to customers taking a table meal. There is genuinely no intention for the premises to turn into a bar and the agreed conditions and a very limited alcohol range reflect the style of the Crepeaffaire operation.

Dear Sir/Madam,

I wish to object to this application for an new premises licence for the following reasons:

- 1. In Licensing Policy 2 this special policy will create a rebuttable presumption that applications or new premises licenses that are likely to add to the existing cumulative impact will normally be refused. The applicant has not demonstrated why the operation of the premises involved will not add to the cumulative impact.
- 2. The applicant is applying for a license to sell alcohol from 8.00 a.m. to 20.00 p.m. Monday to Sunday on and off the premises. No other establishment in Camden Passage has such a license where one can buy and drink all day long.
- 3. There is no reference to selling alcohol on the premises with food only so this could become an off license selling cheap high strength alcohol.
- 4. Vertical drinking would be encouraged on the premises and off in Camden Passage which is a narrow pedestrianised street with stalls on market days. There are benches outside the premises ( not sure if the applicant has a license for this) which can be used for drinking alcohol.
- 5. Selling crepes is not a substantial food so alcohol would be easily absorbed.
- 6. Pistachio & Pickle in Camden Passage can only sell alcohol with food or off sale with cheese platters.
- 7. Appestat has its application for a premises license refused and Coffee Works withdrew theirs.
- 8. Islington has double the national average of licenses premises per resident and this means a huge burden is placed on our local police, the disproportionate costs of which are borne by the residents and non-licensed business. I would guess that the greater percentage of those patronising the licensed premises in the Angel are not Islington rate payers or residents. They therefore bear no element of the cost, nor suffer the noise, vandalism and ASB. There has to be a compelling reason to grant a new license, the burden of proof showing that such a license will not add to the cumulative impact has to be with the applicant. I do not consider that this applicant has done this.

I understand you have received an application from Crepeaffaire to sell alcohol 'on' and 'off' the premises every day between 08:00 and 20:00.

I live in Charlton Place, which leads directly off Camden Passage. I objected to the very recent retrospective planning application on the basis that these premises would fall outside the Council's policy of 2 non-food units for every food unit. The application leant heavily on the basis that it was a cafe serving crepes and coffee, but permission was granted. We are now having to face up to a fully licensed premises, with sales 'on' and 'off' the premises, if this is permitted. Alcohol is already served in many of the premises in Camden Passage, and Crepeaffaire is very large, comprising three units linked together. The concentration of sale of alcohol would be excessive, if granted permission. In any event, if permission is granted, it should be limited to 'on sales' only, in order to protect the local residents.

I object to this application.

Crepe Affair is situated on the corner of a narrow pedestrian section of Camden Passage and Camden Walk . It is opposite the flats forming part of the Colinsdale estate. Camden Passage itself is mostly residential above ground level.

The property has benches outside in Camden Passage and tables outside in Camden Walk. I have not been able to find out if they have a street licence for these.

The property is with the Angel cumulative impact and saturation area. The section of this area between the Camden Head and The York there are 11 licenced premises inclusive of the two pubs and there is Tesco with a full off licence at the north end of the passage.

The reasons for my objection are as follows:

- 1- The applicant has taken no account of Islington's Licensing Policy in the application and has applied for a full on and off licence. There is nothing to show how such a licence will not add to the cumulative impact and there has been no attempt to do this. This is not a good attitude.
- 2-The licence if granted will allow vertical drinking, drinking without food and will allow the drinkers to occupy the outside tables where they will both drink and smoke.
- 3-It is likely that drinkers will spill out onto the street on fine days blocking Camden Passage, where there are often stalls, and increasing noise levels.
- 4-The application makes no reference to table service and therefore the presumption is that the coffee counter will also serve as a bar adding to the noise and potential increase in noise and consumption,
- 5-There is no limit on the number of customers,
- 6 There is no limit on the alcohol to be sold so they could have "happy hours" or unlimited prosecco with breakfast/brunch
- 7-The full off licence requested means that strong cheap alcohol could be sold for takeaway. This is particularly relevant given the questionable planning status which is A1 but with sui generis consent for a creperie,
- 8-Given the planning history they could, having got the licence, sell the premises as a full off licence.
- 9- The owners did not fully investigate the planning when they acquired the premise or research Islington's preferred policy for the shops in Camden Passage and had to apply for a late consent. In that application the applicant made much of the fact that they did not have a kitchen and merely brought in ready prepared crepes and reheated them. They cannot therefore be said to be serving substantial meals and indeed do not have the planning consent so to do. Any food consumed will therefore be ancillary to the alcohol.

In short they are applying for a licence to cover all options they want a full bar and off licence serving from breakfast for 12 hours every day. This will only serve to increase the noise and ASB in the area

and enable punters buy drink for consumption before going onto other venues. The cost of this is tremendous both in financial and health terms and it distracts the police from carrying out other duties.

The application should be refused

The prospect of another alcohol outlet is so dispiriting. Camden Passage is drowning in a sea of alcohol while traditional shops and established antique dealers are going to the wall.

The **Saturation Zone Policy** has lost all meaning.

### Rep 5

I write with regard to Crêpe Affair's licence application to sell alcohol on and off the premises 8am-8pm.

**Public Nuisance** 

The premises are in a residential area where there is currently a licensed public house fulfilling the remit of selling alcohol – and there is also a substantial off licence service at the nearby Tesco store. The noise from the adjacent public house as a result of drinkers is already a nuisance and to add to this noise intrusion by licensing another premises in close proximity is a serious nuisance to residents and their right to quiet enjoyment of their homes.

Crime and Disorder

The area of Camden Passage has seen a rise in anti-social behaviour, drug selling and general crime, including some violent crime, in recent years. It is also a popular area for buskers and beggars and licensing a premises for on and off sales is likely to full more anti-social behaviour and noise to residents who live directly above Crepe Affair or opposite the premises.

Protection of children from harm

The premises is currently used by a mixed clientele, including infants and children – and schoolchildren also frequent the area of Camden Passage on their way home from school. Whereas the area of the adjacent pub is clearly defined, Crepe Affair promotes itself as a healthy eating establishment, which is currently family friendly. Licensing the premises sends a mixed message about alcohol use – and there is no reason why any sandwich bar or fast food catering outlet should

be licensed from 8am. There is a risk that licensing such a premises – which started off as a sandwich bar and has gradually pushed the boundaries of its operation – might act as a gateway to alcohol use for minors using Camden Passage and mollify the risks of alcohol, given the current healthy eating promotion of the premises; as well as encouraging others to purchase alcohol throughout the day, adding to the risk of anti-social behaviour, noise and littering.

# Public safety

In my opinion, there are currently issues with the operation of this premises, given that it shares common parts with other commercial as well as residential tenants. Since the business opened, the common parts of the building have deteriorated and are not kept clean, including floors which remain not cleaned at the end of each trading day. The staff do not appear to think that any mess from the premises on the common parts is their responsibility to clear away, including liquid spills on the fire escapes. Food and spilled drinks are being left for days at a time on floors of the common areas (including a trail of coffee grains leading from the premises to the fire door over which other tenants had to pass and which was left for more than a week). Filthy boot marks are left on floors in the common parts around the premises and leading to and from the premises.

Fresh food is stored in a basement plant room where sewage pipes run and large quantities of paper hand towels and lavatory rolls are now being stored in the electricity room where the electricity supplies and meters are, which appears to be an obvious fire hazard which I have reported to the managing agent.

The exterior of the premises is frequently left dirty, with tables left not cleared, food left out (even in the heat) on tables when customers leave and bird excrement on benches which the public and staff use outside the premises. This has led to increased pigeon activity on the flat roof and gutters of the block, including round residential properties above the premises. I witnessed a member of staff leave the premises to taker a break who sat on a bench which had pigeon droppings on it and was also surrounded by the detritus and food left by customers on the tables, but still took a break rather than clear the tables or wipe the benches first. Staff should not be sitting on benches covered in bird excrement and then returning to work in the premises, apparently oblivious to the health risks.

After the premises' last licensing application I received a letter from Islington Council, which states the council is not concerned that the premises is using the fire escapes as part of its operation — which includes storing cardboard boxes and bags of refuse on or next to the fire escapes and adjacent to the basement electricity room (now half-full of paper towels and lavatory rolls), as well as bags of flour, fresh produce, soft drinks and furniture on the fire escapes.

I attach images of the fire escapes with these items on them – including the electricity room.

If the staff of Crêpe Affair are currently unable to keep the premises in a safe and clean condition, I suggest that the addition of alcohol to the licence is only going to exacerbate the issues – there is limited storage on the premises and the fact that lavatory rolls and hand towels are now being stored in the electricity room and refuse is blocking fire escapes demonstrates this.

Fire doors are also left open by commercial staff – and one fire door in the basement is wedged open with a piece of card. The landlord has also locked fire doors on the upper floor of the block where the residential property is sited, so that emergency services cannot enter the upper fire terrace directly, only through residents' bedrooms, which may not be accessible from the main

residential hallway in the event of a fire. I have asked for a key to one of the doors leading to the upper fire terrace so that I can grant access to emergency services, but have yet to receive this.

I would also add that some years ago, Barclays Bank in the block was allowed by the landlord to clad its façade and I have asked the current managing agents to investigate the materials used for the cladding, in light of the Grenfell Tower fire and await an answer.

However, the presence of stores of alcohol on the premises further adds to fire hazards in this building, as well as potentially adding to the poor state of cleaning and lack of storage. This is a risk not only to residential tenants of the building, but also to the public who use this building to visit commercial premises such as the bank and retail premises – especially as the area outside Barclays Bank where the façade has been clad is now used by smokers 27/4, including the bank's staff and customers.

There are also other premises in very close proximity to the block and any fire would potentially spread very quickly.

There are also frequent faults on the fire alarm inside this building – last year, the alarm's error alarm started to bleep over the Easter holiday and was left bleeping for more than a month, even though I reported the alarm error to the managing agent when it occurred. However, there is no on site manager, housekeeper or concierge – and much of the reporting falls to me, as most of the properties are now rented rather than owner-occupied and the population of the building tends to be transient to an extent. When the fire alarms do ring, it is not unusual for residential tenants – especially those who are new to the building – to be unaware of fire safety procedures and the need to evacuate the building and await the fire brigade.

In my opinion, the situation appears already potentially dangerous without adding alcohol supplies on the premises to the mix – and where these might be stored, I have no idea given the limited space available.

I do not wish to feel I have further responsibility for monitoring what goes on in this building to ensure that I and my neighbours remain safe – and it seems clear that staff at Crêpe Affair are not addressing even the basics of hygiene and health and safety regarding the common parts of the building.

For the reasons given above, I oppose the licence application.

Please withhold my name and address, as previous attempts I have made to speak to staff about some of the issues – including fruit flies on the common parts where fresh food is stored – have been met with negativity.

## Rep 6

I write to object to this application for a new Premise Licence on behalf of the Angel Association.

The application is for a licence to sell alcohol both on and off the premises, a crepe "restaurant" covering three units of Camden Passage, between the hours of 8am and 8pm, 7 days a week. The premises is in the Angel and Upper Street Cumulative Impact area, which the Council believes has reached saturation levels, and in which any further expansion should not adversely affect the quality of life for residents. The application contains very little detail, and does not, in our view, go any way


to demonstrate why the operation of the premises would not add to the cumulative impact or otherwise adversely impact the promotion of the licencing objectives, which it surely must do.

The Camden Passage highway is narrow and already narrowed further by the use of tables outside various premises (including this one). The premises is in a residential area and actually opposite a block of flats. It is simply an inappropriate location and premises for a 12 hour, 7 day a week, licence – which hours seem totally unnecessary for what is effectively a coffee shop selling crepes, waffles, ice cream and breakfast. Its proximity to the Camden Head could result in a filling up of that end of Camden Passage with vertical drinkers, blocking the highway and having a detrimental impact on residents' quality of life.

There is no detail provided about the alcohol off sales, no restrictions in that regard, no provision that alcohol will only be served as ancillary to food and no prohibition on vertical drinking or details of how it might be managed. No serious attempt has been made to take account of the type of premises, it's location, or the Council's licencing policy.

In my letter to Islington Council's Planning Department dated 12/01/17 (copy of letter attached), I had no objection to Crepeaffaire's retrospective Application for change of use from retail to restaurant but expressed reservations about the increase in food and drink outlets in Camden Passage and stated that I would object to any further Application for an alcohol License.

I therefore wish to register an objection to the present Application on the grounds that Camden Passage is already saturated with food and drink outlets with accompanying Alcohol Licenses and that the granting of a License to Crepeaffaire would have an appreciable cumulative impact on the area, to the detriment of the existing small specialist shops and local residents such as myself.

We already have a cheese shop with an Alcohol Licence (Pistachio and Pickle), and a grocery shop with an Alcohol License, (Le CoqEpicier), We also had a hairdessers with an alcohol License (The Blow Bar), since defunct. And now we have the prospect of a pancake shop with an Alcohol License.

These outlets are, of course, in addition to the other Licensed Premises - The York and Camden Head pubs, the bar/restaurant The Elk In The Woods, The Breakfast Club, Fredericks, Chipotle, Kipferl, the Japanese cafe Katsute. All these premises are crammed into a very small area.

There is, however, a precedent for the refusal of a License in the form of Appestat, and it is hoped that the Licensing Committee will follow this example.

The reason for the constant stream of requests for Alcohol Licenses is not hard to understand; it is economic. As if by magic, a £5 bottle of wine in a supermarket becomes a £15 bottle of house wine. A minimum of work involved - just store and pour. And the goose which lays this golden egg is the Licensing Committee.

It would not be appropriate for the Greperie to have the colpletely unrestricted On and Off License, which, it appears, to have been applied for.

There is a further point that the Crepeaffaire is on the corner facing the Camden Head pub whose outside area is usually crammed with noisy drinkers. Any further impacr from drinkers in this narrow area is undesirable.

For the reasons outlined above I consider that the Application should be refused, allowing the Creperie to continue doing what it already does very well -ie the serving of food and drink without alcohol.

# **Conditions proposed by the Metropolitan Police**

- 3. CCTV shall be installed, operated and maintained, at all times that the premises is open for licensable activities, so as to comply with the following criteria:
- 4. The licensee will ensure that the system is checked every two weeks to ensure that the system is working properly and that the date and time are correct. A record of these checks, showing the date and name of the person checking, shall be kept and made available to Police or authorised Council officers on request; One camera will show a close-up of the entrance to the premises, to capture a clear, full length image of anyone entering; The system will provide full coverage of the interior of the premises and any exterior part of the premises accessible to the public; the system shall record in real time and recordings will be date and time stamped; recordings will be kept for a minimum of 31 days and downloaded footage will be provided free of charge to Police or authorised Council officers on request (subject to the Data Protection Act 1998) within 24 hours of any request; and at all times, there will be a person on the premises who can operate the system sufficiently to allow Police or authorised Council officers to view footage on request and to supply a copy of footage immediately to Police to assist with the immediate investigation of an offence.
- 5. Documented staff training will be given regarding the retail sale of alcohol and the prevention of underage sales.
- 6. The premises will operate a Challenge 25 scheme and the only acceptable proof of age identification shall be a current Passport, photo-card Driving Licence or identification carrying a PASS logo.
- 7. Sales of alcohol for consumption off the premises shall only be supplied with, and ancillary to a takeaway meal. Save for customers using the external seating area all off sales shall be in sealed containers only.
- 8. There shall be no vertical drinking in the venue save for a maximum of 8 persons waiting to be seated for a full table meal.
- 9. The supply of alcohol at the premises shall be to a person seated and taking a table meal there and for consumption by such a person as ancillary to their meal.

- 3.2 The Licensing Sub Committee granted a licence to a former operator on 6 November 2012 to allow Late Night Refreshment until 23:30, Mondays to Sundays. This licence was subsequently surrendered on 16 December 2013; the then licence holder stated that they had never used the licence.
- 3.3 The current applicant has stated that they have operated to the same times as proposed in the application within the area of Westminster City Council for 7 years. The Licensing Service have contacted Westminster City Council who have confirmed that they have no record of a licence for the premises identified by the applicant.
- 3.4 The provision of Late Night Refreshment is defined within Schedule 2 of the Licensing Act 2003 and the definition includes the supply of hot food or hot drink to members of the public, whether for consumption on or off the premises, between the hours of 11pm and 5:00am.
- 3.5 Representations have been received to this application from the Metropolitan Police, three local residents and a local property management company representing 8 local properties. The Licensing Authority has also made representation.
- 3.6 The applicant has submitted a response to the representations.
- 3.7 Licensing Officers monitored activity at the premises on 7 July 2017 and found that the premises being used for the provision of late night refreshment. The operator was sent a warning letter on 10 July 2017.

# 4. Planning Implications

3.1 Planning have reported:

"The application is for a premises licence to extend the hours of operation at a Chinese takeaway, which is operating under an A5 use class. Historical records confirm that a Chinese takeaway has existed at the premise for a number of years and, on the balance of probability, it is now a lawful use. There are no enforcement investigations concerning the land. As such, the planning department has no objections to the application."

# 5 Recommendations

- 5.1 To determine the application for a new premises licence under Section 17 of the Licensing Act 2003.
- These premises are located in the Clerkenwell Cumulative Impact Area therefore the Licensing Committee will need to consider Licensing Policy 2, which states that there is a presumption of refusal unless the Committee is satisfied that there will be no adverse cumulative impact on the licensing objectives.
- 5.3 If the Committee grants the application it should be subject to:
  - i. conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (see appendix 5)
  - ii. any conditions deemed appropriate by the Committee to promote the four licensing objectives.

# 6 Conclusion and reasons for recommendations

6.1 The Council is required to consider this application in the light of all relevant information, and if approval is given, it may attach such conditions as appropriate to promote the licensing objectives.

#### General

I have seven years experience running this model of operation to the times applied for in the City of Westminster, with no issues or complaints. Similarly, I have been operating a delivery service from this premises since I took over in July last year until 01:00 on weekdays and until 02:00 at the weekends. I understand that there have been no issues or complaints. These are also the times the previous owners operated the premises until.

# The prevention of crime and disorder

- CCTV shall be installed, operated and maintained in agreement with the Police. 1. Maintained means that the system will be regularly serviced (at least once a year) and checked every two weeks to ensure that it is storing images correctly and a log kept and signed by a Supervisor to this effect. The system will provide an identifiable full head and shoulder image of everyone entering the premises and will operate in any light conditions within the premises. The system will cover the full exterior of the premises and shall record in real time, date and time stamped and will operate whilst the premises is open for licensable activities. The recordings will be kept for a minimum of 31 days and copies will be made available to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24hrs of any request free of charge. I am submitting a representation on behalf of the Licensing Authority in respect of this new application for a Premises Licence to permit late night refreshment on the premises

Monday to Saturdays from 23:00 to 03:00

Sundays from 23:00 to 00:00

The application contains an anomaly over the proposed hours and it is unclear what the applicant's attentions are. In the description of the premises the applicant has stated it is their intention to close at 23:00 hours but would like to deliver food until 03:00; however, in the proposed conditions attached to the application (number 8), the applicant has stated that the premises would be closed to the public from midnight Monday to Friday and 01:00 on Saturday and Sunday.

The application raises concern about compliance with the Licensing Act 2003. The applicant has stated that they ran a premises in Westminster for the same hours as currently being sought for 7 years. The Licensing Service has contacted Westminster Council who have reported that no licence was ever granted for the premises referred to. Furthermore, the applicant has reported that they have been operating the current premises to 02:00 without a licence since July 2016. The applicant states that they have relied on information provided by their solicitor but has evidently made no attempt to obtain a copy of the "licence", which the solicitor referred to. This admission raises concerns about the ability of the applicant to comply with the licence requirements.

The applicant has stated that they have operated from this premises with no issues or complaints. However, Council records show that the applicant has been issued with 4 Fixed Penalty Notices in respect of litter offences relating to these premises since November 2016; these remain unpaid.

The premises has previously been licensed. The Licensing Sub Committee granted a licence on 6 November 2012 to allow Late Night Refreshment until 23:30, Mondays to Sundays. This licence was subsequently surrendered on 16 December 2013; the then licence holder stated that they had never used the licence.

Whilst it is appreciated that the current application does not include the sale of alcohol, the premises is in a part of the borough which is relatively quiet late at night despite being located between the borough's two busiest late night areas at the Angel and in Clerkenwell. Whether the premises is open to customer or not, the arrival and dispatch of delivery drivers will inevitably lead to an increase in noise levels in the early hours of the morning.

The following Policies, determined by the Licensing Authority as being appropriate to promote the licensing objectives, are relevant to this application:

## Licensing Policies 1, 2, 8, 9, 10, 18

- The premises is located in the Clerkenwell Cumulative Impact policy area;
- The premises is located in an area where there are no other late night operating premises in the immediate vicinity;
- The premises is located very close to residential dwellings;
- The proposed hours are outside the favourable hours for take-away premises (midnight Sunday to Thursday and 01:00 Friday to Saturday);
- The applicant has demonstrated a lack of understanding of the legal requirements and has admitted to a history of non-compliance in respect of the Licensing Act 2003;
- There is evidence of non-compliance with other statutory requirements and poor

# management in respect of litter management.

In view of these concerns the Licensing Authority is making a representation against the grant of this application. It is recommended that the application be refused as the Licensing Service has concerns about the ability of this operator to comply with the legal requirements and operate to the required standards.

With reference to the above application, I am writing to inform you that the Metropolitan Police, as a Responsible Authority, will be objecting to this application as it is our belief that if granted the application would undermine the Licensing Objectives, Prevention Of Crime and Disorder and Prevention of public nuisance

The venue is situated in the 'Clerkenwell Cumulative impact area' (CIA), an area which traditionally suffers from high levels of crime and disorder and there are concerns that the addition of a further Licensed venue will add to this impact causing further policing problems in an already demanding area.

I am aware that this venue has been operating without a License for the last year. The applicant Mr Zekair Herar only made this application after contacting the Council Licensing Team to ask about making a license variation. It was then discovered that the previous venue License had been surrendered in December 2013.

Mr Herar stated that when buying the premises he had been told by his solicitor that the venue was licensed until 3am. I appreciate that Mr Herar was paying for best advice from his solicitor but I am astonished that he has never taken the time to read a copy of the license, if there was one, and if he did not have a copy then why has he not contacted the Council to ask for a duplicate. I have grave concerns about his ability to manage the venue correctly and within any conditions on the license.

I emailed Mr Herar asking for some information regarding the application. I received a very short reply so I further emailed asking for further information and details of Mr Herar's previous experience within the licensing trade. I have not had a reply at this time.

I have been made aware that Mr Herar did operate a venue in Westminster for a number of years but it seems that Westminster Licensing have not heard of this venue?

I submit that the Committee refuse the application.

I am writing on behalf of the eight owners and occupiers of the flats comprising in connection with the above application under the Licensing Act 2003. I am the Company Secretary of Pilotgrange Property Management Company Limited, which is the company co-owned by the eight flat-owners and acts on behalf of the common interests of the residents.

Together we constitute the properties which are closest and therefore most immediately affected by this application recently submitted by Yum Yum restaurant and take-away, and are concerned about the impact on order, noise and safety that may result from approving the application.

The presence of Yum Yum has already led to a considerable increase in the level of noise in the street as a result of the activities of both the direct customers of Yum Yum and the delivery scooters/motorbikes whose drivers park and gather outside both Yum Yum itself and further up the road outside Nos. including smoking and chatting on the doorsteps of our premises. This has resulted in higher levels of noise in the early hours of the morning, so the nights are already much noisier, particularly on the occasions when there are arguments outside which then provoke further noise, dogs barking, and so forth, and can sometimes become quite disturbing for us as the nearest residents.

We recognise that local and passing communities have an interest in encouraging local food and other businesses and have therefore not wished to make an issue of this in the past, but we believe that this application goes beyond what is in the common public interest. The extension of hours which has been proposed, including deliveries until 3am in the morning, will inevitably lead to considerably more nuisance and disturbance for a large part of the night, regardless of whether this relates to retail to customers or goods delivery.

Furthermore, we believe that an application for an alcohol licence is inappropriate and unnecessary: inappropriate because of the association between late-night drinking and public disturbance, and unnecessary since it is possible already to buy alcohol from shops within the area, some of which are open very late or even all night.

We therefore oppose granting this licensing application because it will increase the level of noise and other forms of public nuisance well into the early hours of the morning and – especially given the involvement of alcohol – has the potential to lead to crime and other disorders.

I trust that you will take into account the objections raised by the flat-owners of the eight properties which are nearest and therefore most affected, and reject this application. Thank you for considering our views.

#### Visit with NF 7 July 2017

Initially we drove past premises at 23:36 and observed lights on and 3 people behind the serving counter. Two motor cycles were parked immediately outside on the pavement and two males, who appeared to be delivery drivers, were standing immediately outside. I took a photograph as we drove past; NF was driving. We parked on St John Street and monitored activity at the premises standing on the opposite side of the road. I observed one of the riders was smoking. At 23:59 a third motor cycle arrived, pulling up outside. The rider entered the shop, collected an order, returned to his motor cycle and drove away. One of the remaining two riders then left with an order, which he collected from inside, on his motor cycle at 00:03. A further motor cyclist arrived, parked on the pavement opposite, entered shop, collected an order and then left. We continued to monitor, patrolling the pavement on the opposite side of the road and observed at least 5 different motor cyclist arriving, collecting and leaving with orders. We walked past the entrance, where the door was open and the sounds of cooking could be heard and the smell of Chinese style food cooking was clearly evident. A member of staff was seen preparing food in delivery packages. We returned to our vehicle and then drove past the premises again at 00:11. No shutters down, lights still on, and staff still visible behind the counter. There were at least two delivery drivers visible, now standing inside the premises. The were 3 motor cycles parked on the pavement outside and a further motor cycle parked on the pavement opposite.

## Suggested conditions of approval consistent with the operating schedule

- 1. CCTV shall be installed, operated and maintained in agreement with the Police. Maintained means that the system will be regularly serviced (at least once a year) and checked every two weeks to ensure that it is storing images correctly and a log kept and signed by a Supervisor to this effect. The system will provide an identifiable full head and shoulder image of everyone entering the premises and will operate in any light conditions within the premises. The system will cover the full exterior of the premises and shall record in real time, date and time stamped and will operate whilst the premises is open for licensable activities. The recordings will be kept for a minimum of 31 days and copies will be made available to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24hrs of any request free of charge. There will always be a member of staff on duty who can operate the system, to allow Officers to view recordings and if required by a Police Officer, provide a copy of images immediately free of charge to assist in the immediate investigation of offences. If the system malfunctions and will not be operating for longer than one day of business, then Police must be informed.
- 2. The premises licence holder will work closely with the Police and the Licensing Authority.
- 3. All instances of crime and disorder shall be reported to the police.
- 4. An incident book shall be used to record all instances of public disorder.
- 5. All exit routes shall be kept unobstructed, with non-slippery and even surfaces, free of trip hazards and clearly identified.
- 6. Staff at the premises shall ensure that the immediate area outside the premises is kept clear of rubbish at all times the premises are open and operating.
- 7. Prominent, clear and legible notices must be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and the area quietly.

## Licensing Authority Representation - Licensing Act 2003

## Application: Borough Wines, 344-346 Essex Road

I am submitting a representation on behalf of the Licensing Authority with respect to the application for the variation of the premises licence in respect of the above premises to extend the operation of the premises into the basement.

## The grounds for the representation are:

The prevention of public nuisance

### **Licensing Policy Considerations:**

#### Issues of Concerns:

This premises has been licensed since December 2015 when a licence was granted by a members of the Licensing Sub Committee. The licence was granted for on and off sales of alcohol at the premises from 09:00 until 23:00 for the ground floor only.

This application seeks to licence the basement for on and off sales of alcohol from 10:00 until 23:00 Monday to Saturday and from 11:00 until 22:00 on Sunday. The application also seeks to licence the basement for recorded music from 16:00 until 23:00 Monday to Friday, from 10:00 until 23:00 on Saturdays and from 11:00 until 22:00 on Sundays.

The Licensing Authority does not object to this application in principle, however, the Licensing Authority has concerns over the granting of this licence without specific conditions for the basement which safeguard residential amenity from the basement becoming a club.

The inclusion of the basement at this premises increases the potential for more customers to be on the premises at any one time. An increase in customers may have an impact on neighbours when the premises closes. From discussions with the applicant, the Licensing Authority understand that for the vast majority of the time, if the basement is open for an event, the ground floor shop will be closed.

#### Summary and recommendations

If the Committee is minded to grant the application the Licensing Authority recommends the following conditions;

- 1. The premises shall not operate as a bar.
- Consumption of alcohol on the premises shall be limited to the basement for wine tasting events. These events shall be in a very controlled environment promoting education around wine and wine knowledge with limited numbers at each event and operated on a ticketed or invite only basis. Wine shall be served in small measures only of approximately 25ml.
- 3. Customers should not be allowed to consume purchased alcohol outside the premises.
- 4. Any music played at the premises will be at a background volume.

- 5. Noise or vibration must not emanate from the premises so as to cause a nuisance to nearby properties.
- 6. Prominent, clear and legible notices must be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and the area quietly.

Imposing additional conditions proposed by the applicant, Licensing Authority and/or Members of the Licensing Committee --should safeguard the amenities of the residents and prevent the premises impacting on the nigh time economy.

### **Public Noise Nuisance:**

It sometimes gets very noisy on Essex Road and neighbouring roads late on Friday and Saturday nights, with drunk people shouting and making a lot of noise. This is a particular issue for us, as we live the the form of Englefield Road and Essex Road. If the business attracts more customers during these late hours with additional film and music offerings, this will likely worsen the current problem, particularly as customers leave the premises.

## Crime and Disorder:

Similarly, fights and scuffling occasionally break out between individuals in this area at night. Allowing the business to attract more customers and increasingly encourage them to consume alcohol on the premises, and over a longer period, may increase the frequency of these incidents.

The address of the premises is in the Angel and Upper Street Cumulative Impact Area of Islington, suggesting that the Council is already aware of the issues mentioned above.

The licence will be subject to all of the terms and conditions of the existing premises licence. The conditions are listed below;

- 1. The licensee shall adopt the Challenge 25 and the Bll National Standards Proof of Age Scheme.
