45 <u>VOLUNTARY AND COMMUNITY SECTOR PARTNERSHIP GRANTS</u> PROGRAMME 2024-2028 (UPDATE) (Item B1)

Executive Member Homes and Neighbourhood informed the meeting that the report was considered at the December meeting. The following points were highlighted:

- That out of the 51 organisations which were awarded grants, 4 organisations exceeded the total contract value of £500,000 which is deemed to be a key decision under the council's governance arrangements.

1. Synopsis

1.1. The Local Initiatives Fund (LIF) is a flexible devolved budget for councillors to use to address issues and priorities in their wards. It is an important element of the council's community provision and helps to meet the needs of local residents. In 2023/24 each ward has an allocation of £13,000 to spend on local schemes. Councillors consider project ideas for their ward and make recommendations to the Voluntary and Community Sector Committee for formal approval.

2. Recommendations

- 2.1. To consider the new proposals and changes to previous proposals submitted by ward councillors as set out in Appendix A and to agree these proposals in principle subject to the Corporate Director of Community Engagement and Wellbeing being satisfied that the necessary checks have been made and any other issues resolved.
- 2.2. To note the declarations of interest made by councillors due to having a connection with organisations that they are recommending funding for. These are detailed at paragraph 4.3.
- 2.3. To note the amendments to ward budgets resulting from project funding being returned, which are detailed in Appendix B.

- 2.4. To agree that no more than £1000 underspend per ward can be carried forward by councillors to 2024/25.
- 2.5. To continue with delegated authority to the Corporate Director Community Engagement and Wellbeing, in consultation with the Executive Member for Homes and Communities, to make changes to the use of previously awarded funding.

3. Background

- 3.1. The Local Initiatives Fund enables councillors to respond directly to priorities in their ward that lie outside of current mainstream funding programmes and might not otherwise receive funding. It helps them to address the needs of local residents and suggest improvements to local services/facilities or new schemes that will enhance the area.
- 3.2. The Community Partnerships Team in the Community Engagement and Wellbeing Directorate is responsible for managing the Local Initiatives Fund in liaison with ward councillors and members of the Voluntary and Community Sector (VCS) Committee. The team ensures that funds are used appropriately and for the purpose for which they are allocated.
- 3.3. The VCS Committee's terms of reference include 'To be responsible for the allocation of the Islington Community Fund including...allocating the Local Initiatives Fund having regard to the recommendations of the relevant ward members/relevant ward partnership or neighbourhood group and on the basis that the funding will be allocated equally among the 16 wards making up the council's area'.
- 3.4. The VCS Committee in April 2011 agreed that each ward councillor should be given a notional allocation of the Local Initiatives Fund (i.e. divided equally between the councillors elected for each ward). In 2016/17, £15,000 was available to each ward; therefore the notional allocation for each councillor was £5,000.
- 3.5. In January 2017, the Voluntary and Community Sector Committee agreed that in order to address the issue of recruiting and retaining support for ward partnerships, an incentive payment of £1,000 per annum would be paid to each ward partnership co-ordinator and that £1,000 per annum be set aside from each ward partnership Local Initiatives Fund budget to fund this support.
- 3.6. In 2021/22, the annual Local Initiatives Fund budget was therefore £225,000. This was £14,000 per ward apart from the Bunhill and Clerkenwell ward budgets which were each £14,500.
- 3.7. In March 2022, it was agreed that two new ward partnership co-ordinator posts needed to be created. An additional ward partnership co-ordinator was recruited to the Finsbury ward partnership due to the additional workload involved in dealing with two wards. In May 2022, the number of wards in Islington increased from 16 to 17 which meant that a further ward partnership co-ordinator was recruited.
- 3.8. Due to the increased amount spent on honorariums/ incentive payments to cordinators and the larger number of wards, the amount of funding available in each Page 4

- ward budget in 2023/24 for local schemes is £13,000. This means there is a reduction of the overall LIF budget from £240,000 to £238,000. Of this £238,000, £17,000 is spent on honorariums with £221,000 left to allocate to local schemes.
- 3.9. In November 2019, authority was delegated to the Head of Community Partnerships, to allocate funding, up to the value of £250, to activity to support Ward Partnership meetings. Awards approved under delegated authority should be reported to the next VCS Committee at which Local Initiatives Fund awards are considered. In September 2021, it was agreed that funding up to the value of £1,000 can be approved by the Head of Community Partnerships and Corporate Director Community Engagement and Wellbeing for activity to support Ward Partnership meetings.

4. LIF Awards 2023/24

4.1. Occasionally projects do not proceed as planned and funding is returned to ward budgets or the use of a grant has to be changed.

7 reallocations totalling £3403.44 have been added back into ward budgets and these are set out in Appendix B.

- 4.2. Since the last VCS Committee in November 2023, 54 applications for the Local Initiatives Fund have been received.
- 4.3. 3 of the 54 LIF applications were related to Ward Partnership activity, were recommended for funding and then formally agreed by the Head of Community Partnerships/ Corporate Director of Community Engagement and Wellbeing under delegated authority. These four applications totalling £888 are listed in Appendix A for information only.

Of the remaining 51 LIF applications, 1 was deferred until the next round, 10 applications were not recommended for funding, 2 applications were referred to Section 106/ Community Infrastructure Levy funding instead and 1 application was referred to Thriving Neighbourhoods funding, leaving a total of 37 applications recommended by ward councillors.

If the remaining 37 councillor funding recommendations are formally agreed by this VCS Committee, there will be £7004 left in the 2023/24 budget to be carried over to 24/25.

A list of the 37 LIF applications recommended for funding and the recommended amount for each application is set out in Appendix A.

- 4.4. Councillors must always declare their interest if they have a connection with an organisation that they are recommending funding for. Declarations of interest have been made for the following applications reported to this Committee:
 - Cllr Ruth Hayes is a Trustee of Bridging the Gap that has been allocated £950 for mentoring.
 - Cllr Satnam Gill, Cllr Tricia Clarke and Cllr Gulcin Ozdemir are all co-opted trustees of Hilldrop Area Community Association that has been allocated £500 on behalf of St. George's Avenue Street Party.

Awards were made to the following ward partnerships for costs associated with holding ward partnership meetings or events:

- Arsenal Ward
- Junction Ward
- Tollington Ward

The councillors funding these costs are members of these ward partnerships and the main organisers of the meetings/ events so have declared an interest in the above.

5. Implications

5.1. Financial Implications

The Local Initiatives Fund in Financial Year 2023/24 has a total of £241,189 to allocate. This is comprised of an annual budget of £221,000 and a carried forward underspend/unallocated amount of £20,189 from previous awards or financial years. An additional £17,000 LIF budget is spent on honorarium/ incentive payments to ward partnership co-ordinators to a total of £1,000 per annum per ward. The core budget available for LIF will be £238,000.

Any recommendations for carry forwards of LIF underspends will be subject to yearly reviews of the wider financial needs of the Council. The current earmarked reserves as a consequence of previous financial year's carry forwards and previous awards are sufficient to meet the funding requirements of this report.

The proposals referred to in this report can be met from budget and reserve allocations from the Local Initiatives Fund. Delays or alterations to LIF projects may increase ward underspends in Financial Year 2024/25.

Financial Year 2024/25 will start with a comprised annual budget of £221,000 and any additional carried forward underspend/unallocated. An additional £17,000 LIF budget will be spent on honorarium/ incentive payments to ward partnership coordinators to a total of £1,000 per annum per ward. There is a 2023-24 budget of £7,004 across LIF which will be carried forward into 2024/25, with £6,587 allocated

against wards and £417 unallocated. The core budget available for LIF will be £238,000 and a carried forward amount of £7,004.

5.2. Legal Implications

The general power of competence pursuant to Section 1 of the Localism Act 2011 provides the council with very broad powers 'to do anything that individuals generally may do'. This covers the power to give grants to voluntary and community sector organisations as proposed in this report and includes anything which it considers is likely to achieve the promotion or improvement of the economic, social or environmental well-being of the whole or part of its area or all or any of the persons resident or present in that area. The provision of resources through the Local Initiatives Fund is likely to promote the social and economic well-being of Islington's residents.

The council is under a fiduciary duty to ensure that its resources are used appropriately. Where the money is allocated to outside bodies, the requirements of the procurement rules may apply. In any event it will be important to maintain current practice of ensuring that the money will be used for the purposes for which it is allocated and that individual members are made aware of the responsibility they bear in making recommendations in relation to specific groups.

5.3. Environmental Implications and contribution to achieving a net zero carbon Islington by 2030

Most if not all, of the projects funded by the LIF grants have carbon and environmental impacts, including the use of energy, fuel, water, food and drink, materials, prizes, generators and printing, while events being funded may create waste or journeys that contribute to transport-related emissions especially if attendees drive. However, many projects also have positive environmental impacts, including repairing items including planting, greening areas, local food growing and increasing local biodiversity. Wherever possible, projects will be undertaken with regard with the council's goal of achieving a net zero Islington by 2030, as per Islington Council's Environmental Policy.

5.4. Equalities Impact Assessment

The council must, in the exercise of its functions, have due regard to the need to eliminate discrimination, harassment and victimisation, and to advance equality of opportunity, and foster good relations, between those who share a relevant protected characteristic and those who do not share it (section 149 Equality Act 2010). The council has a duty to have due regard to the need to remove or minimise disadvantages, take steps to meet needs, in particular steps to take account of disabled persons' disabilities, and encourage people to participate in public life. The council must have due regard to the need to tackle prejudice and promote understanding.

When considering proposals the VCS Committee will take relevant equalities implications into account. The Local Initiatives Fund provides resources for local projects which directly meet the needs of local residents, many of whom are from groups with protected characteristics. It enables some of Islington's poorest communities to access community-based services and activities and allows provision to be developed locally which can reach groups of residents that may not otherwise be supported.

6. Conclusion and reasons for recommendations

The Local Initiatives Fund is an effective way of addressing local priorities and provides a mechanism for ward councillors to support small projects which might otherwise not be funded. Proposals submitted for approval represent a wide range of activity and will deliver significant benefit to local communities.

Islington Council Venues Community Free Hires Scheme Round 2 2023-24

1. Synopsis

- 1.1. Each year, Islington Council is pleased to offer eight community groups, schools and colleges, arts and cultural organisations based in Islington the chance to have free use of Islington Assembly Hall and selected Town Hall meeting rooms for five hours
- 1.2. The application window for Round 2 was offered over January and February 2024 for hall hires June Mid September 2024 (Assembly Hall) and June to December 2024 (Town Hall Rooms)..
- 1.3. Fourteen applications were received in total for Round 2 2024. Eleven were received for the Assembly Hall and three for the Town Hall.

2. Recommendations

- 2.1. That these organisation be offered a free hire use of the Assembly Hall between June and September 2024:
 - Proud Sports
 - Prior Weston Primary School
- 2.2. To hold the following applicant in reserve, in case of inability of the above applicants to negotiate appropriate dates and timings:

- Britain's Got Reggae CIC
- 2.3. That these two organisations be offered a free hire use of the Town Hall Committee Rooms between June and December 2024:
 - Imece Women's Centre
 - Cape Adventure Playground
- 2.4. To hold the following applicant in reserve, in case of inability of the above applicants to negotiate appropriate dates and timings:
 - Artbox London

Background

- 2.5. There are two different packages available to organisations depending on the nature of the event and/or number of guests and audiences. The Council reserves the right to decide on the option more suitable for events:
- 2.6. The Assembly Hall for fairs, conferences and networking events with an audience of over 100 people, musical performances with a small number of performers, and other simple performances. The free hire scheme is offered on selected Mondays, Tuesdays, Wednesdays and Thursdays, January to Mid-March 2024 (1st round), and between June to Mid-September 2024 (2nd round).
- 2.7. The Town Hall rooms for smaller conferences, workshops and collaborative networking events with an audience between 25 to 80 people depending on layout of the room, and whether attendees are seated or standing up. The Town Hall free hire is offered on working days Monday Friday, between 9am and 5pm from January May 2024 (1st round); and June December 2024 (2nd round) subject to availability.
- 2.8. The second round of the 2023-24 scheme was launched on 18 January 2024 and was promoted during 4 weeks through LBI Communications on the council external website, as well as through Voluntary Action Islington news group, to the 11 by 11 partnership of cultural organisations, schools bulletins and the wider sector via LBI departments.
- 2.9. The scheme received 14 applications from organisations supporting a range of events (see Appendix 1).
- 2.10. Applications have been assessed against the published criteria (see Appendix 2) which requires applicants to demonstrate a commitment to provide events and activities that have a strategic value and, in particular, a focus on at least one of the following four areas:

- 1. community cohesion
- 2. children and young people
- 3. diversity
- 4. creative ways of engaging local residents and, in particular, those who might otherwise miss out on cultural opportunities.
- 5. Have a borough-wide impact
- 6. Demonstrate a commitment to good practice (events that are viable, of high quality, well managed and evaluated)
- 7. Promote Islington Assembly Hall as a focus for high quality events, or demonstrating good use of the civic space at the Town Hall, making best use of the high quality facilities available in both venues

2.11. The scheme does not support:

- Groups that are not based in the borough of Islington
- Events or activities from commercial organisation
- More than one usage per applicant per year
- Organisations who do not have the funding in place to support their event at the time of application
- Applications from organisations who have previously cancelled a slot once accepted
- Applications from departments of Islington Council
- 2.12. Wherever possible, unsuccessful applicants will be supported, to secure alternative premises for their work.
- 2.13. The following organisations and events most closely meet the criteria and are recommended for free use of the Assembly Hall.

Music teaching is provided by the Charity, Music Masters and all children take part in the provision - including children from deprived backgrounds and those with SEND. This would be an amazing opportunity for our children to perform in a local, but very special venue - something most of them will never get the chance to do.

2.14. The following two organisations and events most closely meet the criteria and are recommended for free use of the Town Hall rooms

2.15. The following organisation and event met the criteria and are recommended to be **held in reserve for the Assembly Hall**, in case of inability of organisations recommended for free hires listed in 3.9 to negotiate dates and timings with Assembly Hall management.

Britain's Got Reggae CIC International Reggae Day Meets Windrush event, including a production about a family that comes over form the Caribbean to the UK. This is a 13-cast production of adults and children that deliver the play in a comical way. We will have previous artists perform that have come through the Britain's Got Reggae Competiton. We will have some talks form the Windrush elders about their experiences of arriving in the UK and what it was like.

2.16. The following organisation and event met the criteria and are recommended to be **held in reserve for the Committee Rooms**, in case of inability of organisations recommended for free hires listed in 3.10 to negotiate dates and timings with Town Hall management.

3. Implications

3.1. Financial Implications

3.1.1. There are no financial implications other than the loss of income as a result of waiving the fees for the four hires of the Assembly Hall which has been built into the business plan for the venue

3.2. **Legal Implications**

3.2.1. The Council can support voluntary and community sector organisations under the wellbeing power in Section 2 of the Local Government Act 2000. This gives the Council the power to do anything which it considers is likely to achieve the promotion or improvement of the economic, social or environmental well-being of the whole or part of its area or all or any of the persons resident or present in that area.

3.3.1. There are no environmental implications.

3.4. Equalities Impact Assessment

- 3.4.1. The council must, in the exercise of its functions, have due regard to the need to eliminate discrimination, harassment and victimisation, and to advance equality of opportunity, and foster good relations, between those who share a relevant protected characteristic and those who do not share it (section 149 Equality Act 2010). The council has a duty to have due regard to the need to remove or minimise disadvantages, take steps to meet needs, in particular steps to take account of disabled persons' disabilities, and encourage people to participate in public life. The council must have due regard to the need to tackle prejudice and promote understanding.
- 3.4.2. An Equalities Impact Assessment is not required in relation to this report, because the proposed events serve a wide range of communities and support the Council, Voluntary Community Sector and Cultural Enrichment Team priorities. They target

local residents from diverse communities and children and young people, particularly those from low-income households, to engage in range of creative and cultural activities that celebrate the diversity of Islington's communities, as well as giving residents an opportunity to feedback on provision.

4. Conclusion and reasons for recommendations

4.1. The scheme provides an opportunity for the council to support local organisations through free use of the Assembly Hall and civic space. Applications have been assessed through a clear and transparent process.

There are two different packages depending on the nature of the event and the number of guests and audiences. We reserve the right to decide on the option most suitable for your event.

Application dates

The free hire scheme round two applications open on **Thursday 18 January 2024** for hiring in:

- June to mid-September 2024 (Islington Assembly Hall)
- June to December 2024 (Islington Town Hall rooms).

If your event takes place after December 2024, applications for round one in 2025 will open in summer 2024.

Islington Assembly Hall is not suitable for a full theatrical performance (with multiple acts, props, sets, complex lighting or audio-visual effects) on a limited budget and other venues might provide a better, cost-effective alternative.

We will offer:

- two free free hires of the Assembly Hall
- for a maximum of five-hours
- on Mondays, Tuesdays and Wednesdays
- between June to mid-September 2024.

The five-hour free hire of the Assembly Hall will include:

- access to Islington Assembly Hall for you and your suppliers for your event
- set-up to meet your needs and furniture, as agreed before the event
- an events coordinator leading up to the event
- at least one duty manager during your event
- one member of the Assembly Hall security team
- a small public address (PA) system that you can use without support from an engineer
- a sound engineer (if needed) for five hours only
- jars of drinking water and three hot water urns
- parking for up to four cars, two vans OR one tour bus from load-in and up to loadout
- free Wi-Fi for production team only
- projector.

Security at Islington Assembly Hall

All events at the Assembly Hall need a risk assessment. We will book security staff based on the risk assessment, but any extra staff we need (one per 100 attendees) you will have to pay for.

Extra security staff start from £180 per member for up to five hours, then £36 per hour after that.

Security requirements are at the discretion of Islington Assembly Hall to ensure the safety of all attendees at the venue.

The five-hour Town Hall free hire will include:

- access to Islington Town Hall spaces for you and your guests
- setting up the room the way you want
- · at least one duty facility officer during your event
- our furniture, tables and chairs
- jars of drinking water
- large plasma LED monitor
- free Wi-Fi.

Other costs may include, but are not limited, to:

- hire of extra stationery such as flipcharts, flipchart paper, and pens
- hire of extra technical equipment like projectors
- any other services that are outside normal working hours
- refreshments costs available on request.

Cancelling or postponing your event

We can cancel or postpone your event at any time due to exceptional circumstances without incurring liabilities for any losses or damages to the hirer as a result of cancellation. If we cancel your booking for reasons other than an extraordinary event outside of either party's control within two weeks of the date of the event, we will at our sole discretion try to help the hirer find alternative accommodation for the event.

Criteria

Organisations must demonstrate a commitment to provide events and activities that support the council's strategic priorities by focussing on at least one of the following:

- 1. community cohesion
- 2. children and young people
- 3. Diversity¹
- 4. creative ways of engaging local residents and, in particular, those who might otherwise miss out on cultural opportunities.

Applications should be able to demonstrate your event achieves the following:

- having a borough-wide impact
- demonstrating a commitment to good practice (events that are viable, of high quality, well-managed and evaluated)
- promoting Islington Assembly Hall as a focus for high quality events or demonstrating good use of the civic space at the Town Hall, making best use of the high-quality facilities available in both venues.

You must also be able to demonstrate how your organisation will cover any associated costs (if any) alongside the free hire.

The scheme will not support:

groups that are not based in Islington

- events or activities from commercial organisations
- events that charge entry fees
- organisations that don't have the funding in place to support their event at the time of application
- more than one hire per applicant, per year
- applications from organisations who have previously cancelled a slot after being accepted
- applications from departments of Islington Council.

Subject: Islington Council's Community Chest: Continuation of Council's commitment.

1. Synopsis

- 1.1 Small voluntary and community organisations play an important role in Islington, helping to build resilient communities and support residents who are experiencing poverty and isolation. Islington Council's Community Chest (ICCC), one of the borough's most popular grant programmes, has proved to be a very effective way of funding grassroots activity and developing the capacity of local groups.
- 1.2 This report recommends that Islington Council continues to support the partnership with Cripplegate Foundation for the administering and delivery of Islington Council's Community Chest (ICCC) programme for 1 further year from 1 April 2024 to 31 March 2025 with a financial commitment of £190,000 per annum which will be reviewed on an annual basis.

2. Recommendations

- 2.1 To agree to the renewal of the council's partnership agreement with Cripplegate Foundation for administering and delivery of the ICCC programme for 1 year from 1 April 2024 to 31 March 2025.
- **2.2** To agree a financial commitment from the council of £190,000 per annum for the financial year of the ICCC programme 2024/25. To agree a financial reduction of £10,000 to the current agreement of £200,000 per annum.
- 2.3 To agree for the Community Partnership team to work with Cripplegate Foundation to establish and scope a complete review for the ICCC programme beyond 01 April 2025, including priorities, criteria, how the grant is administered and governance.

3. Background

- 3.1 ICCC is a partnership between Islington Council and Cripplegate Foundation. It is a small grants programme that funds grassroots activity and brings additional capacity building, networking and development support to local voluntary and community organisations. By providing resources for local groups ICCC helps to build community resilience and to tackle poverty and isolation.
- 3.2 Islington Council is committed to working with the voluntary and community sector (VCS). The council solely awards grant-funding to organisations that are paying employees London Living Wage and has amended our procurement approach so that we only procure services from organisations that pay their staff at least the London Living Wage.
- 3.3 ICCC is one of the borough's most popular grant funding programmes and is available to local organisations with a turnover of no more than £100,000 per year in most cases less than £50,000 per year. Organisations can apply for one grant of up to £5,000 per year. The priority is to support applications from the most deprived areas of the borough with a focus on:
 - respond to the cost-of-living crisis
 - seek to address community safety
 - aim to make Islington a more environmentally sustainable place to live

Cripplegate Foundation has successfully managed community chest programmes in Islington for many years, established in 2011. The council has historically contributed £200,000 per year and Cripplegate Foundation adds £50,000 per year (from which £36,000 per year is deducted to cover the costs of managing the programme).

- 3.4 Cripplegate Foundation commits up to £2,500 a year (inclusive of VAT) towards the costs of holding an annual celebration event to promote the achievements and impact of activity supported through ICCC. This helps to raise awareness of the council's role as main funder of ICCC. Cripplegate and the council will work together to plan these events and to secure in-kind contributions for venue and refreshment costs where possible.
- 3.5 The ICCC panel is made up of representatives from Islington Council, Cripplegate Foundation and the local voluntary sector. Chaired by the council's Executive Member for Homes and Communities, the panel meets three times a year to consider applications.
- 3.6 This panel considers issues of wider relevance to the local voluntary and community sector and reviews priorities annually. These priorities are set in partnership. For 2024/25 consultation will be undertaken with relevant council departments to ensure strategic alignment between the programme and the council's corporate priorities and

the council's recently established outcome areas. In addition, the panel track application trends and identify any gaps in the programme that should be addressed.

- 3.7 In April 2017 the Voluntary and Community Sector Committee decided to transfer full responsibility to ICCC Panel regarding confirming the awarding of grants to VCS Organisations, rather than been required to decide on recommendations made by the panel. This change has helped to streamline the decision making process and reduce delays in notifying VCS organisations of the outcome of their applications. The council's interests are protected by having the Executive Member for Homes and Communities as Chairperson of the ICCC Panel. The VCS Committee continues to receive reports to note decisions made by ICCC Panel in respect of awards through the programme. However, the Council has reserved the right to adjust this arrangement if deemed necessary.
- 3.8 The current management agreement is due to end on 31 March 2024. It is recommended that the Voluntary and Community Sector Committee considers continuing it's commitment to ICCC, with a small reduction, and for Cripplegate Foundation to manage the administration of grants to VCS organisations.
- 3.9 The £10,000 reduction will be repurposed to explore a locality participatory model. The funding will still reach the community, this might be residents themselves, grassroot start up groups and other voluntary sector organisations. This will better align to the council locality model ambitions. This will be scoped out in the first quarter of 24-25 and brought to the VCS Committee.

4. Implications

4.1 Financial Implications

The Community Chest budget sits within the Voluntary Community Service department of Community Engagement and Wellbeing, with a 2023-24 budget of £200,000. Therefore, as per the business case to extend the agreement with Cripplegate, the council is in a position to commit £190,000 for a year as this a reduction of £10,000 on the amount already committed.

The total amount available for distribution, excluding any underspends carried forward in each financial year, totals £214,000. On top of this the Cripplegate Foundation fund an annual celebration up to £2,500.

Cripplegate is a long-standing organisation with substantial funds available at its disposal. In the rare event that Cripplegate did have financial difficulties, Islington Council would need to clarify any financial liabilities we may have for the remaining projects. As the council are providing a large share of the total funding (£190,000) paid in three instalments after each funding round. The risks would be minimal.

4.2 Legal Implications

The council has power to provide grants for the voluntary and community sector under the General Power of Competence set out in Section 1 of the Localism Act 2011. The provision of grants for the voluntary and community sector as described in this report is not subject to any other statutory provision. In providing these grants the council must ensure that it complies with its duty to secure best value (Section 3 of the Local Government Act 1999) and its fiduciary duties to council taxpayers.

4.3 Environmental Implications and contribution to achieving a net zero carbon Islington by 2030

Most if not all, of the projects funded by this grant have carbon and environmental impacts, including the use of energy, fuel, water, food and drink, materials, prizes, generators, fireworks and printing, while events being funded may create waste or journeys that contribute to transport-related emissions especially if attendees drive.

However, many projects also have positive environmental impacts, including repairing items including bikes, a free library box, planting, greening areas, local food growing and increasing local biodiversity. Wherever possible, projects will be undertaken with regard with the council's goal of achieving a net zero Islington by 2030, as per Islington Council's Environmental Policy.

Cripplegate will endeavour to ask organisations the below when they give out the award letters:

- Show how the projects are complying with the council's Net Zero strategy
- Feedback on what more they'd like to do
- Feedback on the barriers they may have encountered in doing so, how they overcame them
- Let us know the impact this had in terms of mitigating carbon and enabling resilience to the impacts of climate change (increased likelihood of floods, overheating, other extreme weather events)? For example, it would be good for the groups to make provisions so that on days like this, the most vulnerable Islington citizens are still able to get support or volunteer.

4.4 Equalities Impact Assessment

The council must, in the exercise of its functions, have due regard to the need to eliminate discrimination, harassment and victimisation, and to advance equality of opportunity, and foster good relations, between those who share a relevant protected characteristic and those who do not share it (section 149 Equality Act 2010). The council has a duty to have due regard to the need to remove or minimise disadvantages, take steps to meet needs, in particular steps to take account of disabled persons' disabilities, and encourage people to participate in public life. The council must have due regard to the need to tackle prejudice and promote understanding.

ICCC provides resources for small community organisations, many of which are volunteer-led, and would not otherwise meet the criteria for funding under other programmes. It enables some of Islington's most disadvantaged residents to access community-based services and activities including through newly established groups who offer the potential for adding to existing provision locally, or who can reach communities that may not otherwise be supported.

5. Conclusions and reasons for recommendations

- 5.1 ICCC helps to nurture and sustain an innovative and resilient voluntary and community sector in Islington, in particular providing resources for smaller organisations that find it hard to access funding from other programmes. ICCC is an effective way of developing grass roots activity across the borough and building capacity in local organisations to support residents who are experiencing poverty and isolation.
- 5.2 Islington Council's Community Chest is an effective way of developing grass roots activity across the borough and building capacity in local organisations to support residents who are experiencing poverty and isolation. Continuing this successful partnership that has a direct benefit for local VCS organisations and communities is recommended so that Cripplegate Foundation continues to award on behalf of the council until 31 March 2025.
