

TEMPORARY EVENT NOTICE APPLICATION
CUBANA, 59-61 CHARTERHOUSE STREET, LONDON EC1M 6HA

1. Synopsis

- 1.1 This is a hearing to determine a Temporary Event Notice (TEN) in respect of the above premises. The application was submitted on the 5 July 2017 and is seeking to allow:
 - The sale of alcohol for consumption on the premises from 17:00 to 23:00 on 20 July 2017.
- 1.2 The TEN is applied for under section 100, Part 5 of the Licensing Act 2003.
- 1.3 The premises hold a current premises licence; however, a condition of the licence restricts the consumption of alcohol to seated customers only. This TEN, if permitted, would allow "vertical drinking".
- 1.4 This application is subject to a representation from the Metropolitan Police relating to the following licencing objectives:
 - i. The prevention of Crime and Disorder
 - ii. Public Safety
 - iii. The prevention of Public Nuisance

2. Recommendations

2.1 To determine the TEN under Part 5 of the Licensing Act 2003 as the Licensing Sub-Committee consider appropriate for the promotion of the Licensing Objectives.

- 2.2 The Committee can decide to:
 - i. allow the TEN for the specified event;
 - ii. allow the TEN, subject to one or more conditions of the existing premises licence; or
 - iii. prohibit the TEN by way of a counter notice.

Background

- 3.1 The operators were granted a premises licence on 15 May 2014. The licence permits the sale of alcohol, for consumption on the premises only, from 12:00 to 23:00, Sundays to Thursdays, and 12:00 to 00:00, Fridays to Saturdays.
- 3.2 On 26 May 2017, Licensing Officers visited the premises, which was hosting an end of year prom. The officers found a large group of patrons congregated outside, including some who appeared under 18 years. Many of the patrons present were clearly intoxicated. Customers had been permitted to leave with drinks. There was evidence of vertical drinking at the premises. Management control was poor, with patrons left outside unsupervised, substantial litter and no dispersal arrangements in place.
- 3.3 As a consequence of the Licensing Officers' visit, the operators were invited to attend a Licensing Officer Panel meeting on 8 June 2017.
- 3.4 The premises has been used under one TEN this calendar year on 28 April 2017. This was a "Military work celebration party" for 100 persons, with sales of alcohol and Late Night Refreshment to 03:00 hours. A further TEN submitted for 29 June 2017 was rejected as this was submitted too late; no times were specified on this notice.
- The operators attempted to submit two TENs on 22 June 2017 for events on 13 and 20 July 2017. The applications were incorrectly completed and the applicant was advised by the Licensing Service to amend the applications. In light of the events witnessed on 26 May 2017 the applicant was also advised to supply additional information to satisfy the relevant responsible authorities that the events would be well managed.
- 3.6 Two revised TENs were resubmitted on 5 July 2017. The Metropolitan Police have made representation in respect of both TENs. The TEN for the 13th July was deemed a "Late TEN" and as a consequence this TEN was automatically deemed refused.
- 3.7 The operators have submitted a response to the Metropolitan Police representation.

With reference to the above application, we are writing to inform you that the Metropolitan Police, as a Responsible Authority, will be objecting to this application as it is our belief that if granted this application would undermine the Licensing Objectives.
The venue held an event on 26th May 2017 where high levels of intoxication was witnessed by council Licensing officers. The event was being held for 17/18 year old school pupils and their teachers. Several License breaches were identified and the venue was called in for an officer panel on 8th June 20
On reading the application I note that the applicant, when referring to how the outside space will be managed has stated the following: Either the door super or a Manager will be outside at all times to make sure of the following. This does not fill me with confidence. I would expect a clear plan to be in place, the being, every member of staff having a clearly identified role?
There is no reference to the number of door supervisors expected to be in attendance? And I again woul expect this to be part of any operational plan.
In the section- How the supply of alcohol will be controlled he applicant has stated the following: Our bastaff are trained and our managers are getting additional training following the events of a few weeks ago I take this to mean that at the current time this extra training has not yet been given?
I am also concerned about the number of expected patrons. The venue is only a small venue and the applicant has stated that 200 are expected to attend. I find it difficult to see how it would hold 200 persons? And consider this to increase the risk of patrons spilling out into the street.
I am not confident that this event will be managed in a way that will ensure the licensing objectives are complied with and I therefore make this representation that the application be refused.

Annex 1 - Mandatory conditions

- 1. No supply of alcohol may be made under the premises licence:
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. All door supervisors shall be licensed by the Security Industry Authority.
- 4. The admission of children to the exhibition of a film shall be restricted in accordance with the recommendation of a film classification body as defined in the Video Recordings Act 1984 or Islington Council acting as the licensing authority where it has given notice in section 20(3) of the Licensing Act 2003.

There are further 'Mandatory conditions' applicable to licences authorising the supply of alcohol. A full list of the current mandatory conditions is available from the licensing pages on Islington's web site, www.islington.gov.uk. This list is subject to change by order of the Secretary of State and licensees and other responsible persons are advised to ensure they are aware of the latest conditions.

Annex 2 - Conditions consistent with the Operating Schedule

- 1. No alcohol may be consumed outside.
- Alcohol may only be consumed by seated customers.
- 3. Alcohol may only be sold at times when substantial food and fresh, non-alcoholic fruit drinks are available for purchase and promoted on the premises.
- 4. The premises shall operate Challenge 21.
- 5. Children will only be allowed on the premises under the supervision of adults.
- 6. All staff shall undergo licensing training, which shall include training concerning knowledge of licensing law and the social impacts of the sale of alcohol.
- 7. A maximum of three tables (12 seats) may be provided outside, but only under the authority of a pavement licence. Tables and chairs to the front of the premises shall be cleared and rendered unusable at, or before, 22:15 on each day of operation. Any moveable furniture will be fitted with rubber (or equivalent) feet.
- 8. Adequate notices shall be displayed to inform patrons of the time of removal of tables and chairs.
- 9. A designated smoking area and number of smokers outside the premises at any one time will be agreed with the Council's pollution team. Suitable receptacles will be provided for cigarette litter within that area.. The designated smoking area shall not be used for the consumption of drinks, unless patrons are seated in the tables and chairs area to the front of the premises.
- 10. Litter patrols shall be carried out throughout the hours of operation and once the final customers have left to ensure all litter associated with the premises has been cleared from the public highway.
- 11. CCTV shall be installed, operated and maintained in agreement with the Police.
 "Maintained" means that the system will be regularly serviced (at least once a year) and checked every two weeks to ensure that it is storing images and correctly and a log kept and signed by a Supervisor to this effect. The system will provide an identifiable full head and shoulder system of everyone entering the premises and will operate in any light conditions within the premises. The system shall record in real time, date and time stamped and will operate whilst the premises is open for licensable activities. The recordings will be kept for a

minimum of 31 days and copies will be made available to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24 hours of every request. There will always be a member of staff on duty who can operate the system, to allow Officers to view recordings and if required by a Police Officer, provide a copy of images immediately.


- 12. A scheme for noise insulation shall be agreed with the Council's pollution team.
- 13. Public transport information will be included on the premises' web-site and provided to customers.
- 14. There shall be erected and maintained in a prominent position at every exit a clear, conspicuous and legible notice requesting patrons to avoid causing noise nuisance to local occupants of any properties in the vicinity.
- 15. Odour from any flue used for the dispersal of cooking smells serving the building shall not cause nuisance to the occupants of any properties in the vicinity.
- 16. Music levels shall be monitored and kept lower towards the front of the premises.
- 17. There shall be no music played outside of the premises.
- 18. An assessment of the premises sound insulation shall be undertaken and appropriate improvement works carried out, so as to ensure that noise levels generated on the premises meet the Council's Technical Criteria; and, maximum music noise levels shall be agreed.
- 19. The improvement works and maximum music noise levels shall be approved in writing through the Council's Pollution Team.
- 20. The Premises Licence Holder or nominated person shall supervise and control levels of noise on the smoking area and advise patrons of the need to respect local occupants of any properties in the vicinity where appropriate.
- 21. The occupier of the first floor premises at 57-61 shall be fully consulted as to the specification and testing of sound insulation and the setting of music noise levels.



LICENSING OFFICER PANEL - 8 JUNE 2017

RE: CUBANA CAFÉ 61 CHARTERHOUSE STREET EC1M 6HA

Thank you for attending the officer panel on 8 June 2017.

You met with Jan Hart Service Director, PS Aaron Barnes and Terrie Lane, Licensing Manager.

Attending for your company were Phillip Oppenheim, Pedro Rabanales (duty manager) and vour Solicitor.

The following are the notes taken at the meeting including agreed measures in bold:

JH opened the meeting by explaining that licensing panel was an informal and open discussion whereby licensees are asked to come in when problems are identified in order to reach a resolution and prevent the need for further action.

JH explained that this meeting was being held to due to an event held for sixth formers, where there was a high level of intoxication and licence conditions were not being complied with.

JH - We are very concerned about the events of that evening. We had experienced officers visit your premises that night and they were shocked at what they saw - high levels of drunkenness, even the teachers, they were too drunk to be allowed into nearby premises. There was no food provided when officers visited. This was a dancing and drinking event and not suitable for your premises, which is a café where all customers must be seated and be eating.

PO - The event was booked as an end of term prom; many were under age but they were stamped. We agreed that teachers must be present to keep an eye on the students and substantial food would be served. They arrived at 7pm and were well dressed. There were no problems until mid to end of the evening. It seemed some of them had pre-loaded. We closed the bar early and so they began to congregate outside.

At 11.30pm there were a lot of people outside. Pedro made the mistake of giving them their drinks in plastic cups to take away, he has been given a warning. Our CCTV was 1 hour slow.

Our first reaction was that we would not have that type of party again as we could lose our licence. We know we can have no vertical drinking.

Staff will be going on the Bll level 2 course and have additional training for bar staff dealing with underage.

JH - We encourage events for young people however they must be properly managed and the licence conditions must be complied with. We have dealt with many student pichts You must ID at the bar not just at the front door. It was too much for one door supervisor. Staff

must be vigilant; girls especially will smuggle items in their bags. Jugs of cocktails were not supervised. Your staff must check and monitor customers and not rely on the teachers as it is not their responsibility to check for drunkenness on the premises. It is unacceptable that the teachers were drunk.

Contact us if you want events in the future.

PO – We had a special offer on drinks that was for May only. We realise that we should not have given out the cocktail jugs. We will turn away requests if we feel we can't manage them. I will put you and Simon on our mailing list to see what is coming up.

We expect the above agreements (in bold) to be carried forward and will monitor the premises to ensure compliance.

We also have two door supers booked


We had a problem with a school prom party in May, we met with the licensing panel and agreed a number of improvements to prevent a repetition of any problem - these have all been implemented

I don't think we have been a problematic venue - we are very food led and I hope you will reconsider - these parties are booked for this month and if we have to cancel them it will cause a lot of problems.

I am happy to discuss any of the concerns


