Service Area: Environment and Regeneration, Public Realm, Traffic and Parking Section (Traffic Engineering)

Traffic and Engineering Section deliver many public realm improvement schemes across the borough.

This procurement ensures that there is continuity for ongoing, long standing, major schemes, such as Cross Rail, London Cycle Routes and for Bus Reliability schemes, all of which require Islington to work with partner authorities, with consultancy suppliers supporting delivery.

Other important initiatives in public realm improvement, such as Local Safety schemes, School Play Streets initiatives, Bike Hanger and Lorry ban schemes, also require the input and resources of bespoke technical professionals.

The schemes and projects outlined in the paragraphs above, whether current or planned, impact upon life in the borough and provide enhanced opportunity for residents and visitors to enjoy our public realm safely.

No individual scheme, with possible exception of London Cycle Routes / Bike Hangers, can be identified as specifically targeted on one section of the community or another.
