

APPENDIX B – FUSION 21 DECARBONISATION FRAMEWORK SOCIAL VALUE CREDITS USED FOR ASSESSING BIDDERS

The contractual obligation in accordance with Clause 24 of the Framework Agreement is that appointed Suppliers will create social value equivalent to at least 10 credits for every £100k of contract value; this being the actual value of the contract between the appointed Supplier and the Member.
