The council has an ongoing contract based with the current incumbent for the maintenance, hosting and provision of the data sim cards for the council's electronic notice boards. This report is to procure a new contract for the electronic notice boards.

The risks will be the visible data being shown on the screens and to ensure that boards are placed in accordance with any listed buildings guidance

Opportunities are that there would be an increase of council led communication on Housing estates which the residents can access. The data will be up to date and will save on costs for members of staff to manually update the traditional notice boards.

The risks will be managed via an internal communications protocol and strategy that has been put in place via the communication team. Any content requested will be authorised via the comms team.

All areas that have been identified to have a notice board fitted will be authorised via estate services and other stakeholders so that any building's which are listed are omitted from the plan.

Due to existing infrastructure, any new provider to current contractor will require their systems to integrate with what is currently in place. This does as a benefit reduce 'Downtime' costs if suppliers were changed.

Could increase awareness in local community for council led initiatives which will have an impact on the 4 core principles for Homes and Communities which include Jobs and money, health and wellbeing, belonging and intervention.

The screens are LED backlit and are rated as 'A' for energy efficiency.
