

PREMISES LICENCE NEW APPLICATION

Old Friend, 277 Caledonian Road, London N1 1ET

## 1. Synopsis

- 1.1 This is an application for a new premise licence under the Licensing Act 2003.
- 1.2 The new application is to:
  - i) permit the provision of films, live music and recorded music, from 12:00 until 23:00 Sunday to Thursday and from 12:00 until 00:00 Friday to Saturday.
  - ii) permit the premises to sell late night refreshments, from 23:00 until 00:00 Friday and Saturday.
  - iii) permit the sale of alcohol, from 12:00 until 23:00 Sunday to Thursday and from 12:00 until 00:00 Friday to Saturday.

- The application was originally made to permit the above activities from 12:00 until 02:00 Sunday to Wednesday and from 12:00 until 03:00 Thursday until Saturday. However, these hours were amended by the applicants by way of an email received on 9 October.
- 3.3 The premises is located within the Kings Cross Cumulative Impact Policy area, adopted by the Council on 24 January 2013.
- 3.4 The Licensing Authority has received six letters of representation, including letters from the Licensing Authority, the Police and the body responsible for Public Health.
- 3.5 A premises licence was previously issued for this property, when Islington took over responsibility as the Licensing Authority for alcohol sales, regulated entertainment and provision of late night refreshment.
- 3.6 On 17 August 2005 the Licensing Sub Committee agreed to extend the permitted hours, in the basement only, for the sale of alcohol to 01.30 on Sundays to Wednesdays and to 03.30 on Thursdays to Saturdays. The Committee also agreed to extend the permitted hours for regulated entertainment, in the basement only, to 02.00 on Sundays.
- 3.7 On 8 October 2008 the Council's Licensing Sub Committee heard an application from Islington's Noise Service for the review of the licence. The review application was supported by the Metropolitan Police. At the hearing the Committee decided to impose 17 additional conditions on the premises licence.
- 3.8 On 8 April 2009 the Council's Licensing Sub Committee heard a second application from Islington's Noise Service to review the premises licence because the conditions imposed by the review heard on 8 October 2008 had not been implemented. At the hearing the Committee were satisfied that the conditions had been complied with.

- 3.9 On 31 July 2014 the Council's Licensing Sub Committee heard a third application for the review of the premises licence. This application was made by the Police and was based on the licensing objective of the prevention of crime and disorder following a number of serious offences which occurred at the premises. Members of the Licensing Sub Committee revoked the premises licence. However, the decision was appealed and a Consent Order was issued by the Magistrates' Court which reduced the terminal hour for the On sales of alcohol until midnight Friday and Saturday and 23:00 Sunday to Thursday, removed the provision of Off sales at the premises, reduced the terminal hour for the provision of late night refreshment until midnight Friday and Saturday. The Order also attached a further three conditions to the premises licence.
- 3.10 In May this year the Licensing Team became aware that the premises licensee had been declared bankrupt in June 2010. As no transfer was received in accordance with s.50(3)(a), the premises licence therefore had lapsed in July 2010.

## 4. Planning Implications

- 4.1 Planning have reported that the permitted use of the ground floor is a restaurant whilst the basement benefits from a combination of a bar and restaurant. The upper floors are in residential use.
- 4.2 Planning records indicate the following relevant decisions:
  - Planning permission (Ref: 930856) was granted on 14 October 1993 in connection with "change of use of basement to restaurant and bar area. The planning permission was subject to five conditions. Condition 4 stated "the use shall not operate except between the hours of 11.00 and 24.00 on any day. However, Condition 4 was subsequently varied by way of planning application (Ref: 951562) granted on 07 December 1995. This allowed the use of the premises at basement level to operate 11.00 and 02.00 every day. A further planning application (Ref: 990065) was submitted and later approved on 12 March 1999 to once more vary Condition 4 to allow the premises to operate between 11.00 and 4.00 am every day.
  - On 11 December 2000 planning permission (Ref: P001957) was granted in connection with "change of use of the ground floor from A2 (betting shop) to A3 (restaurant)". The planning permission was subject to 11 conditions. Condition 4 stated the use of the premises can only operate between 11.00 and 12.00 midnight on any day.
- 4.3 There are presently no ongoing enforcement investigations relating to the land.

### 5. Recommendations

- 5.1 To determine the application for a new premises licence under Section 17 of the Licensing Act 2003.
- 5.2 If the Committee grants the application it should be subject to:
  - i. conditions prepared by the Licensing Officer which are consistent with the Operating Schedule (See appendix 3);
  - ii. conditions recommended by Responsible Authorities deemed appropriate by the Committee (see appendix 3); and
  - iii. any additional conditions deemed appropriate by the Committee to promote the four licensing objectives.

## 6. Conclusion and reasons for recommendations

6.1 The Council is required to consider this application in the light of all relevant information, and if approval is given, it may attach such conditions it considers appropriate to promote the licensing objectives.

- 8. A specific taxi operator has been nominated for staff and customers use. The company's telephone number is advertised to customers. The operator and all drivers are aware that they should arrive and depart as quietly as possible, should not sound vehicle horns as a signal of their arrival or leave engines idling unnecessarily. In addition, staff will leave as quietly as possible, particularly at night and early in the morning.
- 9. The Premises Licence Holder or nominated person shall ensure that suitable signage is positioned at exits to request the co-operation of patrons, in particular to make as little noise as possible when leaving the premises. Patrons will be asked not to stand around talking in the street outside the premises and asked to leave the vicinity quickly and quietly.

## e) The protection of children from harm

1. All customers attempting to purchase alcohol who appear to be under the age of 25 shall be required to produce a valid form of identification. Acceptable forms of identification are a proof of age card bearing the PASS hologram logo, an EU photo card, full driving licence or a passport.




I am writing to object strongly to the above license application and object to the late hours requested in the application.

My family and I have been residents of the Caledonian Road for over 20 years and have been involved in our community during most of that time. I say this to emphasize the fact that there are many residents on this road and many who have young families. Our family endured the late ours of the previous establishment, which whether legally or illegally disgorged clients often after 2 am on a Monday mornings. Complaints from myself and my neighbours did nothing to alleviate the problem.

This license proposes ridiculously anti-social hours of operation, music, alcohol, and performance. I realize that the applicants are probably applying for the maximum allowable time in the hopes of getting something less wideranging, but it is still an affront to our community and those of us who have worked to improve the Caledonian Road. This is still a residential area lived in by people who have regular jobs and many with young children who need to be allowed to keep regular hours. The sale of alcohol and the performance of music until 2:00 or 3:00 am is yet another slap in the face to those of us who actually care about the temper and quality of this neighborhood.

I would ask that the committee please consider the large number of us who make the Caledonian Road our home and refuse this license until more reasonable hours are proposed. I would ask that music not be allowed after 10 pm during the week and a limit of midnight on Friday and Saturday. This is a residential neighborhood, not a clubbing destination in Ibiza.

I am submitting a representation against the application for a licence to permit the sale of alcohol from the above premises. This representation is on behalf of Camden and Islington Council's Public Health Department, which as a health body is a responsible authority.

The grounds for the representation are:

- Public safety
- Crime and disorder

The relevant policies in Islington's Licensing Policy

- Policy 2: Cumulative impact and saturation
- Policy 8: Framework hours

The impact of alcohol is particularly great in Islington with some of the greatest levels of alcohol-related problems in London, including:

- The highest rate of alcohol-specific deaths in men in London
- One of the highest rates of alcohol-related hospital admissions in London
- Significantly higher levels of alcohol-related violent crime and claimants of incapacity benefit where the main medical reason for being a claimant is alcoholism

In the <sup>1</sup>LSOA area where this premise is located:

- At the time of this representation there were 20 alcohol-related call outs in 2014/15 higher than the Islington average for <sup>1</sup>LSOA
- At the time of this representation there were 76 alcohol specific hospital admissions in 2014/2015
- The <sup>1</sup>LSOA where this premise is based is currently ranked 34th highest for alcohol-related ambulance callouts by <sup>1</sup>LSOA (1= highest and 118 = lowest) in Islington

## Harm from alcohol in the vicinity of the application

Caledonian Ward is an area which the evidence available demonstrates a particularly high level of alcohol harm relative to the rest of the borough. As a result the area is designated as a **cumulative impact area** in the Islington Statement of Licensing Policy 2013 to 2017. As stated in this policy: any

further increase in the ease of access to alcohol in terms of the number of premises and the **hours of operation** needs to be carefully managed. The onus is also on the applicant to demonstrate how they will avoid adding to this cumulative impact.

I am concerned that if this application is granted it will increase the availability of alcohol for consumption off premises. This could lead to an increase in public nuisance, crime and disorder and impact adversely on the health of both those buying and consuming the alcohol but also the health of others who come in contact with them.

The area already has sufficient premises to meet demand and additional outlets supplying alcohol will be detrimental to the local residents in terms of noise and disturbance, anti-social behaviour and crime.

## Alcohol and health

Alcohol misuse imposes a major preventable burden to health and the effect of this in Islington is felt across all health services. There is a growing body of evidence that an increased number of alcohol outlets results in significant increases in both alcohol consumption and alcohol-related harm, including injury, violence and medical harm. Evidence from a number of countries indicates reducing alcohol outlet density can have an impact on reducing violence and problem drinking. There is also strong and reasonably consistent evidence that changes in hours or days of trading can have a significant impact on volume of alcohol consumed and rates of alcohol related problems.

Islington experiences some of the highest levels of alcohol-related harm in London and the cumulative availability of alcohol is one area that is likely to be impacting on this.

There is evidence that increased availability of alcohol, both in terms of the time period in which alcohol is available (hours of sale) and number of premises from which alcohol is available, results in an increase in alcohol-related harm. One effect of this is increased pressure and costs to the NHS. The impacts are also felt across a range of groups including the council, policing and the community as a whole.

In summary the area has sufficient premises to meet demand and additional outlets supplying alcohol will only be detrimental to the local residents in terms of noise and disturbance, anti-social behaviour and crime and will significantly add to the **cumulative impact** of alcohol on residents.

We do not feel that the applicant has demonstrated how they will not add to this level of impact in line with the Cumulative Impact Policy.

## Recommendations

Camden and Islington Public Health Department recommends that:

The application for a licence to supply the sale of alcohol for consumption on the premises
outside framework hours is refused as it would significantly add to the cumulative impact of

#### **Issues of Concern**

- 1. The premises are located in the Kings Cross Cumulative Impact therefore the onus is on the applicant to demonstrate that this proposal will not undermine the licensing objective.
- 2. The proposed measures are typical of many licenced premises operating in the borough. There does not appear to be any bespoke mitigation measures that would suggest that these premises would not add to the cumulative impact.
- 3. The applicant does not appear to have considered Islington's Licensing Policy, for example in the operating schedule there is no reference to a dispersal policy (LP 21), experience and track record of complying with legal requirements (LP10), support for best practice schemes (LP12).
- 4. This application will undermine the licensing objectives and added to the cumulative impact because:
  - a. The non-standard timings requested for approximately 30 days each year are outside the framework hours in licensing policy 8
  - b. The applicant has not indicated the proposed capacity of the premises, from the plans it is reasonable to assume that it will not be a small venue (less than 50 customers at any time).
  - c. There appears to be no consideration of:

- i. How the premises will be managed including entry and exit control
- ii. The appointment of an experienced management team
- iii. Staff training
- 5. Furthermore the ability of the applicant to run a late night venue without impacting on the licensing objectives is questionable because:
  - a. The applicant has been issued a formal caution for selling alcohol from another premises in the borough without a licence within the last 18 month
  - b. The applicant, who is also the proposed DPS, has failed to provided details of his home address on the application form
- 6. The measures proposed in the operating schedule do not sufficiently rebut the presumption to refuse the application on the basis that the application will not add to the cumulative impact
- 7. The Licensing Authority has been working with partners and the licence trade to tackle alcohol related crime, disorder and antisocial behaviour that affect residents living in the area and places and reduce the pressure in the emergency services. An additional late night venue in this area will undermine this work and add to the cumulative impact.

#### Recommendation

This proposal will undermine the licensing objectives and I recommend that the application is refused.

With reference to the above application, I am writing to inform you that the Metropolitan Police, as a Responsible Authority, will be objecting to this application as it is our belief that if granted the application would undermine the Licensing Objectives.

The venue has historically been a problem venue, with a number of incidents and offences occurring after midnight in and around the venue. The venue, then called Menelik had the licenbse reviewed and the hours were reduced to midnight closing. The hours applied for fall outside of the recommended core hours contained within the Council Licensing Policy 2013-2017 and are also later hours than on the current license at the premises

The venue was visited by Pc Steven Harrington 425NI on the 11<sup>th</sup> September where he met with Mr XIE and other staff members. The venue has 4 rooms in the basement area, which the applicant has stated are for Karaoke, 3 of these are designed to accommodate approximately 10 persons and 1 is slightly larger. 3 of these have their own single toilet contained within the room and the larger room has a male and female toilet outside. The rooms are all off a main corrider which has direct access to a staircase leading to an exit door onto Caledonian. Pc Harrington did ask why the rooms all had their own toilet as this does seem a bit strange and he was told it was to prevent conflict. The ground floor appears to be a restaurant area with a new kitchen built at the rear of the premises.

The venue does fall within the Kings Cross Cumulative Impact Area (CIA) and there are 20 licensed premises within a 200m radius. 8 of these are On-License venues, 8 are Off-License venues and 4 are late night refreshement venues.

We accept that the venue is looking to bring a different style of venue to the area but we feel that the hours requested will still add to the Cumulative Impact within the area and the crime and Disorder. We also note that the requested hours for all licensable activities are exactly the same as the requested

opening hours, therefore not allowing any drinking up time for customers.

In light of this I would make the recommendation that the License variation application is refused.





#### **Annex 1 - Mandatory conditions**

- 1. No supply of alcohol may be made under the premises licence:
  - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. All door supervisors shall be licensed by the Security Industry Authority.
- 4. The admission of children to the exhibition of a film shall be restricted in accordance with the recommendation of a film classification body as defined in the Video Recordings Act 1984 or Islington Council acting as the licensing authority where it has given notice in section 20(3) of the Licensing Act 2003.
- 5. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any "irresponsible promotions" in relation to the premises.

In this condition, an "irresponsible promotion" means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children:

- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
  - i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - ii) drink as much alcohol as possible (whether within a time limit or otherwise):
- provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on:
  - i) the outcome of a race, competition or other event or process, or
  - ii) the likelihood of anything occurring or not occurring;
- e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 6. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 7. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

8. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- 9. The responsible person shall ensure that:
  - a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
    - i) beer or cider: ½ pint;
    - ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - iii) still wine in a glass: 125 ml; and
  - b) customers are made aware of the availability of these measures.

# Annex 2 - Conditions consistent with the Operating Schedule

- 1. Alcohol shall not be sold, supplied, consumed in or taken from the premises except during permitted hours. In this condition permitted hours means the authorised hours specified on this licence for the sale by retail of alcohol. This restriction does not prohibit:
- a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
- d) consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- 2. This licence is subject to such further conditions as are consistent with any restrictions imposed on the use of the premises for the existing licensable activities under the licence by virute of the enactments hereinafter set out:

Children and Young Persons Act 1933 Cinematograph (Safety) Regulations 1955 Sporting Events (Control of Alcohol Etc) Act 1985

3. With respect to the basement:

The sale of alcohol is not authorised after midnight on any day on which music and dancing is not provided after midnight.

On any day that music and dancing ends between midnight and two o'clock in the morning the sale of alcohol shall cease when the music and dancing end.

The sale of alcohol shall cease at midnight on any Sunday on which music and dancing is not provided after midnight;

Where music and dancing end between midnight on any Sunday and 00.30hours, sale of alcohol on that Sunday shall end when the music and dancing end.

Where music and dancing end between midnight and 02.00 hours on any Sundays immediately before a bank holidays the sale of alcohol on that Sunday shall cease when the music and dancing end.

The sale of alcohol must be ancillary to the use of the premises for music and dancing and substantial refreshment.

4. With respect to the Ground Floor:

Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there for consumption by such a person as an ancillary to his meal.

Suitable beverages other than intoxicating liquor (including drinking water) shall be equally available with or otherwise as an ancillary to meals served in the licensed premises.

5. The maximum number of persons accommodated at any one time in the premises shall not exceed the following:

#### Basement 80

- 6. The licence shall be subject to the Council's technical standards for Places of Entertainment.
- 7. The licence shall be subject to the Council's Standard Conditions for Places of Entertainment.
- 8. The licence is subject to the following Additional Conditions referred to in the Standard Conditions for Places of Public Entertainment:

ADDITIONAL CONDITIONS D: APPLICABLE TO PREMISES USING DOOR SUPERVISORS.

ADDITIONAL CONDITION GO: APPLICABLE TO THE KEEPING OF GOOD ORDER.

ADDITIONAL CONDITIONS SX: FOR PARTICULAR CONTROL OVER STRIPTEASE OR SIMILAR ENTERTAINMENT INVOLVING NUDITIY.

- 9. All amplified sound played on the premises shall be subject to the control of an entertainment noise control system ("noise limiter").
- 10. The entertainment noise control system is to be set to the thresholds in condition 11, Annex 2, to prevent amplified sound played on the premises causing nuisance or undue disturbance to occupiers of other premises in the neighbourhood. These levels may be varied should justified complaints be received or if additional sound insulation works are undertaken.
- 11. The entertainment noise control system is to be calibrated to and maintained at the settings below thereby restricting amplified sound levels. Measurements should be taken in the basement aisle, with the microphone facing the front of the premises, approximately 1 metre from the foot of the stairs leading to street level:
  - 87dB(A) Leq (1 min)

- 92 dB(Lin) Leq (1 min)
- 82 dB 63Hz octave band (1 min)
- 87 dB 125 Hz octave band (1 min)
- 12. The entertainment noise control system controls are to be placed in a secure, lockable cupboard or similar location. The entertainment noise control system is to be completely independent of control by persons other than the licensee. Access to the entertainment noise control system control is to be restricted to the licensee or designated manager.
- 13. The mixer/amplifier unit controls should be covered with a secure, lockable cupboard to prevent tampering with the lead plugs running from the noise limiter. The mixer/amplifier unit controls are to be completely independent of control by persons other than the licensee. Access to the mixer/amplifier unit controls is to be restricted to the licensee or designated manager.
- 14. The entertainment noise control system settings are not to be varied so that the music noise levels described above are exceeded without the written approval of the Council.
- 15. The entertainment noise control system shall be regularly monitored, checked and its calibration adjusted as necessary to ensure the above levels are not exceeded. At least annually, by the 31<sup>st</sup> July each year, the licensee shall submit, to the Council, a certificate from an acoustic consultant, registered with the Institute of Acoustics:
  - a) Confirming that the entertainment noise control system is operating correctly so that the music noise levels outlined above are not being exceeded.
  - b) Detailing the components and make up of the sound system under the control of entertainment noise control system.
- 16. If there are any changes in the distribution and type of loudspeakers or amplification equipment serving the sound system then the entertainment noise control system shall be re-calibrated so that the levels given above are not exceeded.
- 17. The sound insulation properties of the premises shall be monitored, maintained and adapted as necessary to ensure that amplified sound played within the premises does not cause nuisance or undue disturbance to occupiers of nearby premises.
- 18. Notices are to be displayed requesting patrons to leave quietly.
- 19. The telephone number of a local taxi firm shall be made available for patrons.
- 20. Door Supervisors, registered with the Security Industry Authority, shall be employed at the premises.

#### Annex 3 - Conditions attached after a hearing by the licensing authority

- 1. Notices shall be displayed reminding patrons to use the toilets before exiting the premises.
- 2. There shall be no accompanied children under 18 years on the premises at any time and no children after 23.00.

- 3. When alcohol and/or public entertainment is provided by way of music and dancing 2 SIA registered door supervisors will be employed from 9 pm until half an hour after closing time, one of them being female whenever practicable.
- 4. Door Supervisors Register A register shall be maintained recording all SIA door supervisors employed at the premises. This shall include their name, badge number, the agency they work for (if any) and the time they start and finish work.
- 5. Management shall take a photocopy of all door staff SIA badges and secure them in a personnel folder and place this in the safe.
- 6. Door Supervisors to display their SIA licence by means of a luminous arm band.
- 7. On any occasion when entertainment is being provided by means of a DJ and/or live music, all patrons visiting the premises will be searched by means of an electronic hand held wand. All visiting DJ's will be searched upon arrival. There will be at least 2 fully functional wands in use at the premises.
- 8. A written security and searching policy shall be in operation at the premises, a copy of which shall be provided to any security company providing door supervisors. Training shall be undertaken and recorded to ensure that door supervisors understand this policy.
- 9. Electronic searching equipment shall be maintained in working order. All Door Supervisors must be trained in the use of this equipment and a record kept of this training.
- 10. CCTV shall be installed, operated and maintained both inside and outside the premises in agreement with the Police. The system will enable a frontal head and shoulders image of every person entering the premises. The system shall record in real time and operate whilst the premises are open for licensable activities. The recordings shall be kept available for a minimum of 31 days. A working copy shall be supplied free of charge to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24 hours of any request. It is the responsibility of the premise to download any recording requests.
- 11. Notices shall be displayed both outside and inside the premises informing patrons that there is CCTV in operation.
- 12. Premises to adopt BII Challenge 21 The National Proof Of Age Standards Scheme.
- 13. A notice shall be displayed at the entrance advising patrons of any dress code and drug policies. This information shall also be included on tickets used by the premise licence holder and on any official website operated by the holder for the premises. Tickets/website will also warn patrons of the fact that they will be searched upon entry.
- 14. When outside promoters or DJ's are performing Metropolitan Police Risk Assessment form 696 must be completed and submitted to the Metropolitan Police Clubs and Vice Unit and Islington Police Licensing Unit with at least 14 days notice. Form 696A to be submitted within 3 days of the completion of the event.
- 15. Polycarbonate drinking vessels only to be used. All glass bottles to be decanted.

- 16. Premises must be represented at any local pub/club watch meetings.
- 17. The works referred to as Phase 1, identified in the "Report on Noise survey" dated 6 October 2008, be completed within 6 weeks, the period to commence 28 days after receipt by the licensee of the amended licence and works to be completed to the satisfaction of Islington's Noise Service.
- 18. Phase 2 works, identified in the "Report on Noise survey" dated 6 October 2008, be carried out if considered necessary by Islington's Noise Service.
- 19. The music limiter shall be calibrated to the satisfaction of the Noise Team.

## Suggested conditions of approval consistent with the operating schedule

# The prevention of Crime and Disorder

- 1. CCTV shall be installed, operated and maintained in agreement with the Police. Maintained means that the system will be regularly serviced (at least once a year) and checked every two weeks to ensure that it is storing images correctly and a log kept and signed by a Supervisor to this effect. The system will provide an identifiable full head and shoulder image of everyone entering the premises and will operate in any light conditions within the premises. The system shall record in real time, date and time stamped and will operate whilst the premises is open for licensable activities. The recordings will be kept for a minimum of 31 days and copies will be made available to an Authorised Officer or a Police Officer (subject to the Data Protection Act 1998) within 24hrs of any request. There will always be a member of staff on duty who can operate the system, to allow Officers to view recordings and if required by a Police Officer, provide a copy of images immediately.
- 2. Alcohol shall only be sold to and consumed by persons seated at a table meal, and ancillary to that meal.
- 3. All alcohol shall be served at the table by staff.
- 4. There will be no vertical drinking at the premises.
- 5. No alcohol shall be consumed at any bar or service area of the premises with the exception of personal waiting for a table to become vacant.
- 6. A member of staff to remain upstairs at all times to ensure safe passage of Karaoke customers to and from the basement Karaoke rooms.
- 7. No alcohol shall be consumed at any bar or service area of the premises while customers are waiting for a Karaoke room to become vacant.
- 8. There shall be no vertical drinking outside the karaoke rooms.

# **Public Safety**

- 9. The fire safety precautions and risk assessments shall be regularly reviewed to comply with legislation.
- 10. The premises licence holder shall carry out regular fire risk assessments to identify any risks and control measures shall be put in place to comply with legislation.


#### The Prevention of Public Nuisance

- 11. All doors and windows shall be kept shut during regulated entertainment and staff shall check prior to the commencement of regulated entertainment, and periodically during the times that entertainment is taking place that all windows and doors are shut.
- 12. The premises licence holder or nominated person shall ensure that self-closing doors are not wedged open during any entertainment.
- 13. Suitable sound equipment and sound proofing for the karaoke rooms to be installed and assessed by a qualified acoustic consultant and approved by the Council prior to the premises being used for regulated entertainment.

- 14. Customers will not be permitted to take drinks outside of the premises.
- 15. Staff shall ensure that customers who go outside to smoke do not disturb local residents.
- 16. Bottling out from the premises is prohibited between 20:00 hours and 07:00 hours.
- 17. Deliveries to the premises is prohibited between 20:00 hours and 07:00 hours.
- 18. A dedicated licensed taxi/mini cab service shall be available with the premises for customers. The companies telephone number will be advertised for customers.
- 19. The drivers will be monitored to ensure that they arrive and depart as quietly as possible, or sound their vehicle horns, or leave their engines idling.
- 20. Staff will leave the premises quietly.
- 21. Prominent, clear and legible notices must be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and the area quietly.
- 22. Patrons will be asked not to stand around talking in the street in the vicinity of the premises and will be asked to disperse quickly and quietly.

The Protection of Children from Harm

23. The licensee shall adopt the Challenge 25 and the BII National Standards Proof of Age Scheme.
